000 CHAIR COHEN: Convenes meeting at 8:15 a.m. Due to lack of a quorum, we shall operate as a subcommittee.

SB 1076 - Workforce Lottery Allocation - Work Session

017 CHAIR COHEN: Discusses drafted amendments to attach language to Section 7.

020 SEN. BUNN: The Department of Education budget only provided student leadership funding for one year. The funding is changed from \$400,000 to \$200,000. We would put the \$400,000 back in.

027 CHAIR COHEN: Sen. Bunn is referring to Section 5. Proposal would add another \$200,000 there. Correct?

031 SEN. BUNN: That is correct. Restores it to level that was intended.

O34 CHAIR COHEN: The chair will be proposing that we take \$3 million out of the regional workforce strategy. Discusses proposed amendments to section 13.

054 SEN. BUNN: Suggests eliminating the \$200,000 from the youth apprenticeship.

090 CHAIR COHEN: Sen. Bunn do we now have in the skill centers alternative learning \$2.3 million which would continue the existing Community College skills centers?

095 SEN. BUNN: Yes. That funding would allow for those five centers and an additional \$500,000 beyond that.

101 CHAIR COHEN: I would propose that we take \$3 million out of the regional funding and move it to the skills centers for a total of \$5.3 million. Assures language enables K-12 skills centers to become regional forces. They have to expand to become a K-12 center.

134 SEN. BUNN: I do not see regional description in the amendments.

136 CHAIR COHEN: We need to re-work language for a commitment to serve beyond regional districts.

SB 755 - Lottery Allocation - Work Session

187 CHAIR COHEN: I have requested amendments to allow the reserve funds to be used as a back-up for the wood products fund. Also suggests amendments for OPB to take \$5.6 million from regional strategies.

SB 1076 - Workforce Lottery Allocation - Work Session

217 CHAIR COHEN: Need for providing a training program for rural physician assistants in rural areas. They need \$170,000 for start-up expenses. Possibly take this money from regional workforce.

260 SEN. BUNN: Positive with taking these funds from that source. Some of witnesses have left a wrong impression.

271 CHAIR COHEN: There are those that will come to the workforce quality council and request funds in a competitive way.

290 CHAIR COHEN: Adjourns meeting at 8:45 a.m.
