000 CHAIR COHEN: Convenes meeting at 8:30 a.m.

SB 1076 - Work Session -

010 CORTRIGHT: Begins overview of SB 1076 Staff Engrossed to Reflect Proposed -3 Amendments (EXHIBIT A) and Proposed -3 Amendments (EXHIBIT B).

189 BOB BAUGH: Discusses concerns with lines 9 and 10 of page 19 in EXHIBIT A.

MOTION: SEN. BUNN MOVES to delete lines 9 through 10 on page 19 of EXHIBIT A.

VOTE: PASSES, WITHOUT OBJECTION.

250 CORTRIGHT: Continues overview of EXHIBIT A.

300 CORTRIGHT: The Committee needs to address the blank percentages in lines 1 through 11 on page 22.

310 SEN. BUNN: Recommends that the issue of percentages in lines 1 through 11 on page 22 be deferred at this time and be discussed at a later time.

235 CORTRIGHT: Submits "Senate Bill 755 Summary of Allocations" (EXHIBIT F)

CORTRIGHT: Discusses allocation amount for Westside Light Rail. The total amount needed to fulfill the state's obligation for this activity is \$18 million.

Committee discussion regarding the state's funding obligation to Westside Light Rail.

MOTION: CHAIR COHEN MOVES to remove \$2 million from the proposed allocation amount of \$20 million for Westside Light Rail.

VOTE: PASSES, WITHOUT OBJECTION.

CHAIR COHEN: There is \$2 million that could be used for OPB.

CHIAR COHEN: Discusses industrial lands. The Governor will take \$3 million from the developable lands initiative from the following categories: \$1.625 million from the developable industrial lands recommendation (EDD); .\$700,000 from the developable lands allocation (DLCD); and \$675,000 from the developable industrial lands allocation (DSL). With that \$3 million, plus the \$2 million from Westside Light Rail, we would need to find another \$500,000 to add up to an OPB allocation of \$5.5 million.

399 CHAIR COHEN: I also have another proposal regarding fish. Presents Proposed -2 Amendments to SB 755 (EXHIBIT H).

Community Facilities Development or from EDD's developable lands section.

MOTION: CHAIR COHEN MOVES \$250,000 from rural community facility development to be used for salmonids (as described in EXHIBIT H).

VOTE: PASSES, WITHOUT OBJECTION.

053 MOTION: CHAIR COHEN MOVES that \$250,000 be reserved out of the Community Facilities funding for maintenance and restoration of covered bridges.

VOTE: PASSES, WITHOUT OBJECTION.

074 CHAIR COHEN: We still need \$500,000 for OPB.

080 SEN. HAMBY: Discusses the high-speed rail corridor from Vancouver to Eugene.
