On line 26, the hand-written amount of "10 %" should have been the amount that was recommended in the evaluation but I don't know what that amount is - I do know it is not 10. Perhaps EDD knows.

GLANCY: The amount recommended for loan funds and business development in the evaluation was 25 percent. AOC and EDD have jointly agreed to a 30 percent level that we have previously recommended in another amendment. The evaluation didn't recommend a percentage, however, it did recommend a match from local committees with a suggestion that county proceeds from video lottery could be used for that match. Again, in a previous amendment AOC and EDD have recommended that there not be a limitation on technical assistance and staff support; that should be a board decision. 382 SEN. WEBBER: I would agree with that recommendation.

SEN. RASMUSSEN: I also agree.

SEN. KENNEMER: I would favor a lower number so that technical assistance cannot evolve into a major part of the project.

GLANCY: I would rather a dollar figure be used than a percentage since a percentage of a lower populated, i.e., rural, area would tend to be lower and they need the help most.

452 SEN. LIM: Recommends some form of guidelines.

050 GLANCY: I am concerned about the word "percentage". I think "portion" would be a better word.
