from an audit of over 400 boards and commissions.

035 CHAIR WEBBER: Were the 400 boards all statutory or are some
created by Executive Order?

048 MORSE: Both. Some we could find no creation authority for.

038 MORSE: The Governor developed a list of criteria to determine
the viability of boards and commissions. Gov. Roberts announced
elimination proposals; sometimes people came forward and others were
screened out. This bill eliminates 30 some boards.

068 MARGIE LOWE: Begins overview of Labor Committee's deliberations on SB 127 . Presents section-by-section analysis of SB 127 (EXHIBIT A).

098 LOWE: Would like to have following boards re-added to the bill (removed from bill by Senate Labor Committee): Mass Transportation Financing Authority; Local Budget Advisory Committee; and State Speed Control Board.
