SB 167 - Department of Business and Consumer Services - Work Session

005 SEN. RASMUSSEN: Overviews subcommittee's work on SB 167. Information submitted as EXHIBIT A.

032 SEN. LIM: Proposes change in membership of Real Estate Board.

MOTION: SEN. LIM MOVES change in Real Estate Board.

VOTE: MOTION PASSES, 5-1; SEN. KENNEMER votes no. SEN. WEBBER is excused.

062 MOTION: SEN. RASMUSSEN MOVES conceptual amendments (included in EXHIBIT A), in addition to SEN. LIM's amendment.

VOTE: MOTION PASSES, 6-0. SEN. WEBBER is excused.

MOTION: SEN. RASMUSSEN moves SB 167, as amended above, to the Senate Floor with a Do Pass recommendation.

VOTE: MOTION PASSES, 5-1. SEN. KENNEMER votes no. Sen. Webber is excused.

092 CORTRIGHT: Overviews Proposed -5 Amendments to SB 335 (EXHIBIT

140 SEN. HAMBY: The Eugene Registered Guard just completed a three month investigation into gambling. Reads and discusses passages from the report.

165 SEN. KENNEMER: Asks for a description of Gaming Education Program in the bill.

169 CORTRIGHT: In the original bill, lines 17-24 define that.

183 MIKE MCCALLUM: My understanding was that Lottery Commission would produce a brochure that would be handed out at this training program; OLCC would distribute it. I thought there would not be a Section 3 in this bill. That would remove the fiscal impact to the server - \$25. We would object to that.

210 SEN. HAMBY: Is concerned with the servers involved in illegal gaming and what their role is.

MCCALLUM: Those issues would be discussed in the brochure.

225 SEN. KENNEMER: Need to modify \$4(6) to show that we are talking about the brochure.

255 MCCALLUM: Discusses criteria for alcohol server training.

265 MOTION: SEN. HAMBY MOVES to delete Section 3 of SB 335.

VOTE: Hearing no objection, so ordered. Sen. WEBBER is excused.

SEN. COHEN: Thinks that the Lottery Commission could provide the program through independent contractors.

SEN. HAMBY: There are ways of reaching out to Gambling Anonymous members.

302 MOTION: SEN. HAMBY MOVES the proposed -5 Amendments, as amended by the deletion of Section 3.

CORTRIGHT: Discusses lines 5-11 of the -5 amendments.

VOTE: Hearing no objection, so ordered; SEN. WEBBER is excused.

340 MOTION: SEN. HAMBY MOVES SB 335, as amended, to the Senate Committee on Ways and Means (by prior reference) with a Do Pass recommendation.

VOTE: MOTION PASSES, 7-0.
