000 CHAIR COHEN: Convenes meeting at 8:40 a.m.

HB 3231 - Beneficiaries for Lottery Winners - Public Hearing

009 ROBERT SAALFELD: Presents testimony in support of HB 3231 (EXHIBIT A).

040 SEN. LIM: Is this retroactive?

SAALFELD: I believe so.

SEN. LIM: I didn't read that in the bill. It should be specified.

SEN. RASMUSSEN: I read the bill to be retroactive.

054 SEN. KENNEMER: This bill makes sense.

063 SEN. HAMBY: Presents Proposed -A4 Amendments to HB 3231A (EXHIBIT B).

090 SEN. RASMUSSEN: These amendments ask us to amend the "relating to" clause. We can't do that in a House bill, can we?

095 CHAIR COHEN: I wouldn't recommend it.

102 CHAIR COHEN: I don't know how sending another directive to the

counties will help us.

SEN. KENNEMER: If we are going to adopt these amendments, this bill would need to go to Ways and Means.

SEN. HAMBY: It's money that's already allotted. The question was to clarify the Attorney General's opinion on whether or not administrative funds could be used for treatment programs.

114 SEN. KENNEMER: I am also concerned about the language "establish public relations programs". I don't think public relations is treatment.

122 CHAIR COHEN: I don't think this is the right or place for this.

134 MOTION: SEN. KENNEMER MOVES HB 3231-A to the Senate floor with a do pass recommendation.

VOTE: MOTION CARRIES, 7-0.

SB 1130 - Government Productivity Act - Work Session

154 CAROLYN YOUNG: Presents Proposed -3 Amendments to SB 1130 (EXHIBIT C).

175 YOUNG: Presents Proposed -4 Amendments to SB 1130 (EXHIBIT D).

230 SEN. HAMBY: What kinds of productivity activities have been funded in the past?

237 ART JAMES: Responds.

283 SANDY BURT: Describes the Vendor Information System project.

300 SEN. KENNEMER: Where do savings go?

305 JAMES: Fifty percent of the savings would return to the General Fund; 50 percent could be returned to the Agency upon approval of a plan to generate seed money.

Discussion.

356 JAMES: Submits information on Employee Suggestion Awards Program (EXHIBIT E). Employee Suggestion Awards Program is a long-standing program in existence since the 1950's. In 1989 another program was appended to it. These amendments separate these two programs. 390 JAMES: Overviews specifics of Employee Suggestion Awards Program.

400 CHAIR COHEN: Why is the commission involved in this?

405 JAMES: Part of the purpose of the commission is to determine whether the employee is awarded cash for the suggestion.

CHAIR COHEN: Then this is separate and above anything that an agency director would do in terms of productivity improvement.

430 SEN. WEBBER: Refers to EXHIBIT E. This is not helpful.

030 SEN. HAMBY: Asks about the extent of the monetary awards. How much has it cost us? Is there a maximum? How is the level of award determined? Is there any tie to potential savings? Agrees with Sen. Webber that EXHIBIT E is not helpful.

085 YOUNG: Presents Proposed -5 Amendments (EXHIBIT F).

125 YOUNG: Presents "Suggested Amendments to SB 1130" (EXHIBIT G).

200 SEN. HAMBY: Presents "Proposed Amendments to SB 1130" (EXHIBIT I).
