SB 1130 - Government Productivity Act - Work Session

011 MARY BOTKIN: Presents amendments to SB 1130 (EXHIBIT A).

SEN. LIM: How many temporary employees are there? What is the definition of "temporary employees"?

BOTKIN: Unsure of exact number; will get that information. Presents examples of use of temporary employees.

080 DAN SIMMONS: Discusses Section 12. 130 CHAIR COHEN: Suggests the adoption of hand-engrossed version (EXHIBIT B) as a working document for further use.

160 DON WAGGONER: Presents written testimony (EXHIBIT C) on Secretary of State's proposed amendment (EXHIBIT D).

250 MIKE GREENFIELD: Addresses Sen. Cohen's concerns and discusses

the Joint Legislative Audit Committee.

336 Discussion on telecommunications and Executive Department amendments (EXHIBIT E).

387 RON EACHUS: Presents testimony on telecommunications and broad-band networking.

030 EACHUS: Continues testimony.

097 SEN. HAMBY: Doesn't think there is sympathy for the state to build on.

100 EACHUS: Discusses mandating a particular technology. Policy considerations should not relate to a particular technology, but should allow for the best decision in terms of what is wanted to be accomplished.

144 EACHUS: Overviews recommendations from Governor's Task Force in 1991.

171 CINDY BECKER: We agree with EACHUS' testimony. The amendment before you attempts to state policy - review a combination of factors.

220 GINNY LANG: Presents testimony. Supports new amendment (EXHIBIT E). Presents "Internet Services" (EXHIBIT F) and "Global" (EXHIBIT G).

MOTION: SEN. LIM MOVES adoption of Proposed -3, Proposed -4, and Proposed -5 amendments, and other changes, as reflected in the hand-engrossed version of SB 1130, dated 6/8/93, and to use the bill as amended as a working document.

290 CAROLYN YOUNG: Overviews hand-engrossed version of SB 1130 (EXHIBIT B).

318 VOTE: MOTION PASSES, 5-1. SEN. GOLD votes "no" to adopt amendments into bill as a working document.

CHAIR COHEN: Adjourns meeting at 9:35 a.m.
