000 CHAIR COHEN: Convenes meeting at 8:30 a.m.

010 MIKE LINDBERG: Overviews activities of Oregon Film & Video Board and his interest in serving another term on that Board.

037 SEN. WEBBER: I am impressed with the industry and economic development

re-appointment of MIKE LINDBERG to the Oregon Film & Video Board be forwarded to the Senate Floor with a recommendation that the Governor's appointment be confirmed.

405 SEN. KENNEMER: PUC is neutral on the transfer issue. It works well and there is no reason to change this.

MOTION: SEN. KENNEMER MOVES to conceptually amend SB 98A to retain the State Weighmaster function under Oregon Department of Transportation, rather than PUC.

MOTION: SEN. KENNEMER ADDS to above motion that the name of state weighmaster be changed to motor carrier enforcement officer..

VOTE: Passes 7-0.

MOTION: CHAIR COHEN MOVES the adoption of the Proposed -A22 Amendments

(EXHIBIT D).

VOTE: Passes, 7-0.

MOTION: SEN. MOVES SB 98A, as amended above, to the Senate Floor with a Do Pass recommendation.

VOTE: Passes, 7-0.

VOTE: PASSES, WITHOUT OBJECTION.

233 CAROLYN YOUNG: Presents proposal to create an Interim Task Force on State Retirement System Reform. (EXHIBIT H).

MOTION: SEN. HAMBY MOVES to adopt EXHIBIT H as a conceptual amendment.

VOTE: PASSES, WITHOUT OBJECTION.
