Review starts with Page 20, lines 5 and 6. 022 PAUL SNIDER: Comments on proposed language. 031 JERRY JUSTICE: Objects to proposed language. 052 RICH PEPPERS: We have discussed the counties' concern and would be willing to develop alternate language. CRAIG CAMPBELL: We have no comment on the proposed language. 062 066 CHAIR COHEN: This section needs to have new language developed. 069 CAROLYN YOUNG: Overviews Proposed Section 15 from EXHIBIT A. 077 CHAIR COHEN: I am not in favor of this maintenance of effort. 085 SEN. RASMUSSEN: I am also concerned about this proposed language. 092 Committee discussion regarding Section 15 from EXHIBIT A. YOUNG: Discusses language from "Proposed Amendments Alternative 105 Language" (EXHIBIT B) - Alternative language from SEN. RASMUSSEN. 126 GORDON FULTZ: Our preference would be to use the language that is in Section 15 of the Proposed - B36 amendments. 140 CAMPBELL: It may be possible to keep language from Section 15 and then add a sub 2 with SEN. RASMUSSEN'S language. CHAIR COHEN: OK. 158 CHAIR COHEN: Overview of Section 16 from EXHIBIT A.

CHAIR COHEN: I would propose not accepting these amendments.

187 YOUNG: Overviews Section 18a on page 21 of EXHIBIT A.

CHAIR COHEN: I a n concerned about the word "plans".

226 CHAIR COHEN: I would proposed to delete Section 18a and b from

EXHIBIT A. 229 YOUNG: Overviews Section 28.

CHAIR COHEN: Any objection to Subsection 1 in Section 28 on page 23 (from DHRlanguage)? I would recommend leaving the language from the B-engrossed version's Subsection 1 and adding the language from the Proposed -B36 subsection 1 m also.

311 BETTY UCHYTIL: Discusses other entitlement services that could be included. Senate Trade & Economic Development Committee July 20, 1993 Page 3

My readmg of this leads me to believe they are trying to narrow their focus. 077 SEN. WEBBER I would propose to put a period after "children" in line 7 and delete the remainder of the language in lines 7 and 8. 090 SEN. WEBBER: I am concerned that local jurisdictions not have their responsibility impeded. 106 SEN. KENNEMER: Is the local option for Day Treatment? 154 SEN. WEBBER: Proposes language on county role on day treahnent. 159 VICKI GATES: Discusses options for change relationship with day treatment programs. 175 LARRY OGLESB Y: Withdraws proposed amendment specifically providing for transfer of remaining CSD functions--this is no longer needed. 195: YOUNG: Presents Speaker's amendment on pilot programs (from EXHIBIT B). 220 CAMPBELL: Comments on reasons for Speaker's amendment. Senate Trade & Economic Development Committee July 20, 1993 Page 4

PAM PATTON: Comments on language regarding pilot program. We oppose transfer of adoption and foster care to the county level. SEN. KIINNEMER: Expresses concern about moving adoption to the local level. 280: SEN. HAMBY: I don't see how adoptions could be moved to the local level. 324 PEPPERS: Opposes foster care and adoption to be moved to the local level. 455 YOUNG: Overviews Section 29 from EXHIBIT A. 470 CHAIR COHEN: I would propose that we add language stating "upon approval of legislature."

030 CHAIR COHEN: Continues to describe added language.

O33 CAMPBELL: When the Legislature would approve it, would this be a general area of services? O37 CHAIR COHEN: Explains. O45 CAMPBELL: The Speaker's office is in favor of a strong state commission. O54 Committee discussion regarding proposed language. O99 RICH PEPPERS: I would recommend that the current language remain. 104 CHAIR COHEN: I will withdraw my language. 113 Committee discussion. 139 CAROLYN YOUNG: Overviews lines 28 (on page 23) through Ime 12 (on page 24) of EXHIBIT A. 144 PAUL SNIDER: I am concerned over new language proposed in subsections 2 and 3.

SENATORS HAMBY, RASMUSSEN, and COHEN concur with concerns.

177 RICH PEPPERS: Describes reasons for language proposed by the Ad Hoc Committee in subsection 2.

SENATORS RASMUSSEN, HAMBY, COHEN, KENNEMER, and WEBBER concur on deletion of subsection 2 and subsection 3.

195 YOUNG: Overviews Section 30 of EXHIBIT A. 212 CAMPBELL: We do not oppose these amendments from the Ad Hoc Committee. 215 SEN. KENNEMER: I appreciate the amendment. 222 SEN. KENNEMER: Discusses lines 16 through 19 on page 24 of EXHIBIT A (Subsection (2) of Section 30) '' Senate Trade & Economic Development Committee July 20, 1993 Page 5

ANGELA SHERBO: We had proposed deletion of this; now we have just asked that Legislative Counsel review it. This could lead to endless litigation. 263 SEN. KENNEMER: What would happen if Subsection 2 was deleted? 275 CAMPBELL: That language was added when the reach of the bill was more broad and intrusive. It was then very important. 294 SEN. RASMUSSEN: I don't eliminating this will reduce possible litigation. 316 CHAIR COHEN: I would support removal of the entirety of sub 2.

SENATORS HAMBY, KENNEMER, and RASMUSSEN concur.

350 SEN. HAMBY: I still see Section 30 (1) as a firewall.

Continued discussion.

440 CAROLYN YOUNG: Overviews Subsection (3) on Page 25 of EXHIBIT A.

O30 CHAIR COHEN: I don't like this language. It is not related to the "wellness" model. 032 CRAIG CAMPBELL: This language was intended to remedy oversight. 055 YOUNG: Overviews minor amendments in Section 37 (Pages 26 and 27 of EXHIBIT A). 062 CAMPBELL: We have no objection to this proposed language. 067 YOUNG: Overviews Section 56 (Page 41 of EXHIBIT A).

CHAIR COHEN: I have no objection to this proposed language.

072 CHAIR COHEN: Discusses Section 57 of EXHIBIT A. I would recommend deletion.

SEN. KENNEMER: This is handled under the plan. The services can be transferred back to the state.

CHAIR COHEN: I would recommend deletion of this language.

O87 CAMPBELL: On Page 13 oftheProposed-B36amendments,Line 15,after"division",thefollowing language needs to be added: "or, on and after July 1, 1995, the State Off~ce for Services to Children and Families,". 120 PAUL SNIDER: Presents Proposed -B38 Amendments (EXHIBIT C).

RICH PEPPERS: We will work with this language also and brmg something back to you.
