CHAIR SCHOON: The bill related to advertising in movies. The Legislative Counsel drafter felt we had missed the portion of the bill that deals with radio broadcasting. We didn't actually, but they wrote the amendment that we adopted in concept to deal with radio broadcasting as well as newspaper advertising (EXHIBIT A). That was not our intent. The amendment is substantive in nature and therefore I felt we needed to reconsider the bill in order to decide whether we wanted to adopt the amendment or not.
