004 CHAIR RIJKEN calls the meeting to order at 9:05 a.m., welcomes a
group of high school seniors from Tigard High School and opens the
public hearing on SB 227.

SB 227 - REQUIRES INTRASTATE TELECOMMUNICATIONS TOLL SERVICE PROVIDERS
TO IDENTIFY SERVICE LEVEL TO PUBLIC UTILITY COMMISSION AND TO MAINTAIN
THAT LEVEL AS CONDITION OF CERTIFICATION FOR SERVICE.

010 TERRY CONNOLLY, Administrator, reviews the Senate Staff Measure
Summary (EXHIBIT A).

The Legislative Fiscal Analysis and Revenue Impact Analysis are hereby

018 MIKE KANE, Assistant Commissioner, Public Utility Commission,
introduces Scott Girard.

020 SCOTT GIRARD, Administrator, Telecommunications Division, Public
Utility Commission, submits and reads a prepared statement in support of
SB 227 (EXHIBIT C).

035 Issues discussed: >Method of notifying consumers has not been
established. >Bill provides for enforcement of service standards of the
telecommunication long distance provider. >Providers are required to
inform consumer of the frequency of being able to complete calls. The
standard in the rule is 99 percent completion by customer.
>Determination of facts in complaint cases. >Extended area service.

SB 230 - REMOVES JURISDICTION OF PUBLIC UTILITY COMMISSION OVER CONTRACTS FOR PRODUCTION, TRANSMISSION, DELIVERY OR FURNISHING OF HEAT,LIGHT, WATER OR POWER TO OR FOR PUBLIC BETWEEN TELECOMMUNICATIONS UTILITIES WHICH ARE ONLY INDIRECTLY ENGAGED IN SUCH BUSINESS.

161 MR. CONNOLLY reviews the Senate Staff Measure Summary (EXHIBIT D).

251 SEN. JOHN BRENNEMAN: Introduces Edwin Parker of Gleneden Beach, a consultant in telecommunications. Mr. Parker has an interest in rural communications issues. This bill is one for rural development and economic development in rural areas by bringing communications to rural Oregon.

280 EDWIN B. PARKER submits and reads a prepared statement in support of SB 470 A-Eng. (EXHIBIT H).

400 SEN. BRENNEMAN: Although the telephone companies can speak for themselves, there were some problems that were taken care of in the amendments. I think there is no opposition at this point.

412 SCOTT GIRARD, Administrator, Telecommunications Division, Public Utility Commission, submits and summarizes a prepared statement in support of SB 470 A-Eng. (EXHIBIT I).

428 CHAIR RIJKEN closes the public hearing and opens the work session on SB 470 A-Eng.
