004 CHAIR PARKINSON calls the meeting to order at 1:23 p.m.

INFORMATIONAL HEARING ON DIOXIN OVERVIEW

DOUGLAS MORRISON, NORTHWEST PULP AND PAPER ASSOCIATION: Introduces the panel.

019 KATHY GILL, NW PULP AND PAPER: 1. 2. Brief overview of the fear of dioxin. 3. Encourage the committee. -History of Dioxin, agent orange, love canal, times beach are a few of the negative sounds. -found also in nature. -study to find how dioxin got into paper products 1988 -By 1990 voluntary efforts have cut down to 1%

MORRISON: Who filed petition? these two companies -Researchers have dramatically reduced fear of dioxin, safe for humans. There is a threshold of exposure. -Washington state reevaluated the effects, the risk is over 3,000 times less than Oregon's standard.

whitty: What are comparable standards to Oregon.

MORRISON: 0.013 parts per quadrillion.

park: Can you measur that small of an amount?

MORRISON: No, you can see 1 part but that is with a million dollar piece of machinery.

whitty: must have been able to at some point.

MORRISON: The object is to get everyone down to that level of detection.

naito: How dioxin comes about and what are the effects?

MORRISON: Part of the leaching process of improving the quality of the pulp. The use of chlorine is the main culprit of dioxin.

whitty: Please explain pulp and what happens with the dioxin?

140 MORRISON: The pulp is a ...substance. if the dioxin goes into the water it may effect the fish. We need to find out the effects on the fish.

norris: If all these dioxins were collected in one area, how big would it be?

CAROL WHITAKER, JAMES RIVER CORP:

## naito:

181 MORRISON: All paper products are safe for use and a few molecules of dioxin will not cause risks that would be noticable. -Overview of position: lot of changes in scientific studies., the mills here in Oregon have voluntarily made changes to reduce dioxins but we need to reevaluate for DEQ to make a decision.

220 DICK NACHB AR, BOISE CASCADE CORPORATION: Personal involvement of dioxin has included a number of leadership roles on this issue.

-Beneficial uses of water protected -Available scientific research needs to be used. -Boise Cascade is already using best available science to reduce numbers of dioxins.

267 WHITAKER: James River Corp is actively supporting... because the existing standard does not reflect scientific thought. -With the best technology available, still not sure if they meet qualifications. -The data currently available does not meet the restrictions. -Levels of dioxin found in the fish in Columbia river are low enough to not have an effect on humans. -Study done on lake... should not be policy here since the water level is much lower and restrictions there are much lower.

MORRISON: The companies represented here today have been presented permits for dioxin levels. We would like to look at the standards again in a public arena.

naito: Does anyone look at the problems in the water?

MORRISON: Yes, this is a water quality standard. At any point of the water should not go over that standard. -reduced concerns -EPA is re lookin at their own standards.

054 LYDIA TAYLOR, DEQ: The commission would accept a petition from anyone. The question would be should the DEQ accept it.

park: EPA does not set policy in Oregon?

TAYLOR: Water quality standards are set state by state. States may be overruled if not strict enough.

norris: If epa denied the postion, then what?

TAYLOR: dont know

norris: if the petition is accepted, would it go to the public?

TAYLOR: We have already had extensive public participation on this

issue.

norris: Would you test for person's credibility from a scientifec point of view.

TAYLOR: We would be very careful.

park:

TAYLOR: The standard that we adopt need to be credible. If they are frivolous they wouldn't stand up in court.

park:

TAYLOR: Not to my knowledge.

repine:

TAYLOR: The standard is developed to protect the water. if it is not measurable at the plant, it still may be measureabld in the water.

repine: EPA report sceduled to be completed?

TAYLOR: Possibly two years.

van 1: specifically wasn't the ... asking Pulp and Talbit to meet a standared that was not measurable?

TAYLOR: The current standard is not measurable in the water column.

van 1: ours is higher than epa?

TAYLOR: epa doesnt' have standard

park:

TAYLOR: You can measure dioxin in the sludge that is removed from the plant. Permit holders have the option of measuring by other methods.

park:

TAYLOR: EPA suggested the DEQ standard. You may find variety from state to state.

222 norris: Submits testimony on Dioxin effect (EXHIBIT B).

van 1: Submits testimony (EXHIBIT C)

385 KELLY ROSS, OREGON ASSOCIATION OF REALTORS: Explains dash 16 amendments (EXHIBIT F). -Should allow land for non-farm uses.

van 1: Thought dash 14 allowed for those uses.

ROSS: Yes, but it does not allow the property to be split. You must farm the whole land. -line 11 of dash 16 subsection 3 should be subsection 2.

repine: do you really mean...

kathryn: Dash 14 amendments delete sections 21 and 22.

norris: "NOTE:" in amendment says that sections were deleted but they aren't.

ROSS: Reccomend deletion.

171 JANE MYERS, FOREST INDUSTRY COUNCIL: Explains dash 17 amendments to HB 3570.

norris: Questions this as a land use decision.

## Myers:

van 1: Set back usually refers to the set back from the road. Are you refering to the road or the nearest forest.

Myers: It is meant to be 500 feet from the nearest forest. 253 repine: Concerned with the term adequate in the amendments. Could a house be adequately protected on it's own with sprinklers and what not?

Myers: We could provide wording for that.

repine: Section (C) in the amendments. Do the standards of roads apply to driveways?

Myers: Yes, the driveway needs to be accessable to fire fighting equipment.

whitty: My house does not comply with any point in your amendments.

MYERS: Not sure what bill you are refering to.

SB 783- PUBLIC HEARING

SEN. JANE CEASE: Testifies in favor of SB 783 and submits written testimony (EXHIBIT I). The Washingtion legislature has not passed ...We are supposed to ship it? over on the safest route but we have not been able to. Any material that needs to be moved would continue to move on 30 to hook up with I205.

park: Is this high level radio active waste? This doesn't deal with the low level waste?

MIKE GRAINEY, DEPARTMENT OF ENERGY: Submits testimony (EXHIBIT I) This bill is intended to deal with only materials from Trojan Nuclear Plant. Washington refuses to allow any waste from Trojan on I-5.
