005 CHAIR REPINE: Calls the hearing to order. (8:05 a.m.)

Roll Call: Representatives Bell, Repine, Shibley & Sunseri answer "present".

WORK SESSION ON SB 132

010 REP. BELL: We held a work group on this and came up with amendments, (EXHIBIT A).

On page 1 & 2 we dealt with subpoena power by inserting "with the authorization of the office of Attorney General"; this won't bind them, but it does keep the current procedures and the AG will be aware of what is going on.

In section 4 we are adding some ORS chapters to make certain that the civil penalty money would be used for enforcement; it wouldn't go into the general fund or anywhere else, but will keep the system moving.

025 REP. BELL: The fiscal concerns I had have been cleared up.

035 MOTION: REP. MCTEAGUE moves the adoption of the (-B7) amendments.

VOTE: Hearing no objection the motion carries unanimously. Members excused: Bauman & Johnson

045 MOTION: REP. MCTEAGUE moves SB 132-B as amended to the floor with a do pass recommendation.

REP. BELL: I would like to thank those who participated in the working group, they were helpful and patient.

052 VOTE: In a roll call vote the motion carries unanimously. Members excused: Bauman & Johnson CARRIER: BELL

REP. BELL: I would like to take this opportunity to have on the record how much I appreciate your work as a Chairman; I have felt comfortable in this committee that everyone has had a fair hearing and I feel that there has been good cooperation in a great part due to your efforts.

070 REP. MCTEAGUE: I want to say that I have appreciated your leadership on this committee and particularly in the area of the housing trust fund where we produced some good legislation, but I am concerned about what the senate is talking about now, so we may want to pull together and lobby our House Ways and Means members.

CHAIR REPINE: Now that we are standing down we will have extra hours to do some of the work that needs to be accomplished in other committees and rooms in this building.

I do want to thank staff for their hard work.
