The two main points are: 1) permits PCs to engage in any business authorized by regulatory boards including combinations and 2) repeals section of current law imposing joint and several liability of shareholders. Discusses latter point. (AMENDMENTS - EXHIBIT N and O).

057 MOTION:REP. MANNIX: Moves HB 2375 as amended to the House floor with a do pass recommendation.

059 CHAIR MILLER: Rep. Mannix moves HB 2375 to the floor with a do pass recommendation. Further Discussion.

067 REP. EDMUNSON: Comments on consideration of bill. Did not amend to provide for elimination of joint and several liability where there was insurance to cover those cases. Discusses insurance and physicians concerned about this. Should not change this law until changes the partnership law.

087 REP. BAUM: Need to think about the list of PC folks. Insurance requirements may be difficult for some. On issue of partnership and PC understand that partnership was not created for benefit of doctors, attorneys, but for business people. Discusses differences between partnership, PCs, and corporation. Comments on rural areas.

112 REP. CLARK: Discusses reason for floating amendment in subcommittee regarding insurance and joint and several liability. OSB requires \$300,000 of insurance. Opposed to the bill. Cannot get around fact of other entities and with passage of this bill not sure what the difference would be between PCs and other ways of doing business.

143 REP. MANNIX: Discusses reasons for PCs being formed. Does not change the definition of a PC. There is also an entity there that can be liable.

173 REP. BAUMAN: The issue of whether professionals may incorporate under the business corporation act is not addressed in this bill, is it?

176 GREG CHAIMOV: There is a Senate bill that does address that.

REP. EDMUNSON: The amendment was not to provide insurance for the shareholders but the PC would maintain insurance and if maintained then shareholders would not be liable.

184 REP. MASON: Opposes the bill on grounds that bill is creating two classes of professional groups. It will benefit the large mega-firm PC but not the small PCs.

200 REP. JOHNSON: Believes large firms will have tons of insurance on other hand, small law firms may not have a lot of insurance.

222 REP. BELL: Comments on judgment calls that individuals make under best knowledge and with best information. Don't see why physician down the hall should be responsible for other partners. Unfair punishment.

231 REP. PARKS: Will vote for the bill. Wants to get to the House floor for a vote.

237 REP. JOHNSON: States a potential conflict of interest. (EXHIBIT P).

265 REP. EDMUNSON: Own a PC also.

268 REP. MANNIX: Owns a PC also.

REP. MASON: Discusses written notice.

REP. JOHNSON: To be in file.

CHAIR MILLER: Calls the question.
