SB 101 - WORK SESSION

006 CHAIMOV: SB 101 creates a standard procedure for imposing agency civil penalties. The bill requires a detailed written notice of the penalty and grounds for the penalty. The party assessed then has 20 days from the time of receiving the notice to ask for a hearing which is then a contested case under the Administrative Procedure Act.

011 MOTION: REP. BAUMAN: Moves adoption of the SB 101-A6 amendments (EXHIBIT A).

SB 732 - WORK SESSION

020 HOLLY ROBINSON: SB 732 revises the way workers compensation permanent partial disability benefits are calculated, going to a percentage amount of the average weekly wage times the numbers of degrees rather than the current figure of \$305 per degree.

New calculation method will be applicable between January 1, 1991 and January 1, 1996.

024 MOTION: REP. EDMUNSON: Moves SB 732-A5 amendments (EXHIBIT B).

SB 766 - WORK SESSION

058 DOLE: SB 766 would require mass transit and transportation districts to use vehicles which burn alternative fuels such as propane or natural gas. After July 1, 1993 these districts must purchase only these kinds of vehicles unless the vehicles will be used in areas which

lack refueling stations or financing is unavailable.

SB 766-A6 amendments extend the bill to cover the Eugene and Salem Transit Authorities and add reformulated gasoline and low sulfur diesel fuel to the definition of alternative fuels.

068 MOTION: REP. CLARK: Moves adoption of SB 766-A6 amendments (EXHIBIT C).

VOTE: Without objection, amendments are adopted.

072 MOTION: REP. CLARK: Moves SB 766-A, as amended, to the floor with a do pass recommendation.

192 REP. MANNIX: The bill is in response to our current poor economic circumstances to allow certain fisher people to maintain their potential license status without having to pay fees if they are not actively operating.

207 MOTION: REP. EDMUNSON: Moves SB 1219, as amended, to the floor with a do pass recommendation.
