004 CHAIR RANDY MILLER: Opens House Committee on Judiciary at 4:45 p.m. Announced it is unlikely that SB 638 and SB 718 will be heard.

SB 882 - WORK SESSION

015 CHAIMOV: Summarized SB 882.

MOTION, REP. BAUMAN: Moved the SB 882 to the Floor with a do pass recommendation.

VOTE: Motion passed. Rep. Bauman to carry.

SB 1076 - WORK SESSION

033 HOLLY ROBINSON: Summarizes -A34 amendments. EXHIBIT A.

050 CHAIR CLARK: What was the vote on the tax credit. Did we vote to extend that?

052 ROBINSON: Yes. The tax credit was extended for the same period of time that 935 is being extended.

054 CHAIR CLARK: The bill that came to us extended the mandate on small businesses to provide health insurance, but did not extend the tax credit. That was one of three major changes made from the Senate version that will probably put the bill into conference committee.

062 REP. PARKS: What did we decide to do about changing from 5 to 3 years if you opt out?

063 ROBINSON: That motion was defeated.

064 REP. PARKS: Where is the language that requires all carriers to participate in the re-insurance pool?

065 ROBINSON: Section 11 of the bill. Page 17, Section 9. That is where your operative language came out and as a result, there were numerous other changes that were made. Those changes are the same as those which appeared in the -A33 amendments.

081 REP. PARKS: What is a multiple employer welfare arrangement? Is that what the banks have?

082 ROBINSON: Those are organizations that are groups like the League of Oregon Cities trust that offers insurance and other groups that form for the benefit of larger organizations. Also union trusts that offer health benefits.

086 REP. PARKS: Did they want to be in the re-insurance pool? Wasn't his intention that they needed to be because they are not commercial carriers.

091 REP. CLARK: Wants to thank the sub-committee for the hard work on this complex bill. Feels they did excellent work and Counsel was very helpful.

095 MOTION, REP. CLARK: Move the -A34 Amendments.

097 CHAIR MILLER: Asked for objections. Asked for roll call vote.

VOTE: Motion passed.
