She pointed out Proposed Rules and requested members review them for possible adoption the next day. Exhibit 1 100 CHAIR JONES noted the impact from Measure 5 on Oregon's current tax system. The House Revenue Committee will begin work on Measure 5 implementation after orientation meetings. The orientation will cover Oregon's current tax system. Work on distribution of school funds will begin in the Senate Revenue Committee. Chair Jones noted subcommittees will be formed and will meet once a week. The full committee will meet four times a week. One subcommittee will be Retirement Tax Equity and another will be announced. 154 CHAIR JONES explained that Measure 5 implementation issues will take place prior to replacement revenue issues. 169 REP. HOSTICKA expressed his concern regarding the complete impact of Measure 5 on the entire tax system. He pointed out that there will be "winners" and "losers" because of Measure 5 and those effects must be understood.
