the SB 814 formula with questions and discussion interspersed. 231
CHAIR JONES clarified her intent for the committee regarding SB 814. 251
TERRY DRAKE continued his explanation of the SB 814 formula with
questions and discussion interspersed. 370 CHAIR JONES conducted
administrative business in relation to SB 814. PUBLIC HEARING HB 3577
378 REP. MANNIX noted sole sponsor for HB 3577 and discussed its
companion HJR 27. TAPE 227. SIDE A 001 REP. MANNIX continued with his

registration. 077 REP. MANNIX pointed out that motor vehicles do not
get a permanent registration and the language in HB 3577 is not intended

to say that does not have to be paid each year. 077 REP. WHITTY questioned if HB 3577 language applies to recreational vehicles. 090 TERRY DRAKE clarified there is no language excluding them. 095 Questions and discussion followed regarding the language in Section 2 of HB 3577. 111 TERRY DRAKE noted a revenue impact analysis was not completed for HB 357 7 and provided estimates. 120 Questions and discussion followed regarding the revenue impact of HB 357 7 in relation to the General Fund. 129 REP. MANNIX pointed out the intention of HB 3577 is to allow an opportunity to shift some General Fund dollars, but at the same time do a better job for the state police. 133 REP. MANNIX mentioned that the \$15 registration fee would be used for traffic enforcement wherever applicable. 140 Questions and discussion relating to HJR 27 as companion to HB 3577. 160 REG MADSEN read his prepared testimony supporting HB 3577. Exhibit 3 200 Questions and discussion regarding OSP budget and highway patrol. 240 REG MADSEN discussed the OSP mission, according to Statute 181, is to be responsible for enforcement of all traffic and criminal laws; game provisions, noting majority of personnel is dedicated to patrol. 260 Questions and discussion followed regarding HB 3577 in relation to HJR 27. 283 TERRY DRAKE clarified that HB 3577 would increase the registration fee \$30 every two years and discussed revenue impact of HJR 27 and HB 3577 in relation to effective dates. 315 Questions and discussion followed regarding revenue impact in relation to the "phase in" factor.
