005 CHAIR PARKINSON called the meeting to order at 8:05.

PUBLIC HEARING - HB 2608

010 STEVE MEYER explained HB 2608 deals with property tax exemption for veterans.

Questions and discussion interspersed relating to target group the exemption within HB 2608 would benefit.

PUBLIC HEARING - HB 2647

100 STEVE MEYER explained HB 2647 deals with transferring the veterans property tax exemption and allows occurrence after July 1 of tax year.

Questions and discussion regarding level of exemption.

- 124 KIM WORRELL commented on the current status of disabled veterans receipt of exemption. HB 2647 allows the veteran to transfer the exemption. He noted problems resulting from a veteran changing property which requires recalculation. KIM WORRELL urged the transfer of property prior to the calculation.
- 159 REP. SCHROEDER testified in support of HB 2647. HB 2647 is in response to a need which will allow a veteran or surviving spouse (up to 11/1) to receive the veterans tax exemption on new property purchased.

226 STEVE MEYER reviewed HB 2947 which doubles an existing property tax exemption to \$20,000 for those having a 100% service connected disability. Questions and discussion interspersed.

255 STEVE MEYER explained HB 2617 deals with farm use assessment and requalification of land under circumstances described in Subsection 5. He pointed out that SB 83 which passed the Senate which is similar to HB 2617. 297 KIM WORRELL explained SB 83 is a sunset clause extension of a provision which allows the Department of Veterans Affairs to foreclose on a property, hold the property, and then transfer the property to another eligible veteran. HB 2617 would extend the same treatment to private individuals. Association of Oregon Counties opposes HB 2617 and Kim Worrell pointed out the proposed treatment is not a necessity.
