SB 636 (Benchmarks) - Public Hearing and Work Session

013 MOTION: REP. KATZ moves to delete "basic skills" on page 5, line  
30, and after the word "mastery" insert "in essential skills".

033 VOTE: Being no objection, the above amendment is adopted.

078 CHAIR BAUM: This bill has been modified by several different  
committees. Did the Senate change anything in in this bill?

084 JOE CORTRIGHT: Yes. Refers to the Staff Measure Summary on SB  
636A (EXHIBIT A).

108 REP. HAYDEN: This bill does not require state agencies to undertake  
any action to achieve benchmarks. It is a commentary on our desires.  
There is no funding in this bill?

113 CHAIR BAUM: No.

125 REP. CARTER: If we can't get state agencies on board then it  
doesn't make much sense to do this.

139 MOTION: REP. MC TEAGUE move SB 636A to the floor with a Do Pass  
recommendation.

145 VOTE: By roll call vote (5-0), SB 636A passed to the floor with a Do Pass recommendation. Voting AYE: REPRESENTATIVES CARTER, HAYDEN, KATZ, MC TEAGUE and BAUM. EXCUSED: REPRESENTATIVES BARNES and PICKARD. Carrier: CHAIR BAUM.

152 REP. MC TEAGUE: What is the status of the lottery allocation package?

155 CHAIR BAUM: It is being heard right now.
