There is language that has hand engrossed amendments to it. I would move that we adopt this as a committee report and forward it to both the Senate and the House and recommend adoption of such committee report.

017 WHITFIELD: Read for the record, "sub 19, specific operational plans in connection with an anticipated threat to individual or public safety for deployment and use of personnel and equipment prepared and used by a law enforcement agency if public disclosure thereof would endanger the life or physical safety of a citizen or a law enforcement officer or jeapordize the law enforcement activity involved.

025 SEN. COHEN: I would amend my motion to say that we recede from the Senate amendments and substitute this language.
