004 REP. LIZ VANLEEUWEN, CHAIR: Calls the meeting to order at 5:34 p.m.

HB 2904 - WORK SESSION

009 JANET ADKINS, COMMITTEE ADMINISTRATOR; Summarizes HB 2904-B (EXHIBIT A). The HB 2904-B6 amendment (EXHIBIT B) provides for a farm vehicle plate to be used for transporting straw for another farmer who also qualifies for a farm vehicle plate. This could be done in exchange for products, labor or transportation of similar value if both farmers raise agricultural crops that produce straw.

MOTION: REP. NORRIS moves to adopt the HB 2904-B6 amendment dated 6/27/91 (EXHIBIT B) to HB 2904-B.

021 SEN. JOAN DUKES: Speaks to the motion. HB 2904-B allows farmers who have different equipment and need to share the responsibility on each other's farms for getting the straw off, to do so in trade. The Senate's concern was for the individual who would get straw for free from a farmer in a farm plated truck, took the straw and sold it for profit. That was looked upon as a commercial venture. This situation is

a shared type of responsibility amongst neigHB ors.

REP. LONNIE ROBERTS: Agrees with Sen. Dukes. This is far more restrictive than the original bill.

035 REP. VANLEEUWEN: Placed the sunset law on until July 1, 1995 at the request of Sen. Dukes.

VOTE: In a roll call vote, the motion carries with all members voting AYE.

050 REP. VANLEEUWEN: Speaks to the motion. Rep. Norris will carry the bill on the House side and Sen. Duff will carry the bill on the Senate side.
