365 REP. CLARK: Called the meeting to order at 7:15 P.M.

369 PAUL DONHEFFNER, MARINE BOARD: Explains the changes in the bill HB 3098 and amendments.

MOTION BY SEN. BUNN: Moves the amendment brought by the Marine Board.

370 REP. JOHNSON: Asked whether the word "boat" in line 27 would also need to have that language?

376 DONHEFFNER: Section 6 should apply to all boats. If a person in a non-motorized boat is willing to consent. They are not under any compunction to consent. But if they are in excess of .08, that would be indirect evidence.

385 REP. JOHNSON: So even if you can't make them blow, this could be a measurement for evidence for later use.

409 REP. CLARK: Asked for objections to the adoption of amendments. Hearing none, so ordered.

410 MOTION, REP. MANNIX: I move that the Committee adopt Committee Report in which we recommend passage of the bill as amended.

414 HOLLY ROBINSON: That the Conference Committee concurs with the Senate amendments and the bill be amended as follows.
