003 CHAIR MARKHAM: Calls the meeting to order at 11:42 a.m.

006 DICK SPRINGER, STATE SENATOR, DISTRICT C: Submits dash C23 LC amendments dated 6/22/91 to HB 3151 (EXHIBIT A). -Legislative Counsel advises this is a revenue measure if it is regulating taxation or an exemption. In a limited way, this bill regulates taxation or exemptions, so there is a question as to whether an emergency clause can be placed on this measure. -Questions whether an emergency clause can be placed on the bill. -Asks consideration of the dash C23 LC amendments which place the measure before the people as a referral. -Expresses opinion many in the state will make the effort to place the measure before the voters.

034 MOTION: SEN. FAWBUSH moves to adopt the dash C23 LC amendments dated 6/22/91 to HB 3151 (EXHIBIT A). VOTE: In a roll call vote, the motion failed, with Sen. Cohen, Sen. Fawbush and Rep. Baum voting AYE. Sen. Brockman, Sen. Cease, Rep. Shiprack and Rep. Markham voting NAY.
