003 CHAIR DERFLER: Opens conference committee on HB 3333 at 12:40 p.m.

006 MOTION: REP. SHIBLEY: Moves that the committee adopt the -B5 amendments, Exhibit A.

SEN. KINTIGH: Please clarify why these amendments are needed.

CHAIR DERFLER: A case concerning this issue is in litigation right now in Albany. We need to eliminate some ambiguity surrounding this issue.

-There being no objections, the amendments are adopted.

018 SEN. KERANS: Presents a couple of case scenarios in order to establish legislative history. In the first one the collective bargaining agreement involving school employees provides that sick leave is not available for use when the employee is on parental leave. This would conflict with the existing administrative rule. We understand that the collective bargaining rule would control.

CHAIR DERFLER: That is correct.

SEN. KERANS: The second example would be a collective bargaining

agreement involving school employees that does not address whether sick leave can be used for parental leave. Since there is no conflict, the existing administrative rule on accrued leave would then apply. Is that correct?

CHAIR DERFLER: That is correct.

SEN. KERANS: Finally, there is no collective bargaining agreement at all, at which point the existing administrative rules on leaves would govern. Since pregnancy disability is a medical condition, sick leave would be available at any time.

CHAIR DERFLER: That is correct.

034 MOTION: SEN. KERANS: Moves that HB 3333, as amended above, be reported back with the recommendation that the House concur in the Senate amendments dated June 13, 1991 and the bill be repassed.
