003 REP. ELDON JOHNSON, CHAIR: Calls the meeting to order at 8:10 a.m.

008 JANET ADKINS, COMMITTEE ADMINISTRATOR: Summarizes HB 3428 (EXHIBIT A).

013 REP. BOB REPINE: On the floor, House members were concerned as to whether or not there was a standard decibel rating. Janet checked with the Department of Environmental Quality's sound consultant as to the distance of a decibel rating. She may be able to respond to that concern.

018 ADKINS: There is a rating for mufflers on vehicles and for race track and racing events and off-road motorcycles. Some of them use 50 feet and some of them use track size decibel levels.

027 REP. REPINE: Another concern on the floor dealt with discretion. Should this issue be left up to law enforcement to use and interpret or should this be a violation that is initiated through a citizen's complaint?

032 SEN. JOAN DUKES: In our committee, we discussed both. In some

areas where there is a lot of cruising, police should be there to give citations. It was an individual who initiated this bill. There is a need for both.

MOTION: REP. JOHNSON moves that the House concur in the Senate amendments dated 6/12/91 and that the bill be repassed.
