CONFERENCE COMMITTEE ON SB 763 Witness:Mark Ford, Oregon Department of Transportation, (ODOT)

001 CHAIR COHEN: Calls the conference committee on SB 763 to order.

003 REP. ROBERTS: Can someone tell me what ODOT's freight rail planning activity entails?

MARK FORD, OREGON DEPARTMENT OF TRANSPORTATION, (ODOT): There is a federal rail planning program that deals primarily with light density branch lines that are in danger of being abandoned.

The overall rail plan can include issues regarding the types of freight you are handling and how to facilitate it better, but the primary focus is actually on the light density branch.

025 MOTION: SEN. McCOY MOVES THE (-C6) AMENDMENTS DATED 6/28/91 TO SB 763.

045 SEN. COHEN: It is my intent to make sure that ODOT understands our intent is to make sure that this is laid out in such a way that rail connects with bus routes.
