098 CEASE: Are there serious problems that would require the kind of authority this bill would allow?

102 WICKS: We had some reason to believe that there were people who were not properly certified doing inspections.

123 TOM HIGASHI, COUNSEL FOR BUILDING CODES AGENCY: We need the authority to

verify whether or not someone has the proper certification to do inspections.

129 CEASE: You are not getting the report from the local government, you're getting it from someone else?

133 HIGASHI: Yes. In one incidence we were denied the information, and had to look at the possibilities of using the Freedom of Information Act to obtain the information we needed.

139 WICKS: Most of the people we deal with on the local level are very cooperative, however there are difficult ones that need additional authority to be able to review what's going on.

- 165 SPRINGER: Is it true that there is a lot of junk out there that needs to be looked at more seriously, but politically it's hard to do?
- 177 WICKS: One of the problems is some buildings were built previous to the kind of codes that are in place now.
- 187 SPRINGER: Is there any way to get at those buildings that are not only displeasing to look at, but are also health hazards as well?
- 192 WICKS: The Building Codes Agency does not have the authority to adopt a dangerous building code. At the present time local governments do have the authority to do something with those buildings, if they've adopted rules under the General Nuisance Abatement Authority, that local governments have. We do not have that authority so we cannot address the kinds of problems that you mentioned.
- 222 JANE CUMMINS, LEAGUE OF OREGON CITIES: SB 132 as amended does satisfy our concerns.
- 267 DON WOODLEY, OREGON BUILDING OFFICIALS ASSOCIATION: We support SB 132 as amended.
- $279 \ \text{SPRINGER}$: Tell me how you would respond to my question about these buildings that are such a mess?
- 292 WOODLEY: The areas that you are talking about are the same ones that this task force has concerns about. This is relevant to a housing code. Housing codes are very expensive to maintain. You have to hire a lot of people to inspect them, and to have someone upgrade an existing structure is expensive.
- 320 SPRINGER: So the first step would be for the county to adopt a housing code to give you the enforcement authority to perform a nuisance like function?
- 326 WOODLEY: That's correct.
- 327 SPRINGER: Do your commissioners show much interest in taking this step?
- 336 WOODLEY: There is a great deal of interest to clean up the mess, and there is a task force working on it.
