018 GEORGE RANKINS, RACING COMMISSION: I am from Portland Oregon. I've been on the Racing Commission for approximately four years. I've lived in the state for over 22 years after my retirement from 23 years in military service. I've worked and attended Oregon State University for 2 1/2 years. I'm originally from GreenSB urg, North Carolina and Newark, New Jersey. I went into the service from there, and have traveled all over the country since.

025 OTTO: Do you attend the races at the dog track?

026 RANKINS: Absolutely. I try to make both the greyhound track and the commercial track whenever possible. I think I've made it to all of the tracks except for one.

I have roots from Kentucky, and have a life long interest in the racing industry. I am very gratified with this nomination. 124 MOTION: SEN. GRENSKY MOVED SB 530 TO WAY AND MEANS.

128 CEASE: I'd like to note that it does have a reduction to the County Fairs Fund and the General Fund.

134 SMITH: My understanding of the reduction of the fiscal is, it is from the seven percent that would be in effect, if action of the previous legislation was not in effect, not from what exists today.

140 HOUSER: The only difference between the bill and what exists today is, at the present time there is a contribution of .43 of 1% to the County Fair Fund that would be eliminated under the bill. The effect on the General Fund comes from the fact that the Sunset provision would take effect if the bill isn't passed.

147 SMITH: Didn't we receive testimony from the County Fair folks that they did not oppose this bill.

149 HOUSER: That's correct. They did not oppose the bill.

160 HOUSER: Distributed the -3 amendments to the bill, Exhibit A. Reviewed the bill and the amendments for the committee.

190 MOTION: SEN. SMITH MOVED TO ADOPT THE -3 AMENDMENTS TO SE 531 . HEARING NO OBJECTIONS, SO ORDERED.

198 MOTION: SEN. SMITH MOVED SB 531 AS AMENDED TO THE FLOOR WITH A DO PASS RECOMMENDATION.

200 CEASE: It says on the staff report that it has a subsequent referral to Ways and Means.

213 SPRINGER: Is there anything we want to put on the record in terms of how we expect the Racing Commission to exercise that discretion. In other words, are we going to open this up to every race, or only for the significant races.

227 GEORGE DEWEY, REPRESENTATIVE OF THE MULTNOMAH KENNEL CLUB: Originally in our testimony, we talked about this new change going on in the industry, which allows a host track to satellite their signal to another state. The amount that is bet in that state would be entered in the host track pool. You have an amendment from Portland Meadows, that we do not object to, which would allow that same thing to be done from Bay Meadows, for example, to Portland Meadows. This has come about because of new technology. What it does for the wagering person is, increase the pool so that they feel more comfortable about the odds not changing. We think it's an excellent idea and a real opportunity for the State of Oregon.

275 CEASE: What kind of activities might have to be done that would have to be funded, in order to implement the bill? Would there be a need to allow expenditures for the Racing Commission?

284 DEWY: At the moment I can't see anything. We are already doing it for the race books in Nevada. We pay for all the satellites, about \$1,800.00 for each performance.

292 HOUSER: The bill does have a referral to Ways and Means, however we received a no fiscal impact notice from the fiscal office on the bill.

305 MOTION: SEN. SMITH MOVED SB 531 TO THE FLOOR AS AMENDED WITH A DO PASS RECOMMENDATION, AND THE SUBSEQUENT REFERRAL TO WAYS AND MEANS BE RESCINDED.

 $354\ \text{HOUSER}$: Distributed and reviewed the -2 amendments, Exhibit B, for the committee.

372 ROB DOUGLAS, OREGON THOROUGHB RED BREEDERS ASSOCIATION: I want to commend the actions of the Multnomah Kennel Club, (M.K.C.). When the situation arose and there was some uncertainty, M.K.C. was very responsive and ceased their activities in the southern part of the state when it was felt by some, that they may conflict with live racing. However, the problem still exists. As you know, when we pushed for the passage of off- track betting it failed, and subsequently succeeded. There were lots of discussions about the safe-guards of off-track betting would not damage those race meets. We feel that SB 533 is a step backward, in that regard and we the Oregon ThorougHB red Breeders Association would like to go on record opposed to the bill.

 $395~\mathrm{SMITH}$: The testimony that we heard before was that this would not damage the races that were occurring in these locations, and in fact would draw more people to them.

405 DOUGLAS: I understand that theory, however the people who put on those race meets, specifically in southern Oregon, would disagree.

416 SMITH: So they think that if you have off-track betting three or four hours before a live horse race, people will come and spend their money in off-track betting, and then not come back for the live race.

422 DOUGLAS: First of all the facility would not be the same for the two. There's only so many discretionary dollars for this type of activity, and their preference is that those dollars would be spent in the live race meet.

438 MOTION: SEN. GRENSKY MOVED THE -2 AMENDMENTS TO SE 533. HEARING NO OBJECTIONS, SO ORDERED.

448 MOTION: SEN. GRENSKY MOVED SB 533 TO THE FLOOR WITH A DO PASS RECOMMENDATION.

455 VOTE: MOTION CARRIED, 4-1. VOTING NO, SEN. SMITH. (EXCUSED, SEN. BUNN AND SEN. KITZHABER).
