HB 2854 RELATING TO FOREST FIRE SUPPRESSION

012 DENIS DOWD, DEPARTMENT OF CORRECTIONS, ASSISTANT DIRECTOR: Reviews testimony, Exhibit B.

024 SMITH: What did the House amendments do?

026 DOWD: The first three sections cleaned up errors. The amendments added \$4 in response to concerns of Representatives on the eastern side of the state. They were concerned about inmates from other states being substituted for available labor.

034 HOUSER: Distributes staff measure summary, Exhibit A.

035 OTTO: What kind of training do the fire fighters from the institutions receive?

037 DOWD: They are trained by the Forestry Department, like any other fire fighting crew.

039 OTTO: Is it a one day training?

040 DOWD: It is a week long training program, I believe.

042 OTTO: It is strictly voluntary?

043 DOWD: It is voluntary, however if the inmates are assigned to the forest camp they anticipate being a member of the fire crew. They are minimum security inmates.

045 OTTO: They receive \$3/day in compensation?

046 DOWD: Yes, for a 24 hour day.

048 CEASE: It is my view that departments should do legislative packages in conjunction with the Executive. Those should have the Governor's approval. When I see bills introduced by individual legislators, at the request of departments, I wonder if it is an end run around a Governor's policy decision. Why was this bill introduced in this manner, instead of through the normal process?

060 DOWD: This bill, in draft form, was introduced after the Executive Departments deadline for the submission of bills for review, by individual departments. This is an exception, and it was because we had trouble working out a draft that was acceptable to all involved states.

 ${\tt 069}$  CEASE: What kind of security measures are necessary when using a trained inmate fire fighter?

073 DOWD: We provide the same security for these inmates as is provided

for any minimum security inmate work crew. Correction officers are assigned to the fire crew and they stay with the fire crew. In addition they are directly supervised by Forestry Department staff.

- 079 CEASE: What is the incidence of inmate escape from this?
- 081 DOWD: There has been none in the last 13 months from the fire line.
- 083 CEASE: There have not been many fire lines in 13 months have there?
- 085 DOWD: I think we spent 37 days last summer on the fire lines. One of those was 17 days in a row at the Bear Creek fire.
