012 CHAIR SHOEMAKER: Starts hearing on SB 833-5. Submits (EXHIBIT A), SB 833 -41 would like to delete the proposed new section 5 and substitute nothing for it. Thus this bill will have no liability limitation provisions whatever. 055 MOTION: Shoemaker moves to amend the dash 5 amendments as indicated. 065 VOTE: Committee so amends it. 069 MOTION: Cohen moves the dash 5 as amended to the floor with a do pass recommendation and with a recommendation that a letter follow to rescind the referral to the Judiciary Committee. VOTE: 4-1 AYES: Cohen, Hamby, Roberts, Shoemaker NAYS: Hannon 080 CHAIR SHOEMAKER: Starts the work session on SB 494-4.

090 BARBARA COOMBS: Reviews changes between the dash 3 and the dash 4 versions of the bill.

058 COOMBS: The Long-Term Care Association has submitted an amendment on the issue of a provider who does not wish to administer the provisions of this bill. This amendment says that when a patient must be transferred to another provider's care then the transfer rules of Senior and Disabled Services do not apply. 060 CHAIR SHOEMAKER: We'll get back to this amendment when we hear what the SDSD rules of transfer are. 171 MOTION: Roberts moves to amend the dash 4 amendments to include new language on comity and the new definition of health care representative. 172 VOTE: Committee so amends the dash 4 amendments.

179 MOTION: Roberts moves SB 494-4 as amended to the floor with a do pass recommendation. 183 VOTE: 4-0 AYES: Cohen, Hamby, Roberts, Shoemaker NAYS: 200 CHAIR SHOEMAKER: Adjourns hearing at 4:00.
