209 CHIEF TOM POTTER, PORTLAND POLICE BUREAU: Submits and summarizes written testimony (Exhibit D).

279 MAJOR DEAN RENFROW, OREGON STATE POLICE: Submits and summarizes written

381 DONALD TRUNKEY, M.D., DEPT. 004 SEN. BUNN: What about the Second Amendment?

007 TRUNKEY: I don't know what constitutes a standing militia. These guns don't belong to an ordinary citizen.

012 SEN. BUNN: Explains concept of standing militia, as composed of able-bodied citizens.

016 TRUNKEY: No individual has a right to own these weapons.

021 SEN. BUNN: How many times a year does Portland have crimes involving a registered fully automatic weapon?

024 POTTER: I will get that information for you.

025 SEN. BUNN: Twenty in the last five years?

027 POTTER: At the high end.

031 SEN. BUNN: You commented about retired Oregon police officers. What about retired officers from other states?

035 RENFROW: There may be an exception there. The basis for my comment was that retired Oregon officers are familiar with Oregon law.

039 SEN. HILL: Do you feel that this bill will really keep criminals from getting guns?

048 POTTER: We can't completely stop that, but we want to cut down the

potential. It is not a perfect bill, but it will restrict enough to help.

066 RENFROW: A number of weapons are obtained through legitimate sources. If legitimately sold weapons are only 1% of firearms used in a crime, that's still a big number; 80,000 firearms were sold during 1990.

085 SEN. HILL: I understand the handgun problem, but I want to know why shotguns and rifles are included in this. How many crimes each year involve shotguns and rifles?

090 POTTER: I don't have the exact numbers. The problem with long guns is that they get sawed off.

097 SEN. HILL: I don't know what you can accomplish with this. I don't see how it will keep guns away from criminals.

124 AVEL GORDLEY, HOUSE OF UMOJA: Submits and summarizes written testimony (Exhibit F).

156 MEGAN PORT CLARK, EMERGENCY NURSES ASSOCIATION: Submits and summarizes written testimony (Exhibit G).

321 SEN. BUNN: Would you support a bill to ban automatic and semi-automatic weapons?

324 THORNTON: I would limit it to assault weapons.

326 SEN. BUNN: Defines assault weapon. -Doesn't this encompass almost every semi-automatic weapon in use?

333 THORNTON: I am not prepared to answer.

347 SEN. BUNN: You cite many statistics showing that the majority of Americans want strict gun control. Aren't our laws based on protecting the minority from the wishes of the majority?

351 THORNTON: I wouldn't use that characterization. This is connected with public safety.

358 SEN. HILL: We live in a violent society. Do you think it worthwhile to put more resources into this, as we have been doing with drugs? Perhaps resources are better spent in getting to the roots of societal violence.

384 THORNTON: While it is true about societal violence, we still need to control assault weapons.

327 SEN. HILL: What about violent crimes not involving weapons? Isn't the issue one of violence, not guns?

344 WILSON: It is incrementally possible to change public attitudes. On this issue, that starts when the Legislature stigmatizes dangerous instruments like firearms, and puts constraints on frivolous and improper use.

365 SEN. BROCKMAN: Don't forget that a gun is an inanimate object.

372 SEN. BUNN: What about semi-automatics from World War I or II?

377 LEONARD: Guns manufactured before 1947 are exempt.

382 SEN. BUNN: Are they less dangerous?

384 LEONARD: They have fewer of the features that modern guns have.

002 CHAIR COHEN: Calls hearing to order at 7:17 p.m.

SB 546, REQUIRES GROUP HEALTH INSURANCE POLICIES TO CONTAIN PROVISIONS REGARDING NOTICES OF POLICY TERMINATION, PUBLIC HEARING

010 SEN. PEG JOLIN: Reviews history and intended purpose of bill. -Submits two letters (Exhibits A & B).

057 REPRESENTATIVE SAM DOMINY: Reviews intended purpose and history of bill.

109 CRAIG URBANI, INSURANCE DIVISION: Submits -A3 amendments (Exhibit C).



118 CHAIR COHEN: How do you envision this working? Will the insurance company need to keep track of everyone?

123 URBANI: The insurer will have to rely on the employer to keep up-to-date records.

134 CHAIR COHEN: What circumstances of non-payment would trigger this action?

136 URBANI: The premium would have to be over 30 days late, and the insurer could not have been replaced by another carrier.

151 AL THOMPSON, BLUE CROSS/BLUE SHIELD INSURANCE: Testifies in opposition to SB 546. -Often, insuree information is not easily available to the insurer.

204 CHAIR COHEN: We are dealing only with the civil penalties segment of the bill.

228 SWENSON: Line 18 of sub-section 3, Section 1, states that the employee has a right of action against employer. -Sections 3-5 are mandates to the insurer. How could an employer violate those?

239 URBANI: We drafted amendments which would hold the insurer responsible. -The language to which you refer puts the employer and insurer together as a partnership, to ensure that notification occurs.

278 REP. DOMINY: The Bureau of Labor & Industries wanted to know how they could help to enforce it.

289 SEN. SHOEMAKER: The original bill had right of action against employer in sub-section 1. -When we added Sections 3-5, I don't recall moving the right of action.

314 SEN. JOLIN: We focused on the insurance side of the issue. Sub-section 1 is relatively standard.

327 SEN. SHOEMAKER: Perhaps we should re-amend line 18.

338 SEN. JOLIN: We had looked at two bills: one related to the employer only, and this bill. -Any amendments would concern the employer.

398 SEN. JOAN DUKES: Reviews history and intended purpose of bill.

043 JOHN BERGQUIST, LAMBDA CHI ALPHA FRATERNITY, OREGON STATE UNIVERSITY: Submits and reviews written testimony (Exhibits D, E, F, & G).

076 SEN. SHOEMAKER: Language in section 2 refers to "any person, parent, or legal guardian." Can they sue for damages to person? Is this a parent suing on a student's behalf, or for their own emotional distress? That should be more clear. -The bill also states that an action may be brought either against an organization, or against any

individual member. The plaintiff has the burden to show an individual's responsibility. How can this work?

091 BERGQUIST: It refers to the organization as a whole, or to members individually responsible.

097 SEN. DUKES: The person who committed the crime would be responsible. A nonparticipant would not be responsible.

100 CHAIR COHEN: That needs to be clarified.

101 SEN. SHOEMAKER: "Responsible" is also not clear. Is anyone who participates, even if they are not the decisionmaker, then liable?

109 SEN. DUKES: Everyone who participated is liable, to the extent that they participated.

116 TAYLOR: The "relating to" clause needs to be amended, since this bill is both civil and criminal.

120 CHAIR COHEN: It should be "relating to hazing." This is the advice of Legislative Counsel.

155 TAYLOR: Does section 2 in any way narrow the current rights of parents or legal guardians?

160 SEN. DUKES: It was not our intent to narrow it.

166 JAMES NELSON, LAMBDA CHI ALPHA FRATERNITY: Testifies in support of bill.

194 CHAIR COHEN: Do you think this needs to be a Class A misdemeanor?

197 NELSON: If there is a potential criminal sanction and violation, that is sufficient.

057 SEN. SHOEMAKER: Are there cases where non-economic damages, of over half a million dollars, are not punitive damages in effect?

065 SEN. HILL: I don't know. If a jury wanted that recourse, it would be available to them.

090 SEN. SHOEMAKER: I have a problem with changing the results of tort reform.

105 SEN. HILL: So do I, but this is a narrowly defined area. -Moves to adopt the -3 amendments to SB 1013.

164 HEARING NO OBJECTIONS, CHAIR COHEN SO ORDERS. SEN. BUNN WAS EXCUSED.

165 SEN. HILL: Moves SB 1013, as amended, to the floor with a "do pass" recommendation.

171 MOTION PASSES, WITH SENATORS HAMBY, SPRINGER, HILL, AND COHEN VOTING AYE, SENATORS BROCKMAN AND SHOEMAKER VOTING NAY AND SENATOR BUNN EXCUSED.
