002 CHAIR COHEN: Calls hearing to order at 5:58 p.m.

005 REP. TED CALOURI: Reviews intended purpose of bill. Submits and reviews written testimony (Exhibit A). -The bill addresses drivers with suspended licenses who continue to drive.

072 CHAIR COHEN: Is the fine assessed on the person who is driving, or on the owner of the car?

075 REP. CALOURI: On the person who is driving. -Continues to review bill.

136 JUDGE BILL KEYS, MULTNOMAH COUNTY DISTRICT COURT: Reviews history of bill. -We need the bill because criminal sanctions don't work. Taking people's cars will make a bigger impact, and force people to change their behavior.

275 CHAIR COHEN: What kind of penalty is imposed on someone who is driving a neighb or's car with a suspended license? You can't take the car, because it doesn't belong to the driver.

285 KEYS: The bill gives the neighb or a cause of action against the driver.

316 SEN. BUNN: Once we make this an infraction, the officer cannot take the driver into custody. How do you intend to seize the vehicle?

322 KEYS: There are six factors which the officer must consider. They are outlined in the bill. -Submits testimony and proposed amendments
