28: We worked on this bill for about one and one-half weeks taking out
anything which we thought would allow latitude.

> If we were to try to satisfy the Executive Department with everything
we did in the legislative branch, it would be a violation of the
separation of powers. > This gives the smaller commodity committees the
ability to deal as they have for the past 30 years.
