008 CHAIR OTTO: Called the combined meeting of Senate Government Operations and Senate Redistricting to order at 4:41 p.m.

003 OTTO: Calls on Senator Bradbury to make a motion to "Out of Sight, Out of Mind" (OOSOOM) the remainder of the bills in the Senate Redistricting Committee.

004 MOTION: SEN. BRADBURY MOVED TO TABLE EN BLOC THE LISTING OF BILLS AS SHOWN IN EXHIBIT A, WITH THE EXCEPTION OF HB 2001.

016 OTTO: Is there comment on the list?

017 MOTION: SEN. DUFF MOVED TO AMEND THE MOTION BY DELETING HJR 41 FROM THE LISTING.

024 BRADBURY: As maker of the motion, I am comfortable in having it OOSOOMed.

027 VOTE: MOTION CARRIED: 5-2. (VOTING NO: SEN. BRADBURY, SEN. SPRINGER).

035 BRADBURY: Clarification. I may have misread one bill number in making the motion. I should have read HB 2769, not HB 2569.

040 VOTE: MOTION CARRIED: 5-2. (VOTING NO: SEN. BRENNEMAN, SEN. BUNN).

045 MOTION: SEN. DUFF MOVED HJR 41 TO THE FLOOR.

047 UNIDENTIFIED: You can't, it's not on the list.

047 BUNN: It is listed for a work session.

048 OTTO: We have to have a work session on it first.

049 BUNN: We are scheduled for a work session, and we were in a work session when the motion was made on it.

051 OTTO: To move it to the floor?

052 UNKNOWN: (Unintelligible).

052 JOHN KITZHABER, OREGON STATE SENATOR, DISTRICT 23: I can't speak, I'm not on that Committee.

053 OTTO: What was that proposal Senator?

054 KITZHABER: I don't believe you opened a work session on HJR 41.

055 OTTO: No, I haven't.

056 BUNN: The fact that you took a motion to exempt it from the earlier motion means it was part of your work session, otherwise you could not have accepted the earlier motion.

059 JANE CEASE, OREGON STATE SENATOR, DISTRICT 10: Wasn't the earlier motion, and also the notice in the agenda for the purpose of tabling the bills? Wasn't the motion strictly for the purpose of taking HJR 41 from the list rather than tabling it? Wasn't that the only intent?

064 BUNN: The fact that any action can be taken on a bill means that it is in a work session, and if one action can be taken then any action available to the body can be taken at the same time.

067 OTTO: What does our parliamentarian say?

068 RYDER: Do you need a parliamentary ruling from the Secretary of the Senate?

070 OTTO: No.

071 RYDER: Reads statement in the agenda, Exhibit A, "It is the intention of the Chair to accept one motion to table all bills on this list with a single motion." That is the intent of the meeting.

073 BUNN: There are often meetings that occur contrary to the intent of the Chair. According to my understanding of the Senate Rules, when we are in a work session, action can happen on a bill, other than that necessarily intended.

Committee recessed at 4:46 to take the motion under consideration.
