031 GIL RIDDELL suggested the request for amendments to SB 441. AOC feels the cuts made necessary by Measure 5 should be equitable and if County levy collections are reduced by Measure 5 then the statutory required contribution for the County School Fund be reduced by the same proportion.

058 GIL RIDDELL presented a list of counties and funds regarding the County Schools. EXHIBIT 1  $\,$ 

070 SEN. DUKES questioned the obligation of the County General Fund to make up lost revenue due to Measure 5 in counties having a tax levy.

EXHIBIT 2 155 The Handicapped Child Fund is explained to be state money which reimburse school districts for their cost of Special Education. Discussion and questions follow regarding the Handicapped Child Fund and the relationship to the County School Fund. 200 SEN DUKES questioned the transferring of County School Fund money from the county to the schools and going through the Education Service District (ESD) with most of it going to general education. 205 KAREN BRAZEAU mentioned there is another distribution of these funds to schools. 212 DAVE BOYER explained how the money is transferred from the General Fund to the County School Fund in the county's budget. The money is then transferred to the ESD. 222 Discussion follows regarding statutory funding of Special Education programs. 237 FRANK MCNAMARA explained how money not spent through the billing process for state programs is distributed to each local school district. 365 SEN. DUKES would like to know how much money coming into the County School Fund is actually going toward Special Education.
