- 021 JOAN PLANK introduced Joanne Peterson.
- 024 JOANNE PETERSON read prepared testimony. EXHIBIT 1
- ${\tt O44}~{\tt SEN.}$ DUKES questioned a bill in the House that would eliminate the requirement for continuous registration of trailers.
- 047 JOAN PLANK responded the House Transportation Committee heard the bill because at the time HB 2550A was an uncertainty. Discussion follows.
- 058 JOANNE PETERSON explained Measure 5 would limit the amount of fees that could be collected on campers and trailers. If the continuous registration is not repealed then statutes will need to be changed to make provisions consistent with Measure 5.

- 078 BOB RUSSELL discussed the PUC registration system. The proposed amendments from the Department of Justice (DOJ) will affect some PUC

statutes. Suggestions were reviewed clarifying proportionately registered vehicles are not subject to Measure 5.

- ${\tt 096}~{\tt GARY}$ VANHORN testified for Janet Neuman and discussed prepared testimony. EXHIBIT 2
- 109 SEN. DUKES questioned the loss of funds to the Common School Fund because of changing oil and gas severance tax to a privilege tax.
- 112 GARY VANHORN responded if the language is not included to change the severance tax to a privilege tax there will be an elimination of the money that currently goes to the Common School Fund. Discussion and questions are interspersed.
- 121 CHAIR CEASE conducted administrative business.
- 127 GIL RIDDELL discussed a set of amendments overlooked by the Department of Forestry in review of statutes related to Measure 5. Reference is made to ORS. Chapter 476 in which a County Governing body can zone lands for fire protection. The amendments would provide that the land owner in Zone 1 lands would have the opportunity to provide their own fire protection.

- 288 ELIZABETH STOCKDALE commented on Section 438f-g which incorporate the text of HB 2847 removing the continuous registration of campers and travel trailers from the vehicle registration law.

- 377 JOANNE PETERSON explained ORS 803.470 is the statute that prohibits the Division from transferring title or registering vehicles if back fees have not been paid.
- 386 CHAIR CEASE commented to Elizabeth Stockdale that the committee should see the drafted amendments dealing with the oil and gas severance tax.
- 402 CONSENSUS CHAIR CEASE asked if there were any objections to adopting proposed amendments to HB 2550A from the Department of Justice dated 4/26/91. EXHIBIT 3
- 410 ORDER There being no objection, CHAIR CEASE so ordered.
