The bill holds the fuel tax constant and alters the truck tax system to bring that back in line with the overall shares of cost responsibility and makes some administrative changes. Ouestions and discussion 118 JOHN MERRISS presented a historical overview of financing Oregon's Highways by cost responsibility with reference to EXHIBIT 2. 153 JOHN MERRISS explained the three types of road use taxes. EXHIBIT 2, Page 3 178 JOHN MERRISS discussed the tax structure with reference to HB 2737 and the taxes paid by various truck weight groups. EXHIBIT 2, Page 4 248 JOHN MERRISS explained the three major components of a cost responsibility study as listed on Page 5, EXHIBIT 2. 273 JOHN MERRISS explained the 1990 cost responsibility study as depicted in EXHIBIT 2, Pages 6-14. The projections for the study are based on the 1992-93 year and therefore the effective date should be January 1992. Discussion followed. TAPE 216 SIDE В 023 JOHN MERRISS, in response to questions, explained how the cost figures are projected. 038 BOB BOTHMAN-clarified inflation is built into the budget of the Department of Transportation which is used in projecting the future costs. HB 3577A - PUBLIC HEARING 090 REP. BURTON stressed the importance of road maintenance and urged the passage of HB 3577A (House version). 135 MIKE HOLLERN termed HB 3577A as a minimal approach to satisfy the needs of the transportation infrastructure system. HOLLERN discussed the history

of a comprehensive roads finance study and directed members attention to two publications and a collection of news articles addressing studies of Oregon's roads and bridges in relation to maintenance and cost responsibility. Exhibits 5, 6, 7 Questions and discussion interspersed 188 CHARLES VARS discussed what he saw as the consequences of not passing HB 3577A and HB 2223A. 245 ED LINDQUIST testified in support of HB 3577A with emphasis on the importance of the state's infrastructure. Discussion and questions are interspersed. 344 SEN. DUKES noted the bill also contains a vehicle registration fee dedicated to police instead of revenues that might have gone into the road fund and questioned support for that. HOWLAND read prepared testimony in support of HB 3577A. EXHIBIT 9 203 SEN. SMITH questioned the number of 102 police officers that would be added with the passage of HB 3577A. 220 L.R. HOWLAND responded with a discussion of the number of officers currently involved with traffic safety, how the number of an additional 102 police officers was decided, and how those officers would improve traffic safetv. Questions and discussion 321 UNIDENTIFIED SPEAKER (accompanied Howland) clarified the additional officers would be added to the traffic patrol. A restructure of the organization and manpower organization was being conducted at that time. A report of planned activities had been presented to the Traffic Safety Commission including what programs the additional officers would be assigned. Discussion 394 ROGER MONTGOMERY testified in opposition to HB 3577A stating he was opposed to taxes until Measure 5 is taken care of.

Exhibit 10 110 TERRY DRAKE clarified there was a potential technical problem in HB 357 7 when repealing the old tax rates passed in 1989; HB 2223 contained the repealer language, and if HB 3577 was to work properly, HB 2223 needed to pass after HB 3577. 114 CONSENSUS CHAIR CEASE noted no committee objection to HB 2223-A8. 124 MOTION SENATOR GOLD moved HB 2223A as amended to the senate floor with a do pass recommendation.
