038 GRETTAN KERANS, SENATE DISTRICT 20: Testifies in support of SB 1218 and explains

SB 1218-2 amendments (EXHIBIT A).

>SB 1218 as printed says that a person who has been the State Treasurer or a member of the

Investment Council cannot within one year after they leave public office hold a position in which

they are engaged in doing business with persons who they dealt with in their official capacity.

>The -2 amendments make other public officials in the Office of State Treasurer and the

Investment Council also subject to the Oregon Government Ethics Commission economic interest

statement. The persons listed in the -2 amendments are not presently subject to the economic

interest statement filing.

060 CHAIR ROBERTS: What is the reason for including these public officials?

SEN. KERANS: Feels it would be prudent to provide these people with the shield of disclosure

by virtue of the fact that without such a disclosure there is no way other than through an

investigation to question whether they have any relationship with anyone who does business with

the Treasurer's Office.

>This economic interest disclosure is to provide them a shield to any charge of self interest.

085 JOSE MATTA, COMMITTEE ADMINISTRATOR: Sections 3, 4, and 5 of the -2 amendments were added by Legislative Counsel. They are technical and clean up the language.

096 > Discussion followed regarding whether other public officials, such as in SAIF and Department

of Transportation should be included. If state official deals in large sums of money, should he be included?

108 SEN. KERANS: Line personnel are not the people the Government Ethics

Commission

economic interest statement is directed at. Audits locate malfeasance in office in these line officials.

>The officials listed in the bill and amendments have funds available to them and have the ability to engage in transactions in their own self interest.

>For whatever oversight in the past, as a matter of prudence they should be included now.

Someone who has control over funds of these natures has a higher opportunity of misuse than

does the Legislative Fiscal Officer or Legislative Counsel. Yet this filing is required of them

and not of these financial officers of the Treasurer's Office.

220 CHAIR ROBERTS: Questions meaning of the words "over which the former public official had

authority." Great deal of difference in degrees of authority and what they have jurisdiction over among those officials listed.

>Discussion over what areas are affected. The official has dealings with many people, but not authority over in many cases.

259 SEN. COHEN: The -1 amendments (EXHIBIT B) add legislators. How can legislator go back

and practice his profession when he has authority to make laws and regulate his profession?

308 MIKE O. RYAN, EXECUTIVE ASSISTANT, TREASURER'S OFFICE: Testifies in opposition to SB 1218.

>There are currently laws at federal and state level that will take care of the situation if an

employee of the State of Oregon is operating inappropriately in relationship to investments.

<code>>Discussion</code> continues regarding whether the Treasurer's Office staff and Investment Council

are in the same category as other public officials.
