063 SENATOR KENNEMER: What is the shelf life of a condom with spermicide?

064 STEVEN SCHULTE: Three years from date of manufacture.

070 CHAIR JOLIN: Recesses for the purpose of gathering a quorum.

074 CHAIR JOLIN: Opens a work session on SB 160.

084 MOTION: Senator Kennemer moves to adopt SB 160.

VOTE: In a roll call vote, the motion passed, with Chair Jolin, Senator Kennemer, and Senator Shoemaker voting AYE. Senator Bunn and Vice-Chair Otto excused.

090 CHAIR JOLIN: Directs Senator Bunn to carry the bill, later Senator Bunn declines. Senator Kennemer will carry the bill.
