008 CHAIR DUKES: Calls hearing to order at 8:10 a.m.

011 ALAN WILLIS, PORT OF PORTLAND: Explains LC 3121 which would allocate lottery

money for dredging. (EXHIBIT A)

WORK SESSION LC 2131

073 MOTION: Senator McCoy moves that the committee adopt LC 2131 as a Committee bill.

VOTE: HEARING NO OBJECTION THE MOTION IS ADOPTED.

PUBLIC HEARING SB 272

- 084 STEVE JOHNSTON, HIGHWAY DIVISION: Supports SB 272 which would allow the weighmaster to cite for mudflap violators.
- -Explains the number of citations issued for mudflap violations in 1989.
- 120 CHAIR DUKES: Discusses mudflap legislation in regard to citations.
- 130 SEN. BROCKMAN: Asks about fee for class B traffic infractions.
- 132 CHAIR DUKES: The maximum fee for that is \$250.00
- 135 MARA ROCHE, AUTOMOBILE CLUB OF OREGON: Submits and reviews written testimony. (EXHIBIT B)
- 158 MIKE MEREDITH, OREGON TRUCKING ASSOCIATIONS: Supports SB 272.
- 173 SEN. MCCOY: Did your research prove conclusively that mudflaps work or not?
- 180 MEREDITH: Explains the comparison between splash and spray devices and the rubber mudflap.
- 188 CHAIR DUKES: The mudflaps do help with the rocks and mud.

- Division regarding mandatory and discretionary requirements. (EXHIBIT E)
- 260 SEN. BROCKMAN: The dash 3 amendments seem more stringent than what we are trying to do here?
- 270 JOAN PLANK, MOTOR VEHICLE DIVISION: Submits and reviews written testimony.(EXHIBIT E)  $\,$
- 295 MIKE UNGER, MOTOR VEHICLE DIVISION: Clarifies written testimony. (EXHIBIT E)
- 323 SEN. BROCKMAN: Asks about section 9 within testimony regarding speeding tickets.
- 331 UNGER: Explains serious traffic violations.
- 338 SEN. TIMMS: Mudflaps are mandatory.
- 349 JANE AIKEN, GOVERNOR'S ADVISORY COMMISSION ON DUI: Testifies in support of SB 72-2 amendments. (EXHIBIT D)
- 371 SEN. PHILLIPS: Do you support life time suspensions?
- 375 AIKEN: Yes, on commercial drivers licenses.
- $385\ \mbox{JOHN}$  SULLAK, OREGON TRUCKING ASSOCIATIONS: Supports SB 72 and amendments.

- -We are trying to offer some assistance in training so we don't lose people.
- -Discusses concern over truckers who can't take a written test.

- 018 SEN. BROCKMAN: Do you support the dash 2 amendments to SB 72?
- 021 SULLAK: Yes.
- 023 SEN. TIMMS: Is there a problem getting young people into the

profession?

027 SULLAK: Generally if someone is new they must prove their skills. -Discusses skills truck drivers must possess.

 $040\,$  SEN. TIMMS: If someone already has a DUI before they become a commercial driver how does that affect this?

045 SEN. SMITH: The statute says you must be driving as a commercial driver.

051 TOM MALLOY, TEAMSTERS: Reviews Mr. Aranda's experience in truck driving.

089 JOHN ARANDA, TEAMSTERS: Explains the American Road Team.

- -The trucking industry is the most vital part of our nation.
- -Discusses public image of truck drivers.
- -Explains the amount of freight hauled in the nation last year.
- -Discusses fatalities in regard to the increased speed limit.

276 SEN. PHILLIPS: Discusses the issue of the lifetime ban versus a ten year

291 ARANDA: I am opposed to lifetime bans. I think there should be a rehabilitation program.

The way we do this has some real constitution questions that need to be answered.

327 JIM MARKEE, AMALGAMATED TRANSIT: Discusses the changes made by the Motor

Vehicle Division in regard to the Federal mandate. The dash 3 amendments that change the blood alcohol level is a great concern to me.

358 SEN. SMITH: Can you blow a .01 with mouthwash?

367 MARKEE: Explains alcohol content in mouthwashes.

383 SEN. TIMMS: We are talking about a one year suspension if you blow a .01.

385 CHAIR DUKES: It would be the same penalty that you have at .04 now.

387 SEN. SMITH: How long does alcohol stay in the blood stream?

393 MARKEE: I am not an expert on the dissipation of alcohol. I think that .01 is going a bit too far.

-Discusses the inaccuracy of intoxilizer machines.

TAPE 24, SIDE B

017 CHAIR DUKES: What is acceptable.

019 MARKEE: We are comfortable with the .04. We oppose the .01 very strongly.

034 CHAIR DUKES: Then is it okay to drink some alcohol as long as it is just a little; before you get in a car and drive?

035 MARKEE: I don't think it is okay to drink and drive. I believe you can be at a .01 without drinking.

037 SEN. TIMMS: This is a one year suspension with no hardship licensing.

 $040\ \textsc{MarKEE:}$  There is also a change in the suspension and a deletion of the rehabilitation program.

052 SEN. TIMMS: Do people know that we are changing things?

 $054\ \textsc{Markee}$  : We are trying to keep up with all of the changes. With respect to the  $10\ \textsc{years}$ 

versus lifetime we are taking no position on that.

064 SEN. TIMMS: What is the standard level of alcohol for a non-commercial

driver?

- 067 MARKEE: Discusses the Oregon law regarding intoxication.

to get help after two DUI's then maybe they shouldn't be a commercial driver.

- 084 MARKEE: To be convicted of an alcohol offense you must be a .08. -Discusses the conviction and suspension under the proposed amendments.
- 107 LT. KEN CHICHESTER, STATE POLICE: Explains the intoxilizer machine. -Explains absorption and dissipation rates and the factors that effect them
- 161 CHAIR DUKES: We hear very often that the intoxilizer machine is not accurate.
- 171 CHICHESTER: Discusses the blood alcohol test. The blood test is usually higher.
- 183 SEN. TIMMS: Does this have a referral to Judiciary? I am concerned about changing this to a .01.
- -Discusses implied consent in regard to increased court cases?
- 210 CHICHESTER: Explains the suspension process at Motor Vehicle Division. -Explains "implied consent" process within Motor Vehicle.
- 234 SEN. TIMMS: It is still a cost to government.
- 237 SEN. SMITH: Asks about "reasonable grounds" language in the implied consent law.
- 241 CHICHESTER: Explains what "reasonable grounds" means.
- $266\ \text{SEN.}$  SMITH: Before someone is required to take a breath test they must be under arrest.
- 278 SEN. DUFF: Can you visually tell between .04 and .01?
- 283 CHICHESTER: I doubt it. Maybe the odor of alcohol would be a factor.  $-\mathrm{Discusses}$  horizontal gaze.
- 322 CHAIR DUKES: How do you determine a .04 blood alcohol level?
- 325 CHICHESTER: It would vary depending on the persons tolerance. -Explains the difficulty in determining intoxication in regards to alcoholics.
- -Explains his role with the State Police.
- 386 MARY BOTKIN, AMERICAN FEDERATION OF STATE, COUNTY & MUNICIPAL EMPLOYEES: The question that arises from SB 72 is the deletion of any option to rehabilitate
- yourself. The reality is that if you remove people from the environment for ten years they  $% \left( 1\right) =\left( 1\right) +\left( 1\right)$
- probably won't go back to driving.
- -Discusses personal experience with alcoholism.
- -Disagrees with the lifetime ban.

- 035 SEN. DUFF: What if we required rehabilitation after the first offense.
- $042\ \mathtt{BOTKIN}$ : Discusses accuracy of testing procedures in regard to alcohol levels.

PUBLIC HEARING SB 245

- 070 VIRGINIA BARTON, MARITIME PILOTS: Submits and reviews written testimony.(EXHIBIT F)  $\,$
- 126 CHAIR DUKES: What other agencies have this type of rule making? It seems that we have been doing the opposite of what you're proposing.
- 129 BARTON: Discusses boards that currently operate this way.

138 SEN. MCCOY: Explain the problem with money in regard to prosecution within boards.

146 BARTON: That could be an issue; in the past five years we have not.

164 SEN. PHILLIPS: Why do you expect the Attorney General fees to increase?

176 BARTON: We are in the process of rule review right now which deals with our licensing  $\,$ 

requirements. It has created a greater than anticipated  ${\tt Attorney}$  General expense.

183 SEN. PHILLIPS: Discusses the language in the draft bill put in by Legislative Counsel.

-I do not like things that don't have specific limits on fees.

206 CHAIR DUKES: Because of the internal difficulty you are having I am not entirely convinced

that this might be adding fuel to the fire.

215 BARTON: Continues with testimony. (EXHIBIT F)

229 CHAIR DUKES: What was the budget that the Ways and Means subcommittee approved based  $\,$ 

on? If you went to the maximum of \$1,500.00 in the original bill would you still have to go to the Emergency Board?

231 BARTON: It was based on \$1,250.00 fee. We would still have to go back to the Emergency Board or the legislature for an increase.

242 CHAIR DUKES: So you are anticipating a \$1,200.00 fee. The original bill would cover your

immediate needs and allow for some increase if necessary.

256 JODY FISHER, CAPTAIN MARK NICHOLS, CAPTAIN GORDON HOWE, LEWIS & CLARK PILOTAGE: Submits and reviews written testimony. (EXHIBIT G)

293 SEN. DUFF: So the \$1,500.00 fee in the original SB 245 is okay?

295 NICHOLS: What ever is needed to keep things operating.

298 SEN. MCCOY: Discusses the increase in fees.

WORK SESSION SB 245

336 SEN. PHILLIPS: Suggests conceptual amendment to SB 245.

352 SEN. SMITH: If we left in the word "subject" on line 6 of SB 245, would that allow them to adjust the fees on their own?

360 CHAIR DUKES: Up to the \$1,500.00 dollar limit; with the approval of the appropriate legislative board.

 $387\ \text{SEN.}$  PHILLIPS: If they came back they would wind up in front of the Emergency Board.

388 BARTON: Our current budget is \$112,000.00 The proposed budget was voted out of the Ways

& Means subcommittee on Thursday. There were some technical adjustments, but it was basically

\$163,00.00 for administration for 1991-93. Projected revenue based on the license fee would

generate \$175,000.00 in revenue.

TAPE 26, SIDE A

020 MOTION: Senator Phillips moves to change SB 245, on line 9 and 10 after the word

"budget" put a period and delete the language "as it may be modified by the  ${\tt Emergency}$   ${\tt Board}$ ".

VOTE: HEARING NO OBJECTION THE MOTION IS ADOPTED.

024 MOTION: Senator Phillips moves SB 245, as conceptually amended, to Ways and Means

with a "DO PASS" recommendation.

VOTE: IN A ROLL CALL VOTE THE MOTION PASSES UNANIMOUSLY.

033 CHAIR DUKES: Adjourned the hearing at 10:05 a.m.
