010 CHAIR DUKES: Calls hearing to order at 8:15 a.m.

PUBLIC HEARING SB 615

013 SENATOR FRANK ROBERTS: Discusses intent of SB 615.
-Expresses concern over compliance with the current law.

-Submits SB 615-1 amendments. (EXHIBIT A)

096 JOSE MATA, STAFF, SENATOR ROBERTS: The purpose of SB 615 provides for towing

of cars parked in disabled parking spaces without a permit.

112 CHAIR DUKES: What parking structures does this bill address?

116 MATA: There are at least 26 parking spaces that this bill would address. The bill also addresses areas with a population of 10,000 or more or one which is within two miles of city limits.

135 SEN. PHILLIPS: Have you talked to people that own a lot of different facilities?

- 139 MATA: We met with a representative of the retail businesses. They are concerned about towing
- their customers and how that would affect their business.
- 150 JAYME ARMSTRONG, STAFF, SENATOR ROBERTS: Discusses which retailers were contacted and how those retailers currently operate with a towing contract.
- 159 SEN. PHILLIPS: Does this conflict with the City of Portland ordinance?
- 162 MATA: We didn't check.
- 164 SEN. PHILLIPS: We don't know if they have a problem with this.
- 167 MATA: My understanding is that they are currently using three tickets and then towing. -
- Discusses city center parking.
- -Continues reviewing intent of SB 615.
- 195 CHAIR DUKES: Reviews how SB 615 would affect a business owner with 100 parking spaces.
- -Would the tow truck driver need permission from the owner of a business? -Discusses the issue of liability in regard to towing.
- 220 MATA: The towing people are concerned about liability.
- 225 CHAIR DUKES: Did you talk to any independent business owners? -Discusses the City of Portland in regard to availability of towers. -Expresses concern about this bill and how it would work in rural areas.
- 243 MATA: There are already numerous contracts where the towing companies have contracts with independent companies.
- $255\ \mbox{CHAIR}$ DUKES: Smaller areas tend not to have contracts with towing companies.
- 263 MATA: Discusses the population intent of SB 615-1 amendments. (EXHIBIT A) $\,$
- 275 CHAIR DUKES: I have concerns about the amendments.
- $280\ \text{MATA:}$ The amendments were put in because of the concerns from the towing businesses.
- -The main purpose of the bill is to make towing mandatory.
- $340\,$ SEN. SMITH: Do you think the real intent is to stop people from parking in spaces initially?
- 368 MATA: The bill would add language to the sign concerning the towing company.
- 377 SEN. SMITH: Will the sign say you car will be towed?
- 383 MATA: Yes, it does say that in SB 615.
- 407 TINA DUGAN, STAFF, SENATOR FRANK ROBERTS: Discusses statistics in regard to citations issued. (EXHIBIT B)

- 020 CHAIR DUKES: Can police go onto private property to patrol?
- 023 MATA: I think that would be a 4th amendment issue. It might constitute a search.
- 027 CHAIR DUKES: If we stayed with the original bill then the police could only patrol those private lots where the owner had given permission.
- 030 MATA: Explains the limitations outlined in the SB 615-1 amendments. (EXHIBIT A) $\,$
- 033 SEN. SMITH: I think SB 615 and the amendments say that the owner of the facility will authorize by contract or otherwise.
- 039 SEN. TIMMS: I don't see a real problem with handicapped spaces being used by people without

a permit.

-Discusses personal experience with being towed.

079 MATA: This bill utilizes the existing mechaniSMwhich is in current law regarding towing responsibilities.

090 SEN. TIMMS: Are you requiring a towing company to patrol?

093 MATA: Explains the original bill versus the amendments.

104 SEN. MCCOY: When we first passed this bill every thing went well. -Discusses how individuals policed handicapped spaces in Portland.

137 SEN. PHILLIPS: How many private lots are we talking about?

140 MATA: We were unable to local any statistics on that. We have tried to limit this bill with the SB 615-1 amendments.

144 SEN. PHILLIPS: Discusses limitations of SB 615-1 amendments. Have you calculated the additional cost to these owners?

153 MATA: Explains cost in regard to the towing issue. Entering into the contract would not cost a company anything.

198 SEN. SMITH: I want to know what the impact would be on a disabled person.

235 EUGENE ORGAN, OREGON DISABILITIES COMMISSION: Submits and reviews written

testimony. (EXHIBIT C)

-Suggests ways in which the patrolling of handicapped spaces could be handled.

332 SEN. PHILLIPS: Is there any type of market analysis that has been done to determine frequency of use or misuse?

351 ORGAN: We haven't done anything like that.

355 SEN. MCCOY: I think Fred Meyer has done a study.

369 SEN. PHILLIPS: Discusses the issue of mixing public lots with private lots.

389 ORGAN: It would be nice if there were some funding to accomplish the

-Discusses the enforcement issue.

TAPE 40, SIDE B

008 ORGAN: I think we have enough spaces at this point. We have tightened the issuing of the permits.

019 JACK MUNRO, ASSOCIATION OF OREGON FOOD INDUSTRIES: Most of the retailers

would probably say that they have had to take four or five spots to make three disabled spots that

aren't frequently not used.

-First rule of a retailer is to never offend the customer.

-Discusses the retail grocery issue in regard to competition.

072 CHAIR DUKES: Are you opposed to the amendments?

074 MUNRO: I think the original bill is a problem. I am opposed to SB 615.

084 SEN. SMITH: Your retail clients don't want one of their customers parked illegally to be

offended. I suspect that if the population shifted and 51% was handicapped, your clients would

be screaming for this kind of legislation.

103 MUNRO: I think you are drawing some inferences that aren't there. We attempt to service the handicapped community as well as we can. Relative to this particular

situation; there is a lot of information and statistics that we don't know.

-Discusses the possibility of having an angry customer because their car was towed.

122 SEN. SMITH: So your concern is for the handicapped person whose placard has fallen off the dash?

126 MUNRO: We are concerned about many things.

-Discusses the fact that a lot of grocers don't actually own their facility.

-Expresses concern about the liability issue.

152 CHAIR DUKES: Discusses the issue of patrolling in regard to SB 615.

157 MUNRO: What reasons exist for our enforcement agencies so that they aren't dealing with this issue is the real question.

165 CHAIR DUKES: Regardless of what the reasons are it isn't happening. -Are your people interested in participating in solving this issue?

181 MUNRO: Yes we are.

189 CHAIR DUKES: When this bill comes before us again I would like something from the industry $\,$

that you represent stating their position on this issue and some possible solutions to this issue.

200 DAVID INGERSON, UNITED CEREBRAL PALSY OF OREGON: Submits and reviews written testimony. (EXHIBIT D)

334 LAUREL WHITEHURST, CITIZEN: I feel this bill allows the business person to deal with

065 CHAIR DUKES: Explains why this bill is back for reconsideration.

078 SUE HANNA, LEGISLATIVE COUNSEL: Reviews SB 907-3 amendments. (EXHIBIT F)

103 SEN. SMITH: Do the SB 907-3 amendments referr to SB 907-2 amendments or the original printed bill?

107 HANNA: Explains line 1 of SB 907. It just conforms it to what you thought you were doing the last time.

-Discusses technical corrects made on page 1, line 10 of SB 907-3.

-On line 22 the bracket should be outside of the 2.

-Discusses other technical cross-reference changes that were made to SB 907 $^{-3}$.

139 CHAIR DUKES: What does ORS 776.405, subsection 1-A do?

144 HANNA: That is the basic requirement that a pilot be on board. When I put in the new language $\,$

I needed to conform all of $\ensuremath{\mathsf{my}}$ references.

145 SEN. SMITH: Can you explain the exceptions to SB 907-3 amendments, on

line 12.

153 HANNA: The Coast Guard wrote and said they did not want our statutory language. The

exemption came straight out of the federal law. It refers to fishery, recreational or coastwise $% \left(1\right) =\left(1\right) +\left(1\right) +\left($

endorsement, which refers to vessels registered under the federal law. We need to exempt those

so I don't have to have a pilot on my sail boat.

- 171 SEN. SMITH: What is a coastwise endorsement? What kind of boat is that?
- 175 JEFF STONE, COLUMBIA RIVER BAR PILOT: Discusses what a coastwise endorsement

is.

- -Discusses the difference between vessels under registry and vessels under enrollment.
- 176 SEN. SMITH: Discusses coastwise endorsements.
- 182 STONE: If it makes one stop overseas than it becomes registered and under the jurisdiction of the state.
- 189 SEN. SMITH: Would this amendment eliminate the part of the bill that would require a pilot to be trained for the Columbia? That was one of the parts of the bill I liked.
- 198 STONE: The laws on federal pilotage are not as tight as they should be. Yes, you are correct. In most cases there is a state pilot on board.
- 216 SEN. SMITH: Discusses the boat grounded in Astoria.
- 222 STONE: That was a foreign registered vessel.
- 226 CHAIR DUKES: SB 907 will require state licensed pilots on those ships for which we have the ability to require.
- 233 STONE: Discusses the problem with federal pre-emption.
- MOTION: SENATOR PHILLIPS MOVES TO AMEND SB 907-3 AMENDMENTS, CHANGE BRACKET ON LINE 22, AND ON PAGE 2, ADD SUBSECTION 1-A ON LINE 24

VOTE: HEARING NO OBJECTION THE MOTION IS ADOPTED.

258 MOTION: SENATOR PHILLIPS MOVES TO CHANGE LINE 19 AND 20, OF SB 907 TO ADD THE LANGUAGE, "SUBSECTION 1".

VOTE: HEARING NO OBJECTION THE MOTION IS ADOPTED.

269 MOTION: MOVES SB 907-3, AS AMENDED, TO THE AMENDED SB 907.

VOTE: IN A ROLL CALL VOTE THE MOTION CARRIES WITH SENATORS MCCOY, TIMMS, DUFF, PHILLIPS, SMITH AND DUKES VOTING AYE, AND SENATOR BROCKMAN EXCUSED.

276 MOTION: SENATOR PHILLIPS MOVES SB 907, AS AMENDED, TO THE FLOOR WITH A "DO PASS" RECOMMENDATION.

VOTE: IN A ROLL CALL VOTE THE MOTION CARRIES WITH SENATORS MCCOY, TIMMS, DUFF, PHILLIPS, SMITH AND DUKES VOTING AYE, AND SENATOR BROCKMAN EXCUSED. SENATOR DUKES WILL CARRY THE BILL.
