013 RUTH LARSON, COMMITTEE ADMINISTRATOR: Explains SB 172-1 amendments. (EXHIBIT A)

002 CHAIR DUKES: So if they were 17 years old and they got a 3 year suspension than under this $\,$

it would go up to 20 years of age. Does Juvenile court have this authority for anything else?

What is the maximum amount of time DMV can suspend a license?

010 KARL KRUEGER, MOTOR VEHICLE DIVISION: The types of suspension we are talking

about the maximum time of suspension is 5 years, and yes Juvenile court has this authority for other things.

012 SEN. PHILLIPS: Asks about a work permit license and if it would be effected.

018 KRUEGER: It would depend on the type of suspension. These offenses that we are talking about

are revocations and so there is no provision for that sort of thing. We are talking about murder, manslaughter, criminal negligent homicide, assault, recklessly

endangering another person, criminal mischief and criminal trespass.

028 CHAIR DUKES: Do you suspend past the age of 18 on a DUII?

 $031\ \mathrm{KRUEGER}\colon$ That is correct. It would be treated the same as the adult suspension.

039 SEN. SMITH: Are these acts done with a vehicle?

040 KRUEGER: Yes they have to involve a vehicle.

041 SEN. PHILLIPS: Criminal trespass and mischief have to occur with a vehicle.

040 PLANK: We are not adding new suspensions. We do estimate the numbers to be small.

- 249 CHAIR DUKES: This bill relates to class I only.
- 256 BILL SEELY, MOTOR VEHICLE DIVISION: Submits and reviews written testimony. (EXHIBIT G)
- 277 CHAIR DUKES: How do you know if the instructor is in good standing?
- 281 SEELY: When we issue the plate we would know but after that we don't.
- 288 SEN. SMITH: Why does the state of Oregon require plates for off road vehicles?
- 294 SEELY: That law came about in 1987 at the request of the ATV industry and users.
- 307 SEN. BROCKMAN: Asks about the process in getting registered to drive an ATV.
- 317 SEELY: Explains DMV's process for registration of ATV instructor and machine.
- 325 CHAIR DUKES: I'm nervous about turning out 8 plates forever.
- 329 SEELY: It wouldn't really be a problem to renew the plates since that is our business.
- $336\ \text{SEN.}$ SMITH: Who administers the reclamation fund that the registration fees go into?
- 342 SEELY: The ATV Allocation Account Committee.
- for the titling and registration was to have the vehicles titled for theft purposes.
- -Discusses the 1985 legislation regarding the ATV account.
- 385 CHAIR DUKES: What about these being renewed periodically.

- 392 MCCALL: That would be fine.
- 402 SEELY: Instructor permits are renewed every two years, maybe we could tie that in together.
- 410 CHAIR DUKES: So a person would submit their instructor permit to get the plates.

- 011 THOMAS: An expiration date would be fine. -Explains the report each instructor must submit.
- 025 SEN. SMITH: Would it be revoked if they don't renew?
- 029 SEELY: We could tie the expiration to the permit.
- 035 CHAIR DUKES: If they didn't send their information in you wouldn't automatically renew the registration.
- 042 SEELY: Explains the costs involved with getting the plates made.
- 056 CHAIR DUKES: I would prefer not to go in the hole with this.
- 062 SEELY: Right now there are 11 instructors that are active. -Discusses other ways in which the renewal would effect the division.
- 081 CHAIR DUKES: How often do you get stopped?
- 083 THOMAS: That really isn't an issue.
- 085 CHAIR DUKES: Why couldn't we exempt ATV vehicles used for training?
- 086 THOMAS: Explains why there would be some problem with exemption.
- 108 CHAIR DUKES: Let's work all of this out and come up with something that makes sense.
