015 LARSON: Submits SB 459-1, 459-2, 459-3 amendments.(EXHIBIT A,B & C) -Explains DMV study.(EXHIBIT D)

043 SENATOR FRANK ROBERTS: Clarifies SB 459-3 amendments.(EXHIBIT C) -Discusses the objectives of the police in Portland.

082 CHAIR DUKES: What is the difference between SB 459-2 and 459-1 amendments?(EXHIBIT A & B)

094 SEN. ROBERTS: My staff really knows more about that. There were changes made in SB 459-1

amendments by DMV, and technicalities have been incorporated into SB 459-3 amendments.(EXHIBIT C) $\,$

WORK SESSION SB 615

- 191 LARSON: Explains SB 615 and SB 615-1, 615-2 and 615-3 amendments.(EXHIBIT E, F & G)
- 249 ROBERTS: Clarifies SB 615-3 amendments.(EXHIBIT G)
- 348 CHAIR DUKES: Is there still a contract in the bill, and would a retailer would still be required to enter into that?
- 354 ROBERTS: That is correct. The retailer does not want to be closely associated with the towing issue.
- 357 SEN. BROCKMAN: In SB 615-2 amendments the "otherwise" is being deleted.
- 363 SEN. SMITH: Are you comfortable with that?
- 368 ROBERTS: I do not like the provision that would eliminate the reference to "at will".
- -Discusses the idea in which the retailer is not involved at all with the towing.
- 392 SEN. BROCKMAN: They still have to contract a towing company.
- 398 ROBERTS: Explains description of the sign at the parking spot.
- 404 CHAIR DUKES: They might get letters of support from disabled people.
- 430 ROBERTS: Displays disabled parking placard to the Committee.

- 012 AL ELKINS, OREGON TOW TRUCK ASSOCIATION: Explains the purpose of the SB 615 $\,$
- 2 amendments.(EXHIBIT F)
- -Our legal counsel has advised us that the words, "otherwise", and "at will", could allow other $\,$

companies to come in and tow from the lot.

- 024 CHAIR DUKES: It says "a towing business", would be allowed to come "at will".
- 027 ELKINS: We are trying to tie that into the contract.
- 030 SEN. TIMMS: I'm still nervous about this in regard to the retailer. -Asks about the contract in regard to a shopping mall.
- 038 ELKINS: The retailer is the one we would contract with, but that may not be the case with

certain shopping malls.

- 042 SEN. TIMMS: There could be several different contracts then?
- 046 ELKINS: Explains the coordination between the retailer and the owner.
- 062 CHAIR DUKES: You don't see a problem with enacting a contract.
- 065 SEN. SMITH: Why is the "at will" language a problem?
- 070 ELKINS: We see a direct connection between "otherwise" and "at will". -We think that the contract between the retailer and the tower should state the patroling

procedures that have been agreed upon.

- 082 SEN. SMITH: If "otherwise" were deleted would you feel comfortable?
- 086 SEN. BROCKMAN: Do you really look forward to doing this?
- 090 ELKINS: Private property impounds are not done by everyone in the industry.
- -Discusses informal survey on security people that patrol lots. -We will tow some handicapped people.
- 126 SEN. TIMMS: Are towing companies able to take care of the volume of business, and what about fees?
- 132 ELKINS: We cover our costs by the tow fee. There is no fee for the contract.
- 142 SEN. TIMMS: Asks about the signs.
- 145 ELKINS: The towing sign would go beneath the handicapped parking sign that is already in place, and they would be uniform throughout the lots.
- 152 MATA: Explains definition of whom the contract would be with.
- 167 CHAIR DUKES: Why did you want lines 10 & 11 of SB 615 deleted?
- 169 ELKINS: I thought is was redundant language. We don't have any feeling one way or the other on that.
- 170 MATA: Once they have the contract then they would be under obligation to call the towing company.
- 174 SEN. MCCOY: Have you talked to owners of malls and shopping centers to see if they would like this idea?
- 178 ELKINS: No I haven't.
- 190 SEN. TIMMS: Discusses the implications of increasee fines.
- 234 MATA: We have lowered the maximum fine to \$250.00. -Explains the intent of the last session in regard to the fines.
- 243 SEN. TIMMS: What does it cost to tow a car and impound it?
- 246 ELKINS: Statewide the fee is about \$33.00 and storage is about \$8.00. That doesn't include the ticket fee.
- 252 SEN. TIMMS: Why was mine more expensive?
- 257 ELKINS: Portland is a lot more expensive.
- 268 MATA: Under existing law they may not be cited the \$100.00 if they are towed before they are ticketed.

-Explains the Highway Divisions conservative cash flow policy.

025 CHAIR DUKES: What is the average balance on any given day?

030 LEWIS: Refers to graph in testimony. (EXHIBIT K)

070 CHAIR DUKES: Why are you running at a deficit?

072 LEWIS: We aren't at a deficit right now. If we draw the balance down there is a possibility that $% \left(1\right) =\left(1\right) +\left(1\right$

we could be in a deficit situation. We can delay construction projects.

078 CHAIR DUKES: I didn't mean delay the project, but what about the bill for the project? Do we

pay it the day it is finished or what? It looks like a day or two could make a significant

difference. We're concerned about paying interest on borrowed money. There may be another $\,$

way to do this.

085 SEN. MCCOY: Do you spend as you go?

 $089\ \mathrm{LEWIS}\colon \mathrm{We}\ \mathrm{do}\ \mathrm{plan}\ \mathrm{ahead}.$ We have a forecast that we look at whick takes us out a couple of bienniums.

098 SEN. MCCOY: Asks about the procedure of forecasting.

104 FORBES: Discusses the Highway Departments fund balance.

125 SEN. PHILLIPS: What is the period of the running time for your accounts payable? How you manage your flow is extremely important.

138 LEWIS: It is a prudent and reasonable time.

142 SEN. SMITH: What would the interest rate be?

144 LEWIS: About 7.8 percent.

150 CHUCK SMITH, OREGON STATE TREASURY: Submits and reviews written testimony.(EXHIBIT L)

175 SEN. MCCOY: Would you help them work out a plan?

179 SMITH: I think they have devoted a lot of resources to managing their cash flow. This would

be a backup tool to maximize the use of their cash on hand.

192 SEN. MCCOY: What would happen if they couldn't pay you?

202 SMITH: Discusses the gas tax and the weight-mile tax. -Explains different ways of re-payment.

- 213 SEN. MCCOY: We would need to do an expenditure limitation?
- 218 LEWIS: That is set in the budgetary process and is independent of this. We are talking about cash

flow limitations.

-We do have a plan in place.

- 233 CHAIR DUKES: We don't want to spend anymore you just want to spend it before you get it.
- 237 LEWIS: We want to spend it more prudently. We want to get the maximum use of the dollars that are there.
- 241 SEN. TIMMS: How much money did you save when you shifted to a more liberal cash flow?
- 251 FORBES: Our basic job is to reconstruct highways. The issue is should we be holding money
- in the bank and drawing interest on it or should we keep the minimum balance necessary, and go out and build roads.
- 258 SEN. TIMMS: What do you get paid on your balance?
- 261 LEWIS: The rate that the Treasury has is about 7.8 percent.
- 275 FORBES: Explains the Highway operating fund. -Discusses dedicated funds.
- 285 CHAIR DUKES: So you would be able to move Litter Patrol and Snow-Park money over for a Highway project?
- 301 FORBES: Just for a very short period of time, a day or two. This is a philosophical issue.
- 306 SEN. MCCOY: What are the other accounts?
- 310 FORBES: Refers to Tony Lewis's testimony.(EXHIBIT K)
- 317 CHAIR DUKES: Is the Treasury currently working with the Highway Department on a financial plan?
- 336 SMITH: Yes I have seen portions of cash flows with respect to financial plans.
- 346 CHAIR DUKES: Is there a plan that has been agreed upon?
- 350 LEWIS: Discusses bonding in relation to cash flow.
- $364\ \textsc{SEN}.$ PHILLIPS: Compares private scenario to a public entity in regard to accounting practices.
- 373 FORBES: Discusses the business process in regard to financing.
- 398 SMITH: Is borrowing through the Treasury rare?
- 403 SEN. MCCOY: You only want to borrow if you got down to a certain level?
- 410 LEWIS: Yes borrowing in this way is rare, but it would be a planned borrow.
- 415 SEN. MCCOY: Can you already go and borrow in case of an emergency?

050 SEN. TIMMS: How come the bill was drafted at 10 million and now you need 25 million?

057 LEWIS: Refers to testimony. (EXHIBIT K)

078 MOTION: SENATOR TIMMS MOVES SB 64-1 AMENDMENTS TO SB 64.

VOTE: HEARING NO OBJECTION THE MOTION IS ADOPTED.

082 MOTION: SENATOR TIMMS MOVES SB 64, AS AMENDED, TO WAYS & MEANS WITH A "DO PASS" RECOMMENDATION.

PUBLIC HEARING ON SB 65

106 FORBES: Submits and reviews written testimony.(EXHIBIT M)

175 LEWIS: Discusses current limitations and bonding authority.

177 SEN. PHILLIPS: This bill makes me extremely nervous. This is a major policy issue. It seems you can't make up your mind.

190 FORBES: It is unfortunate that Bob Bothman couldn't be here today to give you a more direct response.

-When we put together this proposal it was based only on our needs.

207 SEN. PHILLIPS: Is this general obligation authority? Is this a way to some how circumvent a pubic vote? How does that work itself into this factor?

230 SMITH: Discusses general obligation bonds and revenue bonds.

-These are constitutionally voted obligations we are talking about.

269 SEN. PHILLIPS: Asks how this would affect the voter approval mechanism.

280 SMITH: The department would loan the money to local governments based upon their contractual arrangements and the shared gasoline tax would help to re-pay the loan.

287 SEN. PHILLIPS: Is the process in SB 65 going to eliminate the voter authorization?

291 LEWIS: I believe it would because the bonds would be issued under our constitutional authority.

303 SEN.PHILLIPS: So local governments can go out and dip into this general obligation bond pool without the approval of the public. It isn't a good way even if it is only for highway funds.

309 FORBES: One thing the coalition can agree upon is the need for more resources.

-This is a lack of agreement on how best to divide those precious resources to tackle the statewide need.

 $324~\mathrm{SEN}.~\mathrm{PHILLIPS}\colon$ It doesn't do us any good to come forward with measure that would avoid the constituent.

337 FORBES: This was never intended to circumvent the process. We are looking at a way to close the gap between what I am asked to do and the amount of resources I have to do them with.

343 SEN. PHILLIPS: I still have a problem with this.

 $348\,$ SEN. TIMMS: I am still having a problem with highway funding and the Access Oregon issue.

Please carry this message back to Mr. Bothman. -Discusses highways of national significance.

384 FRED NUSSB AUM, OREGON ASSOCIATION OF RAILWAY PASSENGERS: Testifies against SB 65.

-Discusses the Access Oregon program.

010 NUSSB AUM: It is not a good idea to mortgage our future revenues. -Discusses multi-modal transportation funds.
