OFFENSES IN PRESENT OREGON LAW AS THEY
WOULD RELATE TO PROPOSED REVISION

A brief examination of penalties attached to areas of conduct not generally within the criminal code indicates the following:

- (1) Very few penalties will fall within the petty misdemeanor category, largely because low fines are matched with six month jail sentences.
- (2) There appear to be occasional references to a crime described in the criminal code, as well as specification of penalty; e.g. ORS 517.990 specifically indicates that the violation constitutes larceny by bailee.
- (3) There will be a need for a provision specifying the penalty for a misdemeanor where no penalty is specified. See ORS 161.080.
- (4) There are conflicts in the credit to be given per day of jail time in lieu of payment of fine. See ORS 496.990 (\$5 per day) and ORS 540.990 (\$2 per day).
- (5) The recommendations for improvement contained in the Beckett study (40 Oregon Law Review, nos. 1 and 2, 1960) are not going to be met by the proposed revision because it does not deal with even the majority of the penalty clauses to which the study refers. However, in fact, the proposed revision may deal with the majority of the felony penalties. The commission may wish, therefore, to issue a caveat on the limitations of its penalty revisions lest there be some misunderstanding as to the scope of its revision.
