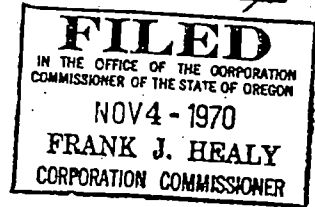

ARTICLES OF INCORPORATION

The undersigned natural person being over the age of twenty-one years and acting as incorporator under the Oregon Nonprofit Corporation Law does hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of this corporation is SOUTHWEST HOSPITAL and its duration shall be perpetual.

ARTICLE II

The primary purpose of the corporation shall be to construct and operate an acute general hospital and medical center and to otherwise engage in any lawful activities, none of which shall be for profit, for which corporations may be organized under the Oregon Nonprofit Corporation Law, ORS Chapter 61.

ARTICLE III

The address of the initial registered office of the corporation is 220 S. W. Morrison Street, Portland, Oregon 97204, and the name of its initial registered agent at such address is James G. Swindells.

ARTICLE IV

The number of directors constituting the initial board of directors of the corporation is 10, and the names and addresses of the persons who are to serve as directors until the first annual meeting or until their successors are elected and shall qualify are:

The provisions for the distribution of assets on dissolution or final liquidation are: "In the event of the dissolution of this corporation, all liabilities and indebtedness thereof shall be paid and the assets then remaining shall be transferred one-half thereof to the Emanuel Lutheran Charity Board, an Oregon nonprofit corporation, or to its successors or assigns, and the other one-half to Physicians and Surgeons Hospital, an Oregon nonprofit corporation, its successors or assigns, provided, always, that none of said assets shall be transferred to any individual or a corporate entity organized for profit."

ARTICLE VII

No person shall be denied the services and care provided by this corporation by reason of race, color, creed or inability to pay.
