SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Enacts new Oregon probate code. Revises laws relating to probate courts and procedure, intestate succession, wills, initiation of estate proceedings, appointment and qualification of personal representatives (executors and administrators), administration and distribution of decedents' estates, guardianships and conservatorships. Generally eliminates distinctions in treatment of real and personal property. Replaces dower and curtesy with enlarged intestate share and election against will of surviving spouse. Lowers age for making will from 21 to 18. Expands requirements for notice to interested persons of initiation of estate proceeding, but reduces number of published notices. Shortens time period for contesting will and filing claims for preferential payment from 6 to 4 months. Broadens and makes more flexible the support allowance for surviving spouse and dependent children. Simplifies handling of small, solvent estates by permitting them, after paying claims, expenses and taxes, to be set apart as family support, with summary closure of estate proceeding. Gives personal representative more power to act without court proceeding and approval, but allows him or any interested person to obtain court instruction or approval. Makes inventory and appraisal requirements more flexible. Simplifies escheat proceedings. Imparts finality and conclusiveness to court's decree of final distribution. Modifies procedures for handling estates of absentees, including substitution of finding of death based on actual search instead of 7-year presumption. Makes changes in inheritance tax procedures to simplify and conform them to modifications of probate laws. Eliminates separate procedures for conserving property of missing persons, and makes estates of such persons subject to guardianship proceedings. Makes many other substantive changes and refinements in probate laws, rearranges and clarifies those laws and conforms other laws that are geared to probate courts and procedures.

ARTICLE I. GENERAL PROVISIONS

2 2 Part 1. Definitions

- Section 1. Definitions. As used in sections 1 to 212 of this Act, unless
- 24 the context requires otherwise:
- 25 (1) "Abate" means to reduce a devise on account of the insufficiency
- 26 of the estate to pay all claims, expenses and devises in full.
- 27 (2) "Action" includes suits and legal proceedings.
- 28 (3) "Administration" means any proceeding relating to the estate of
- 29 a decedent, whether the decedent died testate, intestate or partially
- 30 intestate.

- 31 (4) "Advancement" means a gift by a decedent to an heir to enable
- 32 the donee to anticipate his inheritance to the extent of the gift.
- 33 (5) "All purposes of intestate succession" means succession by, through
- 34 or from a person, both lineal and collateral.

- 1 (6) "Assets" includes real, personal and intangible property.
- 2 (7) "Claim" includes liabilities of a decedent, whether arising in con-
- 8 tract, in tort or otherwise.
- 4 (8) "Court" or "probate court" means the court in which jurisdiction
- 5 of probate matters, causes and proceedings is vested as provided in sec-
- 6 tion 4 of this Act.
- 7 (9) "Decedent" means a person who has died leaving property that is
- 8 subject to administration.
- 9 (10) "Devise," when used as a noun, means property disposed of by a
- 10 will, and includes "legacy" and "bequest."
- 11 (11) "Devise," when used as a verb, means to dispose of property by
- 12 a will, and includes "bequeath.".
- 13 (12) "Devisee" includes "legatee" and "beneficiary."
- 14 (13) "Distributee" means a person entitled to any property of a de-
- 15 cedent under his will or under intestate succession.
- 16 (14) "Domicile" means the place of abode of a person, where he in-
- 17 tends to remain and to which, if absent, he intends to return.
- 18 (15) "Estate" means the real and personal property of a decedent, as
- 19 from time to time changed in form by sale, reinvestment or otherwise, and
- 20 augmented by any accretions or additions thereto and substitutions there-
- 21 for or diminished by any decreases and distributions therefrom.
- (16) "Funeral" includes burial or other disposition of the remains of a
- 23 decedent, including the plot or tomb and other necessary incidents to the
- 24 disposition of the remains.
- 25 (17) "General devise" means a devise chargeable generally on the
- 26 estate of a testator and not distinguishable from other parts thereof or
- 27 not so given as to amount to a specific devise.
- 28 (18) "Heir" means any person, including the surviving spouse, who is
- 29 entitled under intestate succession to the property of a decedent who died
- 30 wholly or partially intestate.
- 31 (19) "Interested person" includes heirs, devisees, children, spouses,
- 32 creditors and any others having a property right or claim against the estate
- 33 of a decedent that may be affected by the proceeding. It also includes
- 34 fiduciaries representing interested persons.

- 1 (20) "Intestate" means one who dies without leaving a valid will, or
- 2 the circumstance of dying without leaving a valid will, effectively disposing
- 3 of all his estate.
- 4 (21) "Intestate succession" means succession to property of a decedent
- 5 who dies intestate or partially intestate.
- 6 (22) "Issue" includes adopted children and their issue and, when used
- 7 to refer to persons who take by intestate succession, includes all lineal de-
- 8 scendants, except those who are the lineal descendants of living lineal
- 9 descendants.
- 10 (23) "Net estate" means the real and personal property of a decedent,
- 11 except property used for the support of his surviving spouse and children
- 12 and for the payment of expenses of administration, funeral expenses,
- 13 claims and taxes.
- 14 (24) "Net intestate estate" means any part of the net estate of a de-
- 15 cedent not effectively disposed of by his will.
- 16 (25) "Personal property" includes all property other than real prop-
- 17 erty.
- 18 (26) "Personal representative" includes executor, administrator, admin-
- 19 istrator with will annexed and administrator de bonis non, but does not
- 20 include special administrator.
- 21 (27) "Property" includes both real and personal property.
- 22 (28) "Real property" includes all legal and equitable interests in land,
- 23 in fee and for life.
- 24 (29) "Settlement" includes, as to the estate of a decedent, the full
- 25 process of administration, distribution and closing.
- 26 (30) "Specific devise" means a devise of a specific thing or specified
- 27 part of the estate of a testator that is so described as to be capable of
- 28 identification. It is a gift of a part of the estate identified and differentiated
- 29 from all other parts.
- 30 (31) "Will" includes codicil; it also includes a testamentary instrument
- 31 that merely appoints an executor or that merely revokes or revives an-
- 32 other will.

Part 2. Probate Courts and Commissioners

34 Section 2. Transfer of probate jurisdiction. (1) All probate jurisdiction,

- 1 authority, powers, functions and duties of the county courts and the judges
- 2 thereof and the district courts and the judges thereof are transferred to
- 8 the circuit courts and the judges thereof in all counties except Gilliam,
- 4 Grant, Harney, Malheur, Sherman and Wheeler Counties.
- 5 (2) All probate jurisdiction, authority, powers, functions and duties of
- 6 the circuit courts and the judges thereof are transferred to the county
- 7 courts and the judges thereof in Gilliam, Grant, Harney, Malheur, Sherman
- 8 and Wheeler Counties.
- 9 Section 3. Transfer of pending proceedings; contested matters; appeals.
- 10 (1) Except as otherwise provided in this section, all matters, causes and
- 11 proceedings relating to probate jurisdiction, authority, powers, functions
- 12 and duties pending on the effective date of this Act in a court from which
- 18 the jurisdiction, authority, powers, functions and duties are transferred
- 14 by section 2 of this Act are transferred to the court to which the juris-
- 15 diction, authority, powers, functions and duties are so transferred.
- 16 (2) Contested matters pending in the circuit court for Gilliam, Grant,
- 17 Harney, Malheur, Sherman or Wheeler County under ORS 5.050, and
- 18 pending appeals therefrom, on the effective date of this Act shall be
- 19 conducted and completed pursuant to the provisions of law in effect
- 20 immediately before that date.
- 21 (3) Appeals pending in a circuit court under ORS 5.120, 109.370, 116.535,
- 22 118.500, subsection (3) of 118.700, subsection (1) of 179.650 or ORS 427.085
- 23 on the effective date of this Act shall be conducted and completed pur-
- 24 suant to the provisions of law in effect immediately before that date.
- Section 4. Probate jurisdiction vested. Jurisdiction of all probate mat-
- 26 ters, causes and proceedings is vested in the county courts of Gilliam,
- 27 Grant, Harney, Malheur, Sherman and Wheeler Counties and in the
- 28 circuit court for each other county and as provided in section 8 of this Act.
- Section 5. Probate jurisdiction described. The jurisdiction of the pro-
- 30 bate court includes, but is not limited to:
- 31 (1) Appointment and qualification of personal representatives.
- 32 (2) Probate and contest of wills.
- 33 (3) Determination of heirship.

- 1 (4) Determination of title to and rights in property claimed by or 2 against personal representatives, guardians and conservators.
- (5) Administration, settlement and distribution of estates of decedents.
- 4 (6) Construction of wills, whether incident to the administration or
- 5 distribution of an estate or as a separate proceeding.
- 6 (7) Guardianships and conservatorships, including the appointment and
- 7 qualification of guardians and conservators and the administration, settle-
- 8 ment and closing of guardianships and conservatorships.
- (8) Supervision and disciplining of personal representatives, guardians
 and conservators.
- 11 Section 6. Powers of probate court. (1) The general legal and equitable
- 12 powers of a circuit court are applicable to effectuate the jurisdiction of
- 13 a probate court, punish contempts and carry out its determinations, orders,
- 14 judgments and decrees as a court of record with general jurisdiction in
- 15 law and equity, and the same validity, finality and presumption of regu-
- 16 larity shall be accorded to its determinations, orders, judgments and de-
- 17 crees, including determinations of its own jurisdiction, as to those of a
- 18 court of record with general jurisdiction in law and equity.
- 19 (2) A probate court has full, legal and equitable powers to make de-
- 20 claratory judgments, as provided in ORS 28.010 to 28.160, in all matters
- 21 involved in the administration of an estate, including those pertaining to
- 22 the title of real property, the determination of heirship and the distribu-
- 23 tion of the estate.
- Section 7. Appeals from probate court; reexamination of issues. (1) Ex-
- 25 cept as otherwise provided in this section, no issue determined in a probate
- 26 court shall be tried again on appeal or otherwise reexamined in a manner
- 27 other than those appropriate to issues determined by a court of record
- 28 with general jurisdiction in law and equity.
- 29 (2) Appeals from a circuit court sitting in probate shall be taken to
- 30 the Supreme Court in the manner provided by law for appeals from the
- 31 circuit court.
- 32 (3) Appeals from a county court sitting in probate shall be taken to
- 33 the circuit court and Supreme Court in the manner provided by ORS
- 84 5.120.

- 1 Section 8. Transfer of estate proceeding from county court to circuit
- 2 court. (1) An estate proceeding, including all probate matters, causes and
- 3 proceedings pertaining thereto, may be transferred at any time from a
- 4 county court sitting in probate to the circuit court for the county by order
- ⁵ of the county court.
- 6 (2) An estate proceeding, including all probate matters, causes and
- 7 proceedings pertaining thereto, commenced in a county court sitting in
- 8 probate and in which the county judge is a party or directly interested
- 9 shall be transferred from the county court to the circuit court for the
- 10 county by order of the county court.
- 11 (3) Upon transfer of an estate proceeding from a county court to the
- 12 circuit court under this section, the county clerk shall certify and cause
- 18 to be filed in the records of the circuit court all original papers and pro-
- 14 ceedings pertaining to the estate proceeding, and thereafter jurisdiction
- 15 of all probate matters, causes and proceedings pertaining to the estate pro-
- 16 ceeding is vested in the circuit court as if that jurisdiction had been
- 17 originally and exclusively vested in the circuit court.
- Section 9. District court judge acting as probate court judge. (1) In
- 19 Benton, Clatsop, Coos, Curry, Deschutes, Hood River, Lincoln, Wasco and
- 20 Washington Counties, a judge of the district court for the county may
- 21 exercise the powers and duties of judge of the circuit court for the county
- 22 in any matter, cause or proceeding in probate pending in the county. In
- 23 any other county, a judge of the district court for the county may exercise
- 24 any power or duty of judge of the circuit court in any matter, cause or
- 25 proceeding in probate pending in the circuit court of the judicial district
- 26 in which the district court is located, which is assigned to him by a judge
- 27 of the circuit court of the judicial district.
- 28 (2) Whenever by reason of absence, illness or injury there is not within
- 29 a county a judge of the probate court able to preside over and conduct
- 30 the business of the probate court, any judge of a district court located in
- 31 the judicial district may exercise the powers and duties of judge of the
- 32 probate court for the county in any matter, cause or proceeding in probate
- 33 pending in the county.
- 34 (3) If the district judge is not a party to, or directly interested in, the

- 1 matter, cause or proceeding, and if the question or matter passed upon by
- 2 him has not been presented to, or passed upon by, any probate court
- 3 judge, any decree, judgment or order given and made by a district court
- 4 judge pursuant to his powers and duties under this section, when filed
- 5 and entered in the matter, cause or proceeding, has the same effect as
- 6 though given and made by a probate court judge.
- 7 Section 10. Appointment of probate commissioner. The court may ap-
- 8 point the clerk of the probate court or some other suitable person at the
- 9 county seat to act as probate commissioner within the county. If the clerk
- 10 of the probate court is appointed probate commissioner, his deputy has
- 11 the power to perform any act as probate commissioner that the clerk has,
- 12 and the clerk is responsible for conduct of the deputy so acting.
- 13 Section 11. Powers of probate commissioner. (1) A probate commis-
- 14 sioner may act upon uncontested petitions for appointment of special ad-
- 15 ministrators, for probate of wills and for appointment of personal repre-
- 16 sentatives, guardians and conservators, to the extent authorized by rule
- 17 of the court. Pursuant thereto he may make and enter orders on behalf of
- 18 the court admitting wills to probate and appointing and setting the amount
- 19 of the bonds of special administrators, personal representatives, guardians
- 20 and conservators, subject to his orders being set aside or modified by the
- 21 judge of the court within 30 days after the date an order is entered.
- 22 (2) Any matter presented to the probate commissioner may be referred
- 23 by him to the judge.
- 24 (3) Unless set aside or modified by the judge, the orders of the probate
- 25 commissioner have the same effect as if made by the judge.

26 Part 3. Probate Procedure Generally

- 27 Section 12. Pleadings and mode of procedure. No particular pleadings
- 28 or forms thereof are required in the exercise of jurisdiction of probate
- 29 courts. The mode of procedure in the exercise of jurisdiction is in the
- 30 nature of a suit in equity except as otherwise provided by statute. The
- 31 proceedings shall be in writing and upon the petition of a party in interest
- 32 or the order of the court. All petitions, reports and accounts shall be veri-
- 33 fied by at least one of the persons making them or by his attorney, or

- 1 in case of a corporation by its agent. The court exercises its powers by 2 means of:
- 3 (1) A petition of a party in interest.
- 4 (2) A notice to a party.
- 5 (3) A subpena to a witness.
- 6 (4) Orders and decrees.
- 7 (5) An execution or warrant to enforce its orders and decrees.
- 8 Section 13. Notice; method and time of giving. (1) Except as otherwise
- 9 specifically provided in sections 1 to 212 of this Act, whenever notice is
- 10 required to be given of a hearing on any petition or other matter upon
- 11 which an order is sought, the petitioner or other person filing the matter
- 12 shall cause notice of the date, time and place of the hearing to be given
- 13 to each person interested in the subject of the hearing or to his attorney,
- 14 if he has appeared by attorney or requested that notice be sent to his
- 15 attorney, in any one or more of the following ways and within the follow-
- 16 ing times:
- 17 (a) By mailing a copy thereof addressed to him or his attorney at least
- 18 14 days before the date set for the hearing.
- 19 (b) By delivering a copy thereof to him personally or to his attorney
- 20 at least five days before the date set for the hearing.
- (c) If the address of any person is not known or cannot be ascertained
- 22 with reasonable diligence, by publishing a copy thereof once in each of
- three consecutive weeks in a newspaper of general circulation in the county
- 24 where the hearing is to be held, the last publication of which shall be at
- 25 least 10 days before the date set for the hearing.
- 26 (2) Upon good cause shown the court may change the requirements
- 27 as to the method or time of giving notice for any hearing.
- 28 (3) Proof of the giving of notice must be made at or before the hear-
- 29 ing and filed in the proceeding. Proof shall be by an admission of serv-
- 30 ice, a return receipt from the postal authorities or an affidavit or certifi-
- 31 cate of the person giving notice or the publisher, or one of his employes,
- 32 of the newspaper publishing the notice.
- 33 Section 14. Waiver of notice. A guardian, a guardian ad litem, a con-
- 34 servator or a person who is neither incompetent nor a minor may waive

- 1 notice by a writing signed by him or his attorney and filed in the pro-
- 2 ceeding, or by his appearance at the hearing.
- 3 Section 15. Filing objections to petition. Any interested person, on or
- 4 before the date set for a hearing, may file written objections to a petition
- 5 previously filed.
- 6 Section 16. Proof of documents; certification. (1) Proof of documents
- 7 pursuant to sections 1 to 212 of this Act may be made as follows:
- 8 (a) Of a will, by a certified copy thereof.
- 9 (b) That a will has been probated or established in a foreign juris-
- 10 diction, by a certified copy of the order admitting the will to probate
- 11 or evidencing its establishment.
- 12 (c) Of letters testamentary or of administration, by a certified copy
- 13 thereof. The certification may include a statement that the letters have not
- 14 been revoked.
- 15 (2) A document or order filed or entered in a foreign jurisdiction may
- 16 be proved by a copy thereof, certified by a clerk of the court in which the
- 17 document or order was filed or entered or by any other official having legal
- 8 custody of the original document or order.
- 19 Section 17. Translation of documents. If a document or part thereof
- 20 is not in the English language, a translation certified by the translator to
- 21 be accurate may be attached thereto and shall be regarded as sufficient
- 22 evidence of the contents of the document, unless objection is made thereto.
- 23 In the absence of objection, if any person relies in good faith on the accu-
- 24 racy of the translation he shall not be prejudiced thereafter because of its
- 25 inaccuracy.
- Section 18. Stenographic record. The judge of the court may, on his
- 27 own motion or on the request of an interested person, direct the reporter
- 28 of his court to attend any hearing and make a stenographic record of the
- 29 same.

ARTICLE II. INTESTATE SUCCESSION AND WILLS

- Part 1. Intestate Succession
- 32 Section 19. Net intestate estate. Any part of the net estate of a decedent
- 33 not effectively disposed of by his will shall pass as provided in sections
- 34 20 to 23 of this Act.

- 1 Section 20. Share of surviving spouse if decedent leaves issue. If the
- 2 decedent leaves a surviving spouse and issue, the surviving spouse shall
- 3 have a one-half interest in the net intestate estate.
- 4 Section 21. Share of surviving spouse if decedent leaves no issue. If the
- 5 decedent leaves a surviving spouse and no issue, the surviving spouse
- 6 shall have all of the net intestate estate.
- 7 Section 22. Share of others than surviving spouse. The part of the net
- 8 intestate estate not passing to the surviving spouse shall pass:
- 9 (1) To the issue of the decedent. If the issue are all of the same de-
- 10 gree of kinship to the decedent, they shall take equally, but if of unequal
- 11 degree, then those of more remote degrees take by representation.
- 12 (2) If there is no surviving issue, to the surviving parents of the de-
- 13 cedent.
- 14 (3) If there is no surviving issue or parent, to the brothers and sisters
- 15 of the decedent and the issue of any deceased brother or sister of the
- 16 decedent by representation. If there is no surviving brother or sister, the
- 17 issue of brothers and sisters take equally if they are all of the same de-
- 18 gree of kinship to the decedent, but if of unequal degree, then those of
- 19 more remote degrees take by representation.
- 20 (4) If there is no surviving issue, parent or issue of a parent, to the
- 21 grandparents of the decedent and the issue of any deceased grandparent
- 22 of the decedent by representation. If there is no surviving grandparent,
- 23 the issue of grandparents take equally if they are all of the same degree of
- 24 kinship to the decedent, but if of unequal degree, then those of more re-
- 25 mote degrees take by representation.
- 26 (5) If, at the time of taking, surviving parents or grandparents of the
- 27 decedent are married to each other, they shall take real property as ten-
- 28 ants by the entirety and personal property as joint owners with the right
- 29 of survivorship.
- 30 Section 23. Escheat. If no person takes under sections 20 to 22 of this
- 81 Act, the net intestate estate shall escheat to the State of Oregon.
- Section 24. Representation defined. "Representation" means the method
- 33 of determining the passing of the net intestate estate when the distribu-
- 34 tees are of unequal degrees of kinship to the decedent. It is accomplished

- 1 as follows: The estate shall be divided into as many shares as there
- 2 are surviving heirs of the nearest degree of kinship and deceased persons
- 3 of the same degree who left issue who survive the decedent, each surviving
- 4 heir of the nearest degree receiving one share and the share of each de-
- 5 ceased person of the same degree being divided among his issue in the
- 6 same manner.
- 7 Section 25. Time of determining relationships; afterborn heirs. The re-
- 8 lationships existing at the time of the death of the decedent govern the
- 9 passing of his net intestate estate, but persons conceived before his death
- 10 and born alive thereafter inherit as though they were alive at the time of
- 11 his death.
- Section 26. Heir to survive decedent by five days. Any person who fails
- 18 to survive the decedent by five days is considered to have predeceased
- 14 the decedent for all purposes of intestate succession, and the heirs of the
- 15 decedent are determined accordingly.
- Section 27. Persons of the half-blood. Persons of the half-blood inherit
- 17 the same share that they would inherit if they were of the whole blood.
- Section 28. Succession where parents not married. (1) For all purposes
- 19 of intestate succession, full effect shall be given to all relationships as
- 20 described in ORS 109.060, except as otherwise provided by law in case
- 21 of adoption.
- 22 (2) For all purposes of intestate succession and for those purposes
- 23 only, before the relationship of father and child and other relationships
- 24 dependent upon the establishment of paternity shall be given effect under
- 25 subsection (1) of this section:
- 26 (a) The paternity of the child shall have been established under ORS
- 27 109.070 during the lifetime of the child or;
- 28 (b) The father shall have acknowledged himself to be the father in
- 29 writing signed by him during the lifetime of the child.
- 30 Section 29. Persons related to decedent through two lines. A person
- 31 who is related to the decedent through two lines of relationship is entitled
- 32 to only a single share based on the relationship which would entitle him
- 33 to the larger share.

Part 2. Advancements

- 2 Section 30. When gift is an advancement. If a person dies intestate as
- 3 to all his estate, property which he gave in his lifetime to an heir shall be
- 4 treated as an advancement against the heir's share of the estate if de-
- 5 clared in writing by the decedent or acknowledged in writing by the heir
- 6 to be an advancement. For that purpose the property advanced shall be
- 7 valued as of the time the heir came into possession or enjoyment of the
- 8 property or as of the time of death of the decedent, whichever occurs
- 9 first.

1

- Section 31. Effect of advancement on distribution. (1) If the value of
- 11 the advancement exceeds the heir's share of the estate, he shall be excluded
- 12 from any further share of the estate, but he shall not be required to re-
- 13 fund any part of the advancement. If the value of the advancement is
- 14 less than his share, the heir shall be entitled upon distribution of the
- 15 estate to such additional amount as will give him his share of the estate.
- 16 (2) The property advanced is not a part of the estate, but for the pur-
- 17 pose of determining the shares of the heirs the advancement shall be added
- 18 to the estate, the sum then divided among the heirs and the advancement
- 19 then deducted from the share of the heir to whom the advancement was
- 20 made.
- Section 32. Death of advancee before decedent. If the recipient of the
- 22 property advanced fails to survive the decedent, the amount of the ad-
- 23 vancement shall be taken into account in computing the share of the issue
- 24 of the recipient, whether or not the issue take by representation.

25 Part 3. Status of Adopted Persons

- Section 33. Adopted persons. (1) An adopted person, his issue and
- 27 kindred shall take by intestate succession from his adoptive parents,
- 28 their issue and kindred, and his adoptive parents, their issue and kindred
- 29 shall take by intestate succession from the adopted person, his issue and
- 30 kindred, as though the adopted person were the natural child of his
- 31 adoptive parents.
- 32 (2) An adopted person shall cease to be treated as the child of his
- 33 natural parents for all purposes of intestate succession by the adopted

- 1 person, his issue and kindred and his natural parents, their issue and
- 2 kindred, except:
- 3 (a) If a natural parent of a person marries or remarries and the per-
- 4 son is adopted by his stepparent, the adopted person shall continue also to
- 5 be treated, for all purposes of intestate succession, as the child of the
- 6 natural parent who is the spouse of the adoptive parent.
- (b) If a natural parent of a person dies, the other natural parent re-
- 8 marries and the person is adopted by his stepparent, the adopted person
- 9 shall continue also to be treated, for all purposes of intestate succession
- 10 by any person through the deceased natural parent, as the child of the
- 11 deceased natural parent.
- 12 (3) Sections 1 to 212 of this Act apply to adopted persons who were
- 13 adopted in this state or elsewhere.
- Section 34. Effect of more than one adoption. For all purposes of in-

- 16 treated as the child of the parents who have most recently adopted him
- and, except as otherwise provided in this section, shall cease to be treated
- 18 as the child of his previous adoptive parents. He shall continue also to be
- 19 treated as the child of his natural parent or previous adoptive parent
- 20 only to the extent provided in subsection (2) of section 33 of this Act,
- 21 and for the purpose of applying that subsection with reference to a
- 22 previous adoptive parent, "natural parent" in that subsection means the
- 23 previous adoptive parent.
- 24 Section 35. References in wills, deeds and other instruments to accord
- 25 with law of intestate succession. Unless a contrary intent is established
- 26 by the instrument, all references in a will, deed, trust instrument or other
- 27 instrument to an individual or member of a class described generically
- 28 in relation to a particular person as children, issue, grandchildren, de-
- 29 scendants, heirs, heirs of the body, next of kin, distributees, grandparents,
- 30 brothers, nephews or other relatives shall include any person who would
- 31 be treated as so related for all purposes of intestate succession, except
- 32 that an adopted person so included must have been adopted as a minor or
- 33 after having been a member of the household of the adoptive parent
- 34 while a minor.

Part 4. Wills

- 2 Section 36. Who may make a will. Any person who is 18 years of age
- 3 or older or who has been lawfully married, and who is of sound mind, may
- 4 make a will.

- 5 Section 37. Execution of a will. A will shall be in writing and shall be
- 6 executed with the following formalities:
- 7 (1) The testator, in the presence of each of the witnesses, shall:
- 8 (a) Sign the will; or
- 9 (b) Direct one of the witnesses or some other person to sign thereon
- 10 the name of the testator; or
- 11 (c) Acknowledge the signature previously made on the will by him or
- 12 at his direction.
- 13 (2) Any person who signs the name of the testator as provided in
- 14 paragraph (b) of subsection (1) of this section shall sign his own name
- 15 on the will and write on the will that he signed the name of the testator
- 16 at the direction of the testator.
- 17 (3) At least two witnesses shall each:
- 18 (a) See the testator sign the will; or
- 19 (b) Hear the testator acknowledge the signature on the will; and
- 20 (c) Attest the will by signing his name to it in the presence of the
- 21 testator and at his request.
- 22 Section 38. Witness as beneficiary. An interested witness is one to
- 23 whom is devised a personal and beneficial interest in the estate. A will
- 24 attested by an interested witness is not thereby invalidated. If an inter-
- 25 ested witness attests a will and the will is not attested also by two dis-
- 26 interested witnesses, the interested witness may take under the will only
- 27 so much of the provision made for him therein as in the aggregate equals
- 28 in value, on the date of death of the testator, the part of the estate of the
- 29 testator that would have passed to him had the testator died intestate.
- Section 39. Validity of execution of a will. A will is lawfully executed
- 31 if it is in writing, signed by or at the direction of the testator and otherwise
- 32 executed in accordance with the law of:
- 33 (1) This state at the time of execution or at the time of death of the
- 34 testator; or

- 1 (2) The domicile of the testator at the time of execution or at the time 2 of his death; or
- 3 (3) The place of execution at the time of execution.
- Section 40. Testamentary additions to trusts. (1) A devise may be made
- 5 by a will to the trustee or trustees of a trust, regardless of the existence,
- 6 size or character of the corpus of the trust, if:
- 7 (a) The trust is established or will be established by the testator, or
- 8 by the testator and some other person or persons, or by some other person
- 9 or persons; and
- 10 (b) The trust is identified in the testator's will; and
- 11 (c) The terms of the trust are set forth in a written instrument, other
- 12 than a will, executed before or concurrently with the execution of the
- 18 testator's will, or in the valid last will of a person who has predeceased
- 14 the testator.
- 15 (2) The trust may be a funded or unfunded life insurance trust,
- 16 although the trustor has reserved any or all of the rights of ownership of
- 17 the insurance contracts.
- 18 (3) The devise shall not be invalid because the trust:
- (a) Is amendable or revocable, or both; or
- 20 (b) Was amended after the execution of the testator's will or after
- 21 the death of the testator.
- 22 (4) Unless the testator's will provides otherwise, the property so de-
- 23 vised:
- 24 (a) Shall not be considered to be held under a testamentary trust of
- 25 the testator, but shall become a part of the trust to which it is given; and
- 26 (b) Shall be administered and disposed of in accordance with the pro-
- 27 visions of the instrument or will setting forth the terms of the trust, in-
- 28 cluding any amendments thereto made before the death of the testator,
- 29 regardless of whether made before or after the execution of the testator's
- 30 will, and, if the testator's will so provides, including any amendments to
- 31 the trust made after the death of the testator.
- 32 (5) A revocation or termination of the trust before the death of the
- 33 testator shall cause the devise to lapse.
- 34 (6) This section shall not be construed as providing an exclusive

- 1 method for making devises to the trustee or trustees of a trust established
- 2 otherwise than by the will of the testator making the devise.
- 3 (7) This section shall be so construed as to effectuate its general pur-
- 4 pose to make uniform the law of those states which enact the same or
- 5 similar provisions.
- 6 Section 41. Manner of revocation or alteration exclusive. A will may be
- 7 revoked or altered only as provided in sections 42 to 45 of this Act.
- 8 Section 42. Express revocation or alteration. (1) A will may be revoked
- 9 or altered by another will.
- 10 (2) A will may be revoked by being burned, torn, canceled, obliterated
- 11 or destroyed, with the intent and purpose of the testator of revoking the
- 12 will, by the testator, or by another person at the direction of the testator
- 13 and in the presence of the testator. The injury or destruction by a person
- 14 other than the testator at the direction and in the presence of the testator
- 15 shall be proved by a least two witnesses.
- 16 Section 43. Revival of revoked or invalid will. If a will or a part thereof
- 17 has been revoked or is invalid, it can be revived only by a re-execution
- 18 of the will or by the execution of another will in which the revoked or
- 19 invalid will or part thereof is incorporated by reference.
- Section 44. Revocation by marriage. A will is revoked by the sub-
- 21 sequent marriage of the testator if the testator is survived by his spouse,
- 22 unless:
- 23 (1) The will evidences an intent that it not be revoked by the sub-
- 24 sequent marriage or was drafted under circumstances establishing that it
- 25 was in contemplation of the marriage; or
- 26 (2) The testator and his spouse entered into a written contract before
- 27 the marriage that either makes provision for the spouse or provides that the
- 28 spouse is to have no rights in the estate of the testator.
- Section 45. Revocation by divorce or annulment. Unless a will evidences
- 30 a different intent of the testator, the divorce or annulment of the marriage
- 81 of the testator after the execution of the will revokes all provisions in
- 32 the will in favor of the former spouse of the testator and any provision
- 33 therein naming the former spouse as executor, and the effect of the will
- 84 is the same as though the former spouse did not survive the testator.

- 1 Section 46. Contract of sale of property devised not a revocation. An
- 2 executory contract of sale made by a testator to convey property devised
- 3 in a will previously made, is not a revocation of the previous devise, either
- 4 in law or equity; but the property shall pass by the devise, subject to the
- 5 same remedies on the agreement, for specific performance or otherwise,
- 6 against devisees as might be had against the heirs of the testator if the
- 7 property had descended to them.
- 8 Section 47. Encumbrance or disposition of property after making will.
- 9 An encumbrance or disposition of property by a testator after he makes
- 10 his will does not affect the operation of the will upon a remaining interest
- 11 therein that is subject to the disposal of the testator at the time of his
- 12 death.
- Section 48. Devise of life estate. A devise of property to any person for
- 14 the term of the life of the person, and after his death to his children or
- 15 heirs, vests an estate or interest for life only in the devisee and remainder
- 16 in the children or heirs.
- Section 49. Devise passes all interest of testator. A devise of property
- 18 passes all of the interest of the testator therein at the time of his death,
- 19 unless the will evidences the intent of the testator to devise a lesser interest.
- Section 50. Property acquired after making will. Any property acquired
- 21 by the testator after the making of his will passes thereby, and in like
- 22 manner as if title thereto were vested in him at the time of making the
- 28 will, unless the intent expressed in the will is clear and explicit to the
- 24 contrary.
- Section 51. Effect of direction to pay debts, charges, taxes or adminis-
- 26 tration expenses. A mere testamentary direction to pay debts, charges,
- 27 taxes or expenses of administration shall not be considered a direction for
- 28 exoneration from encumbrances or against apportionment of estate taxes.
- Section 52. Non-ademption of specific devises in certain cases. (1) In
- 30 the situations and under the circumstances provided in and governed by
- 31 this section, specific devises will not fail or be extinguished by the destruc-
- 32 tion, damage, sale, condemnation or change in form of the property
- 33 specifically devised. This section is inapplicable if the intent that the
- 34 devise fail under the particular circumstances appears in the will or if

- 1 the testator during his lifetime gives property to the specific devisee with
- 2 the intent of satisfying the specific devise.
- 3 (2) Whenever the subject of a specific devise is property only part
- 4 of which is destroyed, damaged, sold or condemned, the specific devise
- 5 of any remaining interest in the property owned by the testator at the
- 6 time of his death is not affected by this section; but this section applies to
- 7 the part which would have been adeemed under the common law by the
- 8 destruction, damage, sale or condemnation.
- 9 (3) If insured property that is the subject of a specific devise is
- 10 destroyed or damaged, the specific devisee has the right to receive, reduced
- 11 by any amount expended or incurred by the testator in restoration or repair
- 12 of the property:
- 13 (a) Any insurance proceeds paid to the personal representative after
- 14 the death of the testator, with the incidents of the specific devise; and
- 15 (b) A general pecuniary legacy equivalent to any insurance proceeds
- 16 paid to the testator within six months before his death.
- 17 (4) If property that is the subject of a specific devise is sold by the
- 18 testator, the specific devisee has the right to receive:
- 19 (a) Any balance of the purchase price unpaid at the time of the
- 20 death of the testator, including any security interest in the property and
- 21 interest accruing before the death, if part of the estate, with the incidents
- ²² of the specific devise; and
- 23 (b) A general pecuniary legacy equivalent to the amount of the pur-
- 24 chase price paid to the testator within six months before his death. Ac-
- 25 ceptance of a promissory note of the purchaser or a third party is not
- 26 considered payment, but payment on the note is payment on the purchase
- 27 price. Sale by an agent of the testator or by a trustee under a revocable
- 28 living trust created by the testator, the principal of which is to be paid
- 29 to the personal representative or estate of the testator on his death, is a
- 30 sale by the testator for purposes of this section.
- 31 (5) If property that is the subject of a specific devise is taken by
- 32 condemnation before the death of the testator, the specific devisee has
- 33 the right to receive:

- 1 (a) Any amount of the condemnation award unpaid at the time of 2 the death, with the incidents of the specific devise; and
- 3 (b) A general pecuniary legacy equivalent to the amount of an award
- 4 paid to the testator within six months before his death. In the event of an
- 5 appeal in a condemnation proceeding, the award, for purposes of this
- 6 section, is limited to the amount established on the appeal.
- 7 (6) If property that is the subject of a specific devise is sold by a
- 8 guardian or conservator of the testator, or insurance proceeds or a con-
- 9 demnation award are paid to a guardian or conservator of the testator,
- 10 the specific devisee has the right to receive a general pecuniary legacy
- 11 equivalent to the proceeds of the sale, the insurance proceeds or the con-
- 12 demnation award, reduced by any amount expended or incurred in res-
- 13 toration or repair of the property. This subsection does not apply if the
- 14 testator, after the sale, receipt of insurance proceeds or award, is adju-
- 15 dicated competent and survives such adjudication by six months.
- 16 (7) If securities are specifically devised, and after the execution of the
- 17 will other securities in the same or another entity are distributed to the
- 18 testator by reason of his ownership of the specifically devised securities
- 19 and as a result of a partial liquidation, stock dividend, stock split, merger,
- 20 consolidation, reorganization, recapitalization, redemption, exchange or
- 21 any other similar transaction, and if the other securities are part of the
- 22 estate of the testator at his death, the specific devise is considered to in-
- 23 clude the additional or substituted securities. As used in this subsection,
- 24 "securities" means the same as defined in subsection (11) of ORS 59.015.
- 25 (8) The amount a specific devisee receives as provided in this section
- 26 is reduced by any expenses of the sale or of collection of proceeds of in-
- 27 surance, sale or condemnation award and by any amount by which the
- 28 income tax of the decedent or his estate is increased by reason of items
- 29 provided for in this section. Expenses include legal fees paid or incurred.
- Section 53. When estate passes to issue of devisee; anti-lapse. When
- 31 property is devised to any person who is related by blood or adoption to
- 32 the testator and who dies before the testator leaving lineal descendants,
- 33 the descendants take by representation the property the devisee would

- 1 have taken if he had survived the testator, unless otherwise provided in
- 2 the will of the testator.
- 3 Section 54. Children born or adopted after execution of will; pretermit-
- 4 ted children. (1) As used in this section, "pretermitted child" means a
- 5 child of a testator who is born or adopted after the execution of the will
- 6 of the testator, who is neither provided for in the will nor in any way
- 7 mentioned in the will and who survives the testator.
- 8 (2) If a testator has one or more children living when he executes
- 9 his will and no provision is made in the will for any such living child, a
- 10 pretermitted child shall not take a share of the estate of the testator
- 11 disposed of by the will.
- 12 (3) If a testator has one or more children living when he executes his
- 18 will and provision is made in the will for one or more of such living
- 14 children, a pretermitted child is entitled to share in the estate of the
- 15 testator disposed of by the will as follows:
- 16 (a) The pretermitted child may share only in the portion of the estate
- 17 devised to the living children by the will.
- 18 (b) The share of each pretermitted child shall be the total value of the
- 19 portion of the estate devised to the living children by the will divided by
- 20 the number of pretermitted children plus the number of living children for
- 21 whom provision, other than nominal provision, is made in the will.
- (c) To the extent feasible, the interest of a pretermitted child in the
- 23 estate shall be of the same character, whether equitable or legal, as the
- 24 interest the testator gave to the living children by the will.
- 25 (4) If a testator has no child living when he executes his will, a preter-
- 36 mitted child shall take a share of the estate as though the testator had died
- 27 intestate.
- 28 (5) A pretermitted child may recover the share of the estate to which
- 29 he is entitled, as provided in this section, either from the other children
- 30 under subsection (3) of this section or from the testamentary beneficiaries
- 31 under subsection (4) of this section, ratably, out of the portions of the estate
- 32 passing to those persons under the will. In abating the interests of those
- 88 beneficiaries, the character of the testamentary plan adopted by the testator
- 34 shall be preserved so far as possible.

- Section 55. Persons not entitled to estate of testator. Except as other-
- 2 wise expressly provided by law, a person, including a child of the testator
- 8 and a descendant of that child, shall not take or be entitled to take any
- 4 portion of the estate of a testator disposed of by his will other than as
- 5 provided in the will.
- Section 56. Delivery of will by custodian; liability. (1) A person having
- 7 custody of a will, other than an executor named therein, shall deliver the
- 8 will, within 30 days after the date of receiving information that the testator
- 9 is dead, to a court having jurisdiction of the estate of the testator or to an
- 10 executor named in the will.
- 11 (2) If it appears to a court having jurisdiction of the estate of a dece-
- 12 dent that a person has custody of a will made by the decedent, the court
- 13 may issue an order requiring that person to deliver the will to the court.
- 14 (3) A person having custody of a will who fails to deliver the will as
- 15 provided in this section is liable to any person injured by that failure for
- 16 damages sustained thereby.
- 17 Section 57. Disposition of wills deposited with county clerk. So far as
- 18 he is able, the county clerk of each county shall deliver to the testator, or
- 19 to the person to whom the will is to be delivered after the death of the
- 20 testator, each will deposited in his office for safekeeping pursuant to ORS
- 21 114.410. Any will he has been unable to so deliver before January 1, 2010,
- 22 may be destroyed by the county clerk.
- 28 Part 5. Effect of Homicide on Intestate Succession, Wills, Joint Assets,

- Section 58. Definitions. As used in sections 58 to 68 of this Act:
- 26 (1) "Decedent" means a person whose life is taken by a slayer.

- 29 Section 59. Slayer considered to predecease decedent. Property that
- **80** would have passed from the decedent or his estate to the slayer by intestate
- 81 succession, by will or by trust shall pass and be vested as if the slayer had
- 32 predeceased the decedent.
- Section 60. Property owned by slayer and decedent. If the slayer and
- **34** the decedent owned property as tenants by the entirety or with a right of

- 1 survivorship, upon the death of the decedent an undivided one-half interest
- 2 shall remain in the slayer for his lifetime and, subject thereto, the property
- 3 shall pass to and be vested in the heirs or devisees of the decedent other
- 4 than the slayer.
- 5 Section 61. Property owned by slayer, decedent and others. If the
- 6 slayer, the decedent and another or others owned property with a right of
- 7 survivorship, upon the death of the decedent the interest of the slayer shall
- 8 remain as an undivided interest in the slayer for his lifetime and, subject
- 9 thereto, the property shall pass to and be vested in the other surviving
- 10 owner or owners.
- 11 Section 62. Reversions, vested remainders, contingent remainders and

- 12 (1) A policy or certificate of insurance on the life of the decedent.
- 13 (2) A certificate of membership in any benevolent association or organi-

- 15 (3) Rights of the decedent as survivor of a joint life policy.
- 16 (4) Proceeds under any pension, profit-sharing or other plan.
- Section 65. Proceeds of insurance on life of slayer. If the decedent is
- 18 beneficiary or assignee of any policy or certificate of insurance on the life
- 19 of the slayer, the proceeds shall be paid to the personal representative of
- 20 the decedent's estate unless:
- (1) The policy or certificate names some person other than the slayer or
- 22 his personal representative as the secondary beneficiary.
- 23 (2) The slayer, by naming a new beneficiary or assignee, performs an
- 24 act which would have deprived the decedent of his interest if the decedent
- 25 had been living.
- Section 66. Payment by insurance company, bank, trustee or obligor;
- 27 no additional liability. Any insurance company making payment according
- 28 to the terms of its policy, or any bank, trustee or other person performing
- 29 an obligation to the slayer shall not be subjected to additional liability
- 80 because of sections 58 to 68 of this Act if the payment or performance is
- 31 made without written notice by a claimant of a claim arising under those
- 32 sections. Upon receipt of written notice the person to whom it is directed
- 38 may withhold any disposition of the property pending determination of his

- 1 Section 67. Rights of persons without notice dealing with slayer. Sec-

- 16 Where the title to property or the devolution thereof depends upon pri-
- 17 ority of death and there is no sufficient evidence that the persons have
- 18 died otherwise than simultaneously, the property of each person shall be
- 19 disposed of as if he had survived, except as provided otherwise in [this
- 20 chapter] sections 69 to 76 of this 1969 Act.
- Section 70. ORS 112.020 is amended to read:
- 22 112.020. Beneficiaries designated to take successively, [Where two or
- 23 more beneficiaries are designated to take successively by reason of survivorship
- 24 under another person's disposition of property and there is no sufficient evi-
- 25 dence that these beneficiaries have died otherwise than simultaneously, the
- 26 property thus disposed of shall be divided into as many equal portions as there
- 27 are successive beneficiaries and these portions shall be distributed respectively
- 28 to those who would have taken in the event that each designated beneficiary
- 29 had survived.] If property is so disposed of that the right of a beneficiary

9 ARTICLE IV. ADMINISTRATION OF ESTATES GENERALLY

Part 1. Support of Spouse and Children

- Section 103. Occupancy of family abode by spouse and children. The

- 13 to occupy the principal place of abode of the decedent until one year after
- 14 his death or, if his estate therein is an estate of leasehold or an estate for

- 25 (3) The occupants shall pay taxes and improvement liens on the
- 26 abode as payment thereof becomes due.
- 27 (4) The abode is exempt from execution to the extent that it was
- 28 exempt when the decedent was living.
- 29 Section 104. Support of spouse and children. The court by order shall
- 30 make necessary and reasonable provision from the estate of a decedent
- 31 for the support of the spouse and dependent children of the decedent, or
- 32 any of them, upon:
- 33 (1) Petition therefor by or on behalf of the spouse or any dependent
- 34 child;

- 1 (2) Service of the petition and notice of hearing thereon to the per-
- 2 sonal representative, unless the petititoner is the personal representative;
- 3 (3) Notice to persons whose distributive shares of the estate may be
- 4 diminished by the granting of the petition, unless the court by order
- 5 directs otherwise; and
- 6 (4) Hearing.
- 7 Section 105. Petition for support and answer. (1) The petition for sup-
- 8 port under section 104 of this Act shall include a description of property,
- 9 other than property of the estate, available for the support of the spouse
- 10 and children, and an estimate of the expenses anticipated for their sup-
- 11 port. If the petitioner is the personal representative, the petition shall also
- 12 include, so far as known, a statement of the nature and estimated value
- 13 of the property of the estate and of the nature and estimated amount of
- 14 claims, taxes and expenses of administration.
- 15 (2) If the personal representative is not the petitioner, he shall answer
- 16 the petition for support. The answer shall include, so far as known, a
- 17 statement of the nature and estimated value of the property of the estate
- 18 and of the nature and estimated amount of claims, taxes and expenses
- 19 of administration.
- Section 106. Temporary support. Pending hearing upon the petition
- 21 under section 104 of this Act, temporary support may be allowed by
- 22 order of the court in an amount and of a nature the court considers reason-
- 23 ably necessary for the welfare of the surviving spouse and dependent
- 24 children of the decedent or any of them.
- Section 107. Modification or termination of support. Provision for sup-
- 26 port under section 104 of this Act ordered by the court may be modified
- 27 or terminated by the court by further order.
- Section 108. Nature of support. (1) Provision for support under section
- 29 104 of this Act ordered by the court may consist of any one or more of
- 80 the following:
- 31 (a) Transfer of title to personal property.
- 32 (b) Transfer of title to real property.
- 33 (c) Periodic payment of moneys during administration of the estate,

- 1 but the payments may not continue for more than two years after the

- 12 than one year after the date of death of the decedent.
- Section 110. Priority of support; treated as administration expense.
- 14 Subject to the limitations imposed by section 109 of this Act, provision for
- 15 support under section 104 of this Act ordered by the court has priority
- 16 over claims and expenses of administration. The provision shall not be
- 17 charged against the distributive share of the person receiving support,
- 18 The provision shall be treated as an expense of administration, but shall
- 19 not be a deduction for inheritance tax purposes.
- 20 Section 111. Setting apart whole estate for support; termination of
- 21 administration. If it appears, after the expiration of four months after the
- 22 date of the first publication of notice to interested persons, that reasonable
- 28 provision for support of the spouse and dependent children of the de-
- 24 cedent, or any of them, warrants that the whole of the estate, after payment
- 25 of claims, taxes and expenses of administration, be set apart for such
- 26 support, the court may so order. There shall be no further proceeding in
- 27 the administration of the estate, and the estate shall summarily be closed.
- 28 Part 2. Elective Share of Surviving Spouse
- Section 112. Right to elective share; effect of election, (1) If a decedent
- 30 is domiciled in this state at the time of his death and dies testate, the sur-
- 31 viving spouse of the decedent has a right to elect to take the share provided
- 32 by this section. The elective share consists of one-fourth of the value of
- 38 the net estate of the decedent, but the elective share shall be reduced by

- 1 the value of the following property given to the surviving spouse under the
- 2 will of the decedent:
- 3 (a) Property given outright;
- 4 (b) The present value of legal life estates; and
- (c) The present value of the right of the surviving spouse to income
- 6 or an annuity, or a right of withdrawal, from any property transferred
- 7 in trust by the will that is capable of valuation with reasonable certainty
- 8 without regard to the powers forfeited under subsection (2) of this section.
- 9 (2) Except as to property applied under subsection (1) of this section to
- 10 reduce the elective share, an election to take under this section forfeits
- 11 any other right to take under the will and under the law of intestate suc-
- 12 cession. If the will would otherwise create a power of appointment in the
- 13 surviving spouse, the spouse by electing to take under this section retains
- 14 the power only if it is not a general power of appointment as defined in
- 15 subsection (5) of ORS 118.010 and the testator has not provided otherwise,
- 16 but the spouse forfeits any general power of appointment. A power to pay
- 17 more than the income or annuity or withdrawals, the value of which
- 18 reduced the elective share under paragraph (c) of subsection (1) of this
- 19 section, or to apply additional principal or income in behalf of the electing
- 20 spouse, may not be exercised in favor of the electing spouse.
- 21 (3) The right to elect may be barred under section 113 of this Act, the
- 22 share limited by section 114 of this Act or the right denied or the share
- 23 reduced under section 115 of this Act.
- 24 Section 113. Election barred by agreement. The right of the surviving
- 25 spouse to elect under section 112 of this Act may be barred by the terms of
- 26 a written agreement signed by both spouses. The agreement may be entered
- 27 into before or after marriage.
- Section 114. Elective share limited by total property received. (1) The
- 29 surviving spouse may not receive by election under section 112 of this Act
- 30 any amount which, together with any of the following property received
- 31 by him, exceeds one-half of the total of the following property, such
- 32 property to be reduced by the amount of the federal estate tax payable
- 33 by reason of the property:
- 34 (a) The property passing under the will;

- 1 (b) Joint annuities furnished by the decedent;
- 2 (c) Proceeds of insurance on the life of the decedent, whether or not he
- 3 had any of the incidents of ownership at his death;
- 4 (d) Transfers by the decedent within three years before the date of his
- 5 death, to the extent the decedent did not receive full consideration in
- 6 money or money's worth;
- 7 (e) Transfers by the decedent during his lifetime as to which he
- 8 retained power, alone or in conjunction with any other person, to alter,
- 9 amend, revoke or terminate or to designate a beneficiary;
- 10 (f) Payments from the employer of the decedent or from a plan
- 11 created by the employer or under a contract between the decedent and his
- 12 employer, excluding workmen's compensation and social security payments;
- (g) Property appointed by the decedent by will or by deed executed
- 14 within three years before the date of his death, whether the power is
- 15 general or special, but only if the property is effectively appointed in favor
- 16 of the surviving spouse; and
- (h) Property in the joint names of the decedent and one or more other
- 18 persons, except such proportion as is attributable to consideration furnished
- 19 by persons other than the decedent.
- 20 (2) For the purpose of subsection (1) of this section, the surviving
- 21 spouse is considered to receive:
- (a) Any property as to which the spouse is given all the income and a
- 23 general power to appoint the principal.
- 24 (b) Life insurance proceeds settled by the decedent on option, if the
- 25 spouse is entitled to the interest and has a general power to appoint the
- 26 proceeds or to withdraw proceeds, or if the spouse is entitled to an annuity
- 27 for life or instalments of the entire principal and interest for any period
- 28 equal to or less than the normal life expectancy of the spouse.
- 29 (3) As used in subsection (1) of this section, "property in the joint
- 30 names" means all property held or owned under any form of ownership
- 31 with right of survivorship, including cotenancy with remainder to the
- 32 survivor; stocks, bonds or bank accounts in the name of two or more persons
- 33 payable to the survivor; United States Government bonds in co-ownership
- 34 form or payable on death to a designated person; and shares in credit unions

- or savings and loan associations payable on death to a designated person or
 in joint form.
- 3 Section 115. Denial of election or share reduction when decedent and
- 4 surviving spouse living apart. If the decedent and the surviving spouse
- 5 were living apart at the time of the death of the decedent, whether or not
- 6 there was a decree for legal separation, the court in its discretion may deny
- 7 any right to elect against the will, may reduce the elective share of the
- 8 spouse to such amount as the court determines reasonable and proper or
- 9 may grant the full elective share in accordance with the circumstances
- 10 of the particular case. The court, in deciding what elective share, if any,
- 11 should be granted, shall consider the length of the marriage, whether the
- 12 marriage was a first or subsequent marriage for either or both of the
- 13 spouses, the contribution of the surviving spouse to the property of the
- 14 decedent in the form of services or transfers of property, the length and
- 15 cause of the separation and any other relevant circumstances.
- Section 116. What constitutes election. The surviving spouse is con-
- 17 sidered to have elected to take under the will unless, within 90 days after
- 18 the date of the admission of the will to probate or 30 days after the date of
- 19 the filing of the inventory, whichever is later, he serves on the personal
- 20 representative or his attorney and files in the estate proceeding a statement
- 21 that he elects to take under section 112 of this Act instead of under the will.
- 22 The surviving spouse may bar any right to take under section 112 of this
- 23 Act by filing in the estate proceeding a writing, signed by the spouse, elect-
- 24 ing to take under the will.
- Section 117. Election by guardian of surviving spouse. An election
- 26 under section 112 of this Act may be filed on behalf of an incompetent sur-
- 27 viving spouse by a guardian of the spouse. A guardian may elect against
- 28 the will only if additional assets are needed for the reasonable support
- 29 of the surviving spouse, taking into account the probable needs of the
- 30 spouse, the provisions of the will, any nonprobate property arrangements
- 31 made by the decedent for the support of the spouse and any other assets,
- 32 whether or not owned by the spouse, available for such support. The
- 33 election is subject to the approval of the court, with or without notice to
- 34 other interested persons.

- 1 Section 118. Payment of elective share. Estate property shall be ap-
- 2 plied in satisfaction of the elective share in the following order, unless
- 3 the will provides otherwise:
- 4 (1) Any intestate property;
- 5 (2) After the intestate property is exhausted, each devisee shall con-
- 6 tribute ratably to the elective share out of the portion of the estate passing
- 7 to him under the will, except that in abating the interests of the devisees
- 8 the character of the testamentary plan adopted by the testator shall be
- 9 preserved so far as possible.

Part 3. Title and Possession of Property

- Section 119. No distinction between real and personal property. Sec-
- 12 tions 1 to 212 of this Act apply without distinction between real and per-
- 13 sonal property.
- Section 120. Devolution of and title to property. (1) Upon the death
- 15 of a decedent, title to his property vests:
- 16 (a) In the absence of testamentary disposition, in his heirs, subject to
- 17 support of spouse and children, rights of creditors, administration and sale
- 18 by the personal representative; or
- (b) In the persons to whom it is devised by his will, subject to support
- 20 of spouse and children, rights of creditors, right of the surviving spouse
- 21 to elect against the will, administration and sale by the personal repre-
- 22 sentative.
- 23 (2) The power of a person to leave property by will, and the rights
- 24 of creditors, devisees and heirs to his property, are subject to the restric-
- 25 tions and limitations expressed or implicit in sections 1 to 212 of this Act
- 26 to facilitate the prompt settlement of estates.
- 27 Section 121. Possession and control of decedent's estate. A personal
- 28 representative has a right to and shall take possession and control of the
- 29 estate of the decedent, but he is not required to take possession of or be
- 30 accountable for property in the possession of an heir or devisee unless in
- 31 his opinion possession by the personal representative is reasonably re-
- 32 quired for purposes of administration.
- Part 4. Duties and Powers of Personal Representatives
- 34 Section 122. Commencement of duties and powers of personal repre-

- 1 sentative; prior acts. The duties and powers of a personal representative
- 2 commence upon the issuance of his letters. The powers of a personal
- 3 representative relate back in time to give his acts occurring prior to ap-
- 4 pointment the same effect as those occurring thereafter. A personal repre-
- 5 sentative may ratify and accept acts on behalf of the estate done by others
- 6 where those acts would have been proper for a personal representative.
- 7 Section 123. General duties of personal representative. A personal rep-
- 8 resentative is a fiduciary who is under a general duty to and shall collect
- 9 the income from property of the estate in his possession and preserve,
- 10 settle and distribute the estate in accordance with the terms of the will
- 11 and sections 1 to 212 of this Act, as expeditiously and with as little sacri-
- 12 fice of value as is reasonable under the circumstances.
- 13 Section 124. Personal representative to proceed without court order;
- 14 application for authority, approval or instructions. A personal represent-
- 15 ative shall proceed with the administration, settlement and distribution
- 16 of the estate without adjudication, order or direction of the court, except
- 17 as otherwise provided in sections 1 to 212 of this Act. However, a personal
- 18 representative or any interested person may apply to the court for au-
- 19 thority, approval or instructions on any matter concerning the admin-
- 20 istration, settlement or distribution of the estate, and the court, without
- 21 hearing or upon such hearing as it may prescribe, shall instruct the per-
- 22 sonal representative or rule on the matter as may be appropriate.
- 23 Section 125. Naming or appointment of personal representative does
- 24 not discharge claim against him. The naming or appointment of any person
- 25 as personal representative does not discharge any claim which the decedent
- 26 had against that person. The claim shall be included in the inventory. If
- 27 the person agrees to act as personal representative, he is liable for the
- 28 claim as for so much money in his hands at the time the claim becomes
- 29 due and payable; otherwise he is liable for the claim as any other debtor
- 30 of the decedent.
- Section 126. Discharge or devise in will of claim of testator. The dis-
- 32 charge or devise in a will of a claim of the testator against a personal repre-
- 33 sentative or against any other person is of no effect as against creditors of
- 34 the decedent. The claim shall be included in the inventory and for purposes

- 1 of administration shall be regarded and treated as a specific devise of the
- 2 amount of the claim.
- 3 Section 127. Transactions authorized for personal representative. Ex-
- 4 cept as restricted or otherwise provided by the will or by court order, a
- 5 personal representative, acting reasonably for the benefit of interested
- 6 persons, is authorized to:
- 7 (1) Direct and authorize disposition of the remains of the decedent
- 8 pursuant to ORS 97.130 and incur expenses for the funeral, burial or other
- 9 disposition of the remains in a manner suitable to the condition in life of
- 10 decedent. Only those funeral expenses necessary for a plain and decent
- 11 funeral and disposition of the remains of the decedent may be paid from
- 12 the estate if the assets are insufficient to pay the claims of the State Public
- 13 Welfare Commission and the Oregon State Board of Control.
- 14 (2) Retain assets owned by the decedent pending distribution or
- 15 liquidation.
- 16 (3) Receive assets from fiduciaries or other sources.
- 17 (4) Complete, compromise or refuse performance of contracts of the
- 18 decedent that continue as obligations of the estate, as he may determine
- 19 under the circumstances. In performing enforceable contracts by the
- 20 decedent to convey or lease real property, the personal representative,
- 21 among other courses of action, may:
- 22 (a) Execute and deliver a deed upon satisfaction of any sum remaining
- 23 unpaid or upon receipt of the note of the purchaser adequately secured; or
- (b) Deliver a deed in escrow with directions that the proceeds, when
- 25 paid in accordance with the escrow agreement, be paid to the successors
- 26 of the decedent, as designated in the escrow agreement.
- 27 (5) Satisfy written pledges of the decedent for contributions, whether
- 28 or not the pledges constituted binding obligations of the decedent or were
- 29 properly presented as claims.
- 30 (6) Deposit funds not needed to meet currently payable debts and
- 31 expenses, and not immediately distributable, in bank or savings and loan
- 32 association accounts, or invest the funds in short-term United States Gov-
- 33 ernment obligations.

- 1 (7) Abandon burdensome property when it is valueless, or is so encum-
- 2 bered or is in a condition that it is of no benefit to the estate.
- 3 (8) Vote stocks or other securities in person or by general or limited 4 proxy.
- 5 (9) Pay calls, assessments and other sums chargeable or accruing
- 6 against or on account of securities.
- 7 (10) Sell or exercise stock subscription or conversion rights.
- 8 (11) Consent, directly or through a committee or other agent, to the
- 9 reorganization, consolidation, merger, dissolution or liquidation of a cor-
- 10 poration or other business enterprise.
- 11 (12) Hold a security in the name of a nominee or in other form without
- 12 disclosure of the interest of the estate, but the personal representative is
- 13 liable for any act of the nominee in connection with the security so held.
- 14 (13) Insure the assets of the estate against damage and loss, and insure
- 15 himself against liability to third persons.
- 16 (14) Advance or borrow money with or without security.
- 17 (15) Compromise, extend, renew or otherwise modify an obligation
- 18 owing to the estate. If the personal representative holds a mortgage,
- 19 pledge, lien or other security interest, he may accept a conveyance or
- 20 transfer of the encumbered asset in lieu of foreclosure in full or partial
- 21 satisfaction of the indebtedness.
- 22 (16) Accept other real property in part payment of the purchase price
- 23 of real property sold by him.
- 24 (17) Pay taxes, assessments and expenses incident to the administration
- 25 of the estate.
- 26 (18) Employ qualified persons, including attorneys, accountants and
- 27 investment advisers, to advise and assist the personal representative and
- 28 to perform acts of administration, whether or not discretionary, on behalf
- 29 of the personal representative.
- 30 (19) Prosecute or defend actions, claims or proceedings in any jurisdic-
- 31 tion for the protection of the estate and of the personal representative in
- 32 the performance of his duties.
- 33 (20) Continue any business or venture in which the decedent was

- 1 engaged at the time of his death to preserve the value of the business or
- 2 venture.
- 3 (21) Incorporate or otherwise change the business form of any business
- 4 or venture in which the decedent was engaged at the time of his death.
- 5 (22) Discontinue and wind up any business or venture in which the
- 6 decedent was engaged at the time of his death.
- 7 (23) Provide for exoneration of the personal representative from per-
- **8** sonal liability in any contract entered into on behalf of the estate.
- 9 (24) Satisfy and settle claims and distribute the estate as provided in
- 10 sections 1 to 212 of this Act.
- 11 (25) Perform all other acts required or permitted by law or by the will
- 12 of the decedent.
- Section 128. Right to perfect lien or security interest. A personal rep-
- 14 resentative has the same rights to perfect a lien or security interest as the
- 15 decedent would have had if he were living.
- Section 129. Power to sell, mortgage, lease and deal with property. (1)
- 17 A personal representative has power to sell, mortgage, lease or otherwise
- 18 deal with property of the estate without notice, hearing or court order.
- 19 (2) Exercise of the power of sale by the personal representative is
- 20 improper, except after notice, hearing and order of the court, if:
- (a) The sale is in contravention of the provisions of the will; or
- (b) The property is specifically devised and the will does not authorize
- 23 its sale; or
- (c) A bond of the personal representative has been required and filed,
- $_{25}$ the sale price of the property to be sold exceeds \$5,000 and the bond of the
- 26 personal representative has not been increased by the amount of cash to be
- 27 realized on the sale, unless the court has directed otherwise.
- 28 Section 130. Court order for sale, mortgage or lease. Upon proof satis-
- 29 factory to the court by an interested person that a sale, mortgage or lease
- 30 of property of the estate is required for paying support of spouse and
- 31 children, elective share of surviving spouse, claims or expenses of adminis-
- 32 tration, or for distribution, and that the personal representative has failed
- 33 or declined to act, the court may order the personal representative to make
- 34 the sale, mortgage or lease.

- Section 131. Title conveyed free of claims of creditors. Property sold,
- ² mortgaged or leased by a personal representative is subject to liens and
- 3 encumbrances against the decedent or his estate, but is not subject to rights
- 4 of creditors of the decedent or liens or encumbrances against his heirs
- ⁵ or devisees. The filing and allowance of a claim in an estate proceeding
- 6 does not make the claimant a secured creditor.
- Section 132. Sale or encumbrance to personal representative voidable;
- exceptions. (1) Any sale or encumbrance to the personal representative,
- ⁹ his spouse, agent or attorney, or any corporation or trust in which he has
- ¹⁰ more than a one-third beneficial interest, is voidable unless:
- (a) The transaction was consented to by all interested persons affected
- ¹² thereby; or
- 13 (b) The will expressly authorizes the transaction by the personal rep-
- 14 resentative with himself; or
- 15 (c) The transaction was made in compliance with another statute or
- 16 with a contract or other instrument executed by the decedent.
- 17 (2) The title of a purchaser for value without notice of the circum-
- 18 stances of the transaction with the personal representative is not affected
- 19 unless the purchaser should have known of the defect in the title of his
- 20 seller.
- Section 133. ORS 116.835 is amended to read:
- 116.835. Validation of certain sales. The following are the subject of
- 23 validating Acts [applicable to this chapter]:
- 24 (1) Certain sales of decedent's real property made prior to 1903 where
- 25 confirmation of sale was premature, validated by page 133, section 2, Gen-
- 26 eral Laws of Oregon 1903.
- 27 (2) Certain sales of decedent's property made prior to 1907 under
- 28 power in will, validated by chapter 175, General Laws of Oregon 1907.
- 29 (3) Certain sales of decedent's real property made prior to 1917 where
- 30 publication of the notice of sale was improper, validated by section 2,
- 31 chapter 114, General Laws of Oregon 1917.
- 32 (4) Certain sales by executors or administrators made prior to 1943,

- 34 Section 134. Nonliability of transfer agents. A transfer agent or a

- 1 corporation transferring its own securities incurs no liability to any per-
- 2 son by making a transfer of securities of an estate as requested or di-
- 3 rected by a personal representative.
- 4 Section 135. Persons dealing with personal representative; protection.
- 5 A person dealing with or assisting a personal representative without actual
- 6 knowledge that the personal representative is improperly exercising his
- 7 power is protected as if the personal representative properly exercised
- 8 the power. The person is not bound to inquire whether the personal repre-
- 9 sentative is properly exercising his power, and is not bound to inquire
- 10 concerning the provisions of any will or any order of court that may affect
- 11 the propriety of the acts of the personal representative. No provision in
- 12 any will or order of court purporting to limit the power of a personal rep-
- 13 resentative is effective except as to persons with actual knowledge thereof.
- 14 A person is not bound to see to the proper application of estate assets

- 25 of an express trust. Exercise of power in violation of a court order is a
- 26 breach of duty. Exercise of power contrary to the provisions of the will
- 27 may be a breach of duty.
- Section 137. Personal liability of personal representative. (1) The per-
- 29 sonal liability of a personal representative to third parties, as distinguished
- 30 from his fiduciary accountability to the estate, arising from the administra-
- 31 tion of the estate is that of an agent for a disclosed principal.
- 32 (2) A personal representative is not personally liable on contracts
- 33 properly entered into in his fiduciary capacity in the course of administra-

- 1 (3) A personal representative is not personally liable for obligations
- 2 arising from possession or control of property of the estate or for torts

- (4) Claims based upon contracts, obligations and torts of the types
- 6 described in subsections (2) and (3) of this section may be allowed against
- 7 the estate whether or not the personal representative is personally liable

- 9 Section 138. Co-personal representatives; when joint action required.
- 10 (1) When two or more persons are appointed co-personal representatives,
- 11 the concurrence of all is required for all acts connected with the adminis-
- 12 tration and distribution of the estate, except:
- 13 (a) Any co-personal representative may receive and receipt for property
- ¹⁴ due the estate.
- 15 (b) When the concurrence of all cannot readily be obtained in the time
- 16 reasonably available for emergency action.
- 17 (c) Where any others have delegated their power to act.
- 18 (d) Where the will provides otherwise.
- 19 (e) Where the court otherwise directs.
- 20 (2) Persons dealing with a co-personal representative who are actually
- 21 unaware that another has been appointed to serve with him are as fully
- 22 protected as if the person with whom they dealt had been the sole personal
- 23 representative.
- Section 139. Discovery of property, writings and information. (1) The
- 25 court may order any person to appear and give testimony as provided in
- 26 ORS chapter 45 if it appears probable:
- 27 (a) That he has concealed, secreted or disposed of any property of the
- 28 estate of a decedent;
- (b) That he has been intrusted with property of the estate of a decedent
- 30 and fails to account therefor to the personal representative.

The right to recover that property so far as necessary for the payment of those expenses, claims and taxes is in the personal representative, who shall take necessary steps to recover it. 17 Part 1. Claims Against Estates

15 constitutes general assets for the payment of creditors.

- Section 141. Presentation of claims; time limitations. (1) Claims against the estate of a decedent, other than claims of the personal representative as a creditor of the decedent, shall be presented to the personal representative ative.
- 22 (2) Claims presented within four months after the date of the first 23 publication of notice to interested persons shall be paid, as provided in 24 section 151 of this Act, before claims presented after the four-month 25 period.
- 26 (3) Claims not presented before the expiration of 12 months after the 27 date of the first publication of notice to interested persons, or before the 28 date the personal representative files his final account, whichever occurs 29 first, are barred from payment.
- 30 (4) If a claim is presented after the expiration of the 12-month period, 31 but before the final account is filed, the claim is not barred if the court 32 finds that the late presentment was caused by mistake, inadvertence, sur-33 prise or excusable neglect.
- Section 141a. Claims for personal injury, death or property damage

- 1 covered by insurance. A claim for injury to or death of a person or damage
- 2 to property, to the extent that the liability of the decedent therefore is
- 3 covered by insurance, is not barred by failure to present it as provided in
- 4 subsection (3) of section 141 of this Act, but payment of the claim not so
- 5 presented may be made only from the insurance proceeds. The estate of
- 6 the decedent may be reopened for the purpose of asserting the claim and
- 7 payment thereof, if allowed or established, from the insurance proceeds.
- Section 142. Form and verification of claims. Each claim presented shall:
- 10 (1) Be in writing.
- 11 (2) Describe the nature and the amount thereof, if ascertainable.
- (3) State the names and addresses of the claimant and, if any, his
 attorney.
- 14 (4) Be accompanied by the affidavit of the claimant or someone on
- ¹⁵ his behalf who has personal knowledge of the fact, stating that the amount
- ¹⁶ claimed is justly due, or if not due, when it will or may become due; that
- 17 no payments have been made which are not credited; and that there is
- 18 no just offset thereto, to the knowledge of the affiant, except as stated.
- Section 143. Waiver of presentment, defect or insufficiency. The pre-
- 20 sentment of a claim and any defect of form or insufficiency of a claim
- 21 presented may be waived by the personal representative or by the court.
- 22 Section 144. Written evidence of claim. When it appears that there is
- 23 written evidence of a claim that has been presented to the personal rep-
- 24 resentative, the claimant, upon demand by the personal representative,
- 25 shall produce the evidence or account for its nonproduction.
- Section 145. Claims on debts due. If a claim on a debt due is presented
- 27 and allowed, allowance shall be in the amount of the debt remaining
- ²⁸ unpaid on the date of allowance.
- Section 146. Claims on secured debts due. (1) A claim on a debt due
- 30 for which the creditor holds security may be presented as a claim on an
- 31 unsecured debt due, or the creditor may elect to rely entirely on the
- 32 security without presentation of the claim.
- 33 (2) If the claim is presented, it shall describe the security. If the
- 34 security is an encumbrance that is recorded, it is sufficient to describe

- 1 the encumbrance by reference to the volume, page, date and place of re-2 cording.
- 3 (3) If the claim is presented and allowed, allowance shall be in the 4 amount of the debt remaining unpaid on the date of allowance.
- 5 (4) If the creditor surrenders the security, payment shall be on the 6 basis of the amount allowed.
- 7 (5) If the creditor does not surrender the security, payment shall be 8 on the basis of:
- 9 (a) If the creditor exhausts the security before receiving payment, the 10 amount allowed, less the amount realized on exhausting the security; or
- 11 (b) If the creditor does not exhaust the security before receiving pay-12 ment or does not have the right to exhaust the security, the amount 13 allowed, less the value of the security determined by agreement or as the 14 court may order.
- 15 (6) The creditor shall not exercise remedies reserved under his security
 16 until at least 30 days after the date the claim is presented and after notice
 17 to the personal representative of his intention to exercise his remedy, but
 18 the court, on cause shown, may shorten the period.
- 19 (7) The personal representative may convey the secured property to 20 the creditor in consideration of the release of the security and satisfaction 21 or partial satisfaction of the claim.
- Section 147. Claims on debts not due. A claim on a debt not due, whether or not the creditor holds security therefor, may be presented as a claim on a debt due. If the claim is allowed, allowance shall be in an amount equal to the value of the debt on the date of allowance. The creditor, after allowance of the claim, may withdraw the claim without prejudice to his other remedies. Payment on the basis of the amount allowed discharges the debt and the security, if any, held by the creditor therefor.
 - Section 148. Claims on contingent and unliquidated debts. (1) A claim on a contingent or unliquidated debt shall be presented as any other claim.
 - 32 (2) If the debt becomes absolute or liquidated before distribution of 33 the estate, the claim shall be paid in the same manner as a claim on an 34 absolute or liquidated debt.

- 1 (3) If the debt does not become absolute or liquidated before distri-
- 2 bution of the estate, the court shall provide for payment of the claim by
- 3 any of the following methods:
- 4 (a) The creditor and personal representative may determine, by agree-
- ⁵ ment, arbitration or compromise, the value of the debt, and upon approval
- 6 thereof by the court, the claim may be allowed and paid in the same
- 7 manner as a claim on an absolute or liquidated debt.
- (b) The court may order the personal representative to make distri-
- 9 bution of the estate, but to retain sufficient funds to pay the claim if and
- 10 when the debt becomes absolute or liquidated. The estate may not be
- 11 kept open for this purpose more than two years after distribution of the
- 12 remainder of the estate. If the debt does not become absolute or liquidated
- 13 within that time, the funds retained, after payment therefrom of any
- 14 expenses accruing during that time, shall be distributed to the distributees.
- 15 (c) The court may order the personal representative to make distri-
- 16 bution of the estate as though the claim did not exist.
- 17 (d) If after distribution under paragraph (b) or (c) of this subsection
- 18 the debt becomes absolute or liquidated, the distributees are liable to the
- 19 creditor to the extent of the estate received by them. Payment of the debt
- 20 may be arranged by creating a trust, giving a mortgage, securing a bond
- 21 from a distributee or by such other method as the court may order.
- Section 149. Compromise of claims. The personal representative may
- 23 compromise a claim against the estate of a decedent.
- Section 150. Claims of personal representative. A claim of a personal
- 25 representative shall be filed with the clerk of the court within the time
- 26 required by law for presentment of claims. Upon application by the per-
- 27 sonal representative or by any interested person the claim may be con-
- 28 sidered by the court on the hearing of the final account of the personal
- 29 representative.
- Section 151. Payment of claims. Upon the expiration of four months
- 31 after the date of the first publication of notice to interested persons, the
- 32 personal representative, after making provision for support of spouse and
- 33 children ordered by the court, for expenses of administration and for claims
- 34 already presented which have not been allowed or allowance of which

- 1 has been appealed, shall proceed to pay the claims presented within four
- 2 months after the date of the first publication of notice to interested per-
- 3 sons and allowed against the estate, in the order of priority prescribed by
- 4 section 152 of this Act. After payment of those claims, claims presented
- 5 after the four-month period shall be paid in the same order.
- Section 152. Order of payment of expenses and claims. (1) If the ap-
- 7 plicable assets of the estate are insufficient to pay all expenses and claims
- 8 in full, the personal representative shall make payment in the following
- 9 order:
- 10 (a) Support of spouse and children, subject to the limitations imposed
- 11 by section 109 of this Act.
- 12 (b) Expenses of administration.
- 13 (c) Expenses of a plain and decent funeral and disposition of the
- 14 remains of the decedent.
- 15 (d) Debts and taxes with preference under federal law.
- 16 (e) Reasonable and necessary medical and hospital expenses of the last
- 17 illness of the decedent, including compensation of persons attending him.
- 18 (f) Taxes with preference under the laws of this state that are due and
- 19 payable while possession of the estate of the decedent is retained by the
- 20 personal representative.
- 21 (g) Debts owed employes of the decedent for labor performed within 90
- 22 days immediately preceding the date of death of the decedent.
- (h) The claim of the State Public Welfare Commission for the net
- 24 amount of public assistance, as defined in ORS 411.010, paid to or for the
- 25 decedent, and the claim of the Oregon State Board of Control for care and
- 26 maintenance of any decedent who was at a state institution to the extent
- 27 provided in ORS 179.610 to 179.770.
- 28 (i) All other claims against the estate.
- 29 (2) If the applicable assets of the estate are insufficient to pay in full
- 30 all expenses or claims of any one class specified in subsection (1) of this
- section, each expense or claim of that class shall be paid only in proportion
- 32 to the amount thereof.
- Section 153. Allowance and disallowance of claims. (1) A claim pre-
- sented to the personal representative shall be considered allowed as pre-

- 1 sented unless within 60 days after the date of presentment of the claim the
- 2 personal representative mails or delivers a notice of disallowance of the
- 3 claim in whole or in part to the claimant and, if any, his attorney. The
- 4 personal representative shall file in the estate proceeding the claim as
- 5 presented and a copy of the notice of disallowance.
- 6 (2) A notice of disallowance of a claim shall inform the claimant that
- 7 the claim has been disallowed in whole or in part and, to the extent dis-
- 8 allowed, will be barred unless the claimant proceeds as provided in section
- 9 154 of this Act.
- 10 (3) The personal representative may rescind his previous allowance
- 11 of an unpaid claim, if the claim was allowed because of error, misinforma-
- 12 tion or excusable neglect. Not less than 30 days before the date of the filing
- 13 of the final account the personal representative shall give notice of rescis-
- 14 sion of his previous allowance of a claim to the claimant and, if any, his
- 15 attorney in the same manner and containing the same information as a
- 16 notice of disallowance.
- 17 Section 154. Procedure by claimant on disallowance of claim. (1) If the
- 18 personal representative disallows a claim in whole or in part, the claimant,
- 19 within 30 days after the date of mailing or delivery of the notice of dis-
- 20 allowance, may either:
- 21 (a) File in the estate proceeding a request for summary determination
- 22 of the claim by the probate court, with proof of service of a copy of the
- 23 request upon the personal representative or his attorney; or
- (b) Commence a separate action against the personal representative on
- 25 the claim in any court of competent jurisdiction. The action shall proceed
- 26 and be tried as any other action.
- 27 (2) If the claimant fails to request a summary determination or fails to
- 28 commence a separate action as provided in subsection (1) of this section,
- 29 the claim, to the extent disallowed by the personal representative, is barred.
- 30 Section 155. Separate action required by personal representative. If the
- 81 claimant files a request for summary determination of the claim as pro-
- 32 vided in section 154 of this Act, the personal representative, within 30 days
- 33 after the date of service of a copy of the request upon the personal repre-
- 34 sentative or his attorney, may notify the claimant in writing that if he

- 1 desires to prove the claim he must commence a separate action against the
- 2 personal representative on the claim within 60 days after the date of
- 3 receipt of such notice. If the claimant fails to commence a separate action
- 4 within 60 days after the date of receipt of the notice, the claim, to the
- 5 extent disallowed by the personal representative, is barred.
- 6 Section 156. Summary determination procedure. In a proceeding for
- 7 summary determination by the probate court of a claim disallowed in whole
- 8 or in part by the personal representative:
- 9 (1) The personal representative shall move or plead to the claim as
- 10 though the claim were a complaint filed in an action.
- 11 (2) The court shall hear the matter without a jury, after notice to the
- 12 claimant and personal representative. Upon the hearing the court shall
- 13 determine the claim in a summary manner and shall make an order allow-
- 14 ing or disallowing the claim in whole or in part.
- 15 (3) No appeal may be taken from the order of the court made upon the
- 16 summary determination.
- 17 Section 157. Interested persons heard in summary determination or
- 18 separate action. Any interested person may be heard in a proceeding for
- 19 summary determination by the probate court of a claim, and may intervene
- ²⁰ in a separate action against the personal representative on the claim.
- Section 158. Creditor may obtain order for payment. A creditor whose
- 22 claim has been allowed or established by summary determination or
- 23 separate action, and who has not received payment within six months after
- 24 the date of the first publication of notice to interested persons, may apply
- 25 to the court for an order directing the personal representative to pay the
- 26 claim to the extent that funds of the estate are available for that payment.
- 27 Section 159. Proof for court allowance of disallowed claim. A claim
- 28 that has been disallowed by the personal representative may not be allowed

- Section 160. Waiver of statute of limitations. A claim barred by the

- Section 161. Extension of statute of limitations. If a claim is not barred
- 2 by the statute of limitations on the date of death of the decedent, the claim
- 3 is not barred by the statute of limitations thereafter until at least one year

Part 2. Discharge of Encumbrances

- 6 Section 162. Discharge of encumbrances. (1) As used in this section:
- 7 (a) "Voluntary encumbrance" means any mortgage, trust deed, security
- 8 agreement, pledge or public improvement assessment lien, or any lien
- 9 arising from labor or services performed or materials supplied or
- 10 furnished, or any combination thereof, upon or in respect of property.
- 11 (b) "Involuntary encumbrance" means any encumbrance upon prop-

- 14 death of the testator is specifically devised, the devisee takes it subject
- 15 to the encumbrance, and the personal representative is not required to
- 16 make any payment on account of the obligation secured by the encum-
- 17 brance, whether or not the testator was personally liable on the obligation
- 18 secured by the encumbrance, except as provided otherwise in the will or
- 19 in subsection (3) or (4) of this section.
- ²⁰ (3) Unless the will provides otherwise, the devisee of specifically de-
- ²¹ vised property may require that an encumbrance thereon be fully or
- ²² partially discharged out of other assets of the estate not specifically de-
- 23 vised, if:
- (a) The encumbrance is an involuntary encumbrance; or
- 25 (b) The encumbrance is a voluntary encumbrance and:
- 26 (A) The will specifically directs full or partial discharge of the en-
- ²⁷ cumbrance out of other assets; or
- 28 (B) The personal representative receives rents or profits, or both, from
- 29 the property and the devisee requests that he apply all or part of the
- 30 rents or profits, or both, in full or partial discharge of the obligation
- 31 secured by the encumbrance, in which event the personal representative
- 32 shall apply the rents or profits, or both, upon principal or interest, or both,
- 33 owing upon the obligation, as requested; or
- 34 (C) Any devisee requests, in a writing signed by the devisee and

- 1 delivered to the personal representative, that the obligation secured by the
- 2 encumbrance be fully or partially discharged out of property, or the pro-
- 3 ceeds of the sale thereof, which otherwise would pass to the devisee.
- 4 (4) If a claim based upon an obligation secured by a voluntary en-
- 5 cumbrance upon specifically devised property is presented and paid, or if
- 6 specifically devised real property subject to a voluntary encumbrance is
- 7 redeemed, and the devisee is not entitled to exoneration pursuant to sub-
- 8 section (3) of this section, the personal representative has a lien upon the
- 9 property in the amount paid, and the lien shall be administered upon as
- 10 an asset of the estate.
- 11 (5) If property is specifically devised by a will executed before the
- 12 effective date of this section, and if an encumbrance upon that property
- 13 exists on the date of the death of the testator, the rights of the devisee of
- 14 that property in respect of exoneration thereof out of other assets of the
- 15 estate shall be determined in accordance with the law in effect on the date
- 16 the will was executed.
- 17 Section 163. Power to redeem estate property. Unless otherwise pro-
- 18 vided by the will, the personal representative may redeem property of the
- 19 estate sold on foreclosure of mortgage or upon execution if it appears that
- 20 the redemption would be for the benefit of the estate and would not be
- 21 prejudicial to creditors.

- Section 164. Encumbered assets; powers of personal representative.
- 23 When any assets of the estate are encumbered by an involuntary or volun-
- 24 tary encumbrance, the personal representative may discharge the encum-
- 25 brance or any part thereof, renew or extend any obligation secured by the
- 26 encumbrance or convey or transfer the assets to the creditor in satisfaction
- 27 of his lien, in whole or in part, whether or not the holder of the encum-
- 28 brance has filed a claim, if it appears to be for the best interest of the estate.

26 ARTICLE VI. ACCOUNTING, DISTRIBUTION AND CLOSING

- Part 1. Allocation of Income
- Section 168. Allocation of income. Unless the will of the decedent
- 29 otherwise provides, income from the assets of the estate of a testate dece-
- 30 dent received after the death of the decedent and before final distribution,
- 31 including income realized from property that is sold or otherwise expended
- 32 for the purpose of discharging expenses of administration, claims and
- 33 inheritance and estate taxes, shall be determined in accordance with the

- 1 rules applicable to a trustee under ORS 129.010 to 129.140 and distributed 2 as follows:
- 3 (1) To specific devisees, the income received from the property devised
- 4 to them respectively, less the taxes, ordinary repairs and other expenses
- 5 incurred in the management and operation of the property, any interest
- 6 paid during the period of administration on account of such property and
- 7 an appropriate portion of taxes imposed on income, excluding taxes on
- 8 capital gains, that are paid from the estate during the period of administra-
- 9 tion.
- (2) To all other devisees, except devisees of pecuniary devises that are
- 11 not in trust and that do not qualify for the marital deduction provided for
- 12 in section 2056 of the Internal Revenue Code of 1954 (26 U.S.C. 2056), as
- 13 amended and in effect on January 1, 1969, the remaining income in propor-
- 14 tion to their respective interests in the assets of the estate that have not
- 15 been distributed to them or expended for the payment of inheritance or
- 16 estate taxes charged against their particular shares of the estate, computed
- 17 at the time of each such distribution on the basis of inventory values. As
- 18 used in this subsection, "remaining income" means the total income from
- 19 all property that is not specifically devised, less the taxes, ordinary repairs
- 20 and other expenses incurred in the management and operation of all such
- 21 property from which the estate is entitled to income, any interest paid dur-
- 22 ing the period of administration on account of such property, any interest
- 23 paid on general pecuniary devises and the taxes imposed on income, exclud-
- 24 ing taxes on capital gains, that are paid from the estate during the period
- 25 of administration and that are not charged against the property specifically
- 26 devised.
- 27 (3) Income received during the period of administration under this
- 28 section and distributed to a trustee shall be treated as income of the trust.
- Part 2. Partial Distribution
- Section 169. Petition and order for partial distribution. Upon petition
- 31 by the personal representative or other interested person, and after such
- 32 notice and hearing as the court may prescribe, the court may order the
- 33 personal representative to distribute, prior to final settlement and distribu-

- 1 tion, property of the estate to the person or persons who would be entitled
- ² to the property under the will or under intestate succession on final distri-
- 3 bution, if the court finds that:
- 4 (1) All inheritance taxes payable to the State of Oregon have been paid
- ⁵ or the State Treasurer has consented in writing to the distribution;
- 6 (2) After the distribution sufficient assets will remain to pay support of
- 7 spouse and children, expenses of administration, unpaid claims and all
- 8 known unpaid creditors of the decedent or of the estate; and
- 9 (3) The distribution may be made without loss to creditors or injury
- 10 to the estate or to any interested person.
- Section 170. Undertaking of distributee. The court may require a bond
- 12 or other security of any distributee for the protection of creditors and other
- 13 interested persons who might suffer loss or injury because of the distribu-
- 14 tion of property under section 169 of this Act.
- Section 171. Discharge of personal representative. The distribution of
- 16 property in accordance with the order of the court under section 169 of this
- 17 Act is a full discharge of the personal representative in respect to all
- 18 property embraced in the order, except as otherwise provided in sections
- 19 1 to 212 of this Act.
- Section 172. Petition and order for refund by distributee. If, after the
- 21 distribution of property under section 169 of this Act, it appears that all or
- 22 any part of the property distributed is required for the payment of claims
- 23 and expenses of administration, including determined and undetermined
- 24 state and federal tax liability, the personal representative shall petition the
- 25 court to order the return of the property. Notice of the hearing on the
- 26 petition shall be given as provided in section 13 of this Act. Upon the hear-
- 27 ing the court may order the distributee to return the property distributed
- 28 or any part thereof, or to pay its value as of the time of distribution, and
- 29 may specify the time within which the return or payment must be made.

Part 3. Accounting and Distribution

- 4 (1) All of the estate of the decedent that comes into his possession at
- 5 any time, including the income therefrom.
- 6 (2) All property not a part of the estate if:
- 7 (a) He has commingled the property with the assets of the estate; or
- 8 (b) The property was received under a duty imposed on him by law in
- 9 the capacity of personal representative.
- 10 (3) Any loss to the estate arising from:
- 11 (a) Neglect or unreasonable delay in collecting the assets of the estate.
- 12 (b) Neglect in paying over money or delivering property of the estate.
- (c) Failure to pay taxes as required by law or to close the estate within
- 14 a reasonable time.
- (d) Embezzlement or commingling of the assets of the estate with other
- 16 property.
- 17 (e) Unauthorized self-dealing,
- (f) Wrongful acts or omissions of his co-personal representatives that
- 19 he could have prevented by the exercise of ordinary care.
- 20 (g) Any other negligent or wilful act or nonfeasance in his administra-
- 21 tion of the estate by which loss to the estate arises,
- Section 174, Nonliability of personal representative. A personal rep-
- 23 resentative is not liable for or chargeable in his accounts with:
- 24 (1) Debts due the decedent or other assets of the estate that remain
- 25 uncollected without his fault.
- 26 (2) Loss by the decrease in value or destruction of property of the
- 27 estate if the loss is caused without his fault.
- Section 175. Accounting by personal representative. (1) A personal
- 29 representative shall make and file in the estate proceeding a verified
- 30 account of his administration:
- 31 (a) Unless the court orders otherwise, annually within 30 days after
- 32 the anniversary date of his appointment.
- 33 (b) Within 30 days after the date of his removal or resignation or the
- 34 revocation of his letters.

- 1 (c) When the estate is ready for final settlement and distribution.
- 2 (d) At such other times as the court may order.
- 3 (2) Each account shall include the following information:
- 4 (a) The period of time covered by the account.
- 5 (b) The total value of the property with which the personal representa-
- 6 tive is chargeable according to the inventory, or, if there was a prior
- 7 account, the amount of the balance of the prior account.
- 8 (c) All money and property received during the period covered by the 9 account.
- 10 (d) All disbursements made during the period covered by the account.
- 11 Vouchers for disbursements shall accompany the account, unless otherwise
- 12 provided by order or rule of the court.
- 13 (e) The money and property of the estate on hand.
- 14 (f) Such other information as the personal representative considers
- 15 necessary to show the condition of the affairs of the estate or as the court
- 16 may require.
- 17 (3) When the estate is ready for final settlement and distribution, the
- 18 account shall also include:
- 19 (a) A statement that all Oregon income, inheritance and personal
- 20 property taxes, if any, have been paid, or if not so paid, that payment of
- 21 those taxes has been secured by bond, deposit or otherwise.
- (b) A petition for a decree authorizing the personal representative to
- 23 distribute the estate to the persons and in the portions specified therein.
- 24 (4) If the distributees consent thereto in writing and all creditors of
- 25 the estate have been paid in full, the personal representative, in lieu of the
- 26 final account otherwise required by this section, may file as his final
- 27 account a verified statement that includes the following:
- 28 (a) The period of time covered by the account.
- 29 (b) A statement that all creditors have been paid in full.
- 30 (c) The statement and petition referred to in subsection (3) of this
- 31 section.
- 32 Section 176. Notice for filing objections to final account and petition
- 33 for distribution. (1) Upon filing the final account and petition for decree
- 34 of distribution, the personal representative shall fix a time for filing

- 1 objections thereto in a notice thereof. Not less than 20 days before the time
- 2 fixed in the notice, the personal representative shall cause a copy of the
- 3 notice to be mailed to:
- 4 (a) Each heir at his last-known address, if the decedent died intestate.
- 5 (b) Each devisee at his last-known address, if the decedent died testate.
- 6 (c) Each creditor who has not received payment in full and whose 7 claim has not otherwise been barred.
- 8 (d) Any other person known to the personal representative to have or 9 to claim an interest in the estate being distributed.
- 10 (2) The notice need not be mailed to the personal representative.
- 11 (3) Proof of the mailing to those persons entitled to notice shall be made
- 12 by affidavit and filed in the estate proceeding at or before approval of the
- 13 final account.
- 14 (4) If the State Public Welfare Commission or its authorized agent has
- 15 presented a claim under ORS chapters 411 to 417, or the Oregon State
- 16 Board of Control or its authorized agent has presented a claim under
- 17 subsection (3) of ORS 179.620, and the claim has not been settled or paid
- 18 in full, the personal representative shall cause to be mailed to the commis-
- 19 sion or board a copy of the final account at the same time, and shall make
- ²⁰ proof of the mailing in the same manner, as the notice provided for in this
- 21 section.
- Section 177. Objections to final account and petition. Any person en-
- 23 titled to notice under section 176 of this Act may, within the time fixed
- 24 for the filing, file in the estate proceeding his objections to the final account
- 25 and petition for distribution, specifying the particulars of the objections.
- 26 Upon the filing of objections the court shall fix the time for hearing
- 27 thereon.
- Section 178. Decree of final distribution. (1) If no objections to the final
- 29 account and petition for distribution are filed, or if objections are filed,
- 30 upon the hearing, the court shall give its decree of final distribution. In its
- 31 decree the court shall designate the persons in whom title to the estate
- 32 available for distribution is vested and the portion of the estate or property
- 33 to which each is entitled under the will, by agreement approved by the

- 1 court or pursuant to intestate succession. The decree shall also contain any 2 findings of the court in respect to:
- **3** (a) Advancements.
- 4 (b) Election against will by the surviving spouse.
- 5 (c) Renunciation.
- 6 (d) Lapse.
- 7 (e) Adjudicated controversies.
- 8 (f) Partial distribution, which shall be confirmed or modified.
- g (g) Retainer.
- (h) Claims for which a special fund is set aside, and the amount setaside.
- (i) Contingent claims that have been allowed and are still unpaid.
- (j) Approval of the final account in whole or in part.
- 14 (2) The personal representative is not entitled to approval of his final
- 15 account until Oregon income, inheritance and personal property taxes, if
- 16 any, have been paid and appropriate receipts, releases and clearances
- 17 therefor have been filed, or until payment of those taxes has been secured
- 18 by bond, deposit or otherwise.
- 19 (3) If, by agreement approved by the court, property is distributed to
- 20 persons in whom title is vested by the decree of final distribution otherwise
- 21 than as provided by the will or pursuant to intestate succession, the decree
- operates as a transfer of the property between those persons.
- 23 (4) The decree of final distribution is a conclusive determination of the
- 24 persons who are the successors in interest to the estate and of the extent
- 25 and character of their interest therein, subject only to the right of appeal
- 26 and the power of the court to vacate the decree.
- Section 179. Effect of approval of final account. To the extent that the
- 28 final account is approved, the personal representative and his surety,
- 29 subject to the right of appeal, to the power of the court to vacate its final
- 30 orders and to the provisions of section 188 of this Act, are relieved from
- 31 liability for the administration of his trust. The court may disapprove the
- 32 account in whole or in part, surcharge the personal representative for any
- 33 loss caused by any breach of duty and deny in whole or in part his right
- 34 to receive compensation.

- 1 Section 180. Distribution; order in which assets appropriated; abate-
- 2 ment. (1) If the will expresses an order of abatement, or the testamentary
- 3 plan or the express or implied purpose of the devise would be defeated by
- 4 the order of abatement stated in subsection (2) of this section, the shares
- 5 of the distributees abate as may be found necessary to give effect to the
- 6 intention of the testator.
- 7 (2) Except as provided in section 54 of this Act as to the shares of
- 8 pretermitted children, and in section 112 of this Act as to the share of the
- 9 surviving spouse who elects to take against the will, shares of distributees
- 10 abate without any preference or priority as between real and personal
- 11 property in the following order:
- (a) Property not disposed of by the will.
- 13 (b) Residuary devises.
- 14 (c) General devises.
- 15 (d) Specific devises.
- 16 (3) A general devise charged on any specific property or fund is con-
- 17 sidered, for purposes of abatement, property specifically devised to the
- 8 extent of the value of the thing on which it is charged. Upon the failure
- 19 or insufficiency of the thing on which it is charged, it is considered a
- 20 general devise to the extent of the failure or insufficiency.
- 21 (4) Abatement within each classification is in proportion to the amounts
- 22 of property each of the distributees would have received had full distribu-
- 23 tion of the property been made in accordance with the terms of the will.
- 24 (5) Persons to whom the will gives tangible personal property not used
- 25 in trade, agriculture or other business are not required to contribute from
- 26 that property unless the particular devise forms a substantial amount of the
- 27 total estate and the court specifically orders contribution because of the
- 28 devise.
- 29 (6) When the subject matter of a preferred devise is sold or used inci-
- 30 dent to administration, abatement shall be achieved by appropriate adjust-
- 31 ments in, or contribution from, other interests in the remaining assets.
- 32 Section 181. Interest on pecuniary devises. General pecuniary devises
- 33 not entitled to a share of income under subsection (2) of section 168 of this
- 34 Act bear interest payable from the residuary estate at the rate of five

- 1 percent per annum for a period beginning one year after the first appoint-
- 2 ment of a personal representative until payment, unless a contrary intent
- 3 is evidenced in the will or unless otherwise ordered by the court.
- 4 Section 182. Right of retainer. The amount of the indebtedness of a
- ⁵ distributee to the estate if due, or its present worth if not due, shall be
- 6 offset against the interest of the distributee in the estate; but the distributee
- 7 has the benefit of any defense that would be available to him in a direct
- 8 proceeding for recovery of the debt. The right of offset and retainer is prior
- 9 and superior to the rights of judgment creditors, heirs or assignees of the
- 10 distributee.
- Section 183. Distribution to foreign personal representative. When ad-
- 12 ministration of an estate in this state has been completed and the estate is
- 13 in a condition to be distributed, the court, upon application by the personal
- 14 representative, may authorize the delivery to the personal representative
- 15 of an estate of a decedent pending in a foreign jurisdiction of such property
- 16 as the court finds appropriate for the payment of debts, taxes or other
- 17 charges or for distribution to the distributees of the estate in the foreign
- 18 jurisdiction.
- 19 Section 184. ORS 117.680 is amended to read:
- 20 117.680. Compensation of personal representative. (1) Upon application
- 21 to the court a personal representative is entitled to receive compensation
- 22 for his services as provided in this section. If there is more than one
- 23 personal representative acting concurrently, the compensation shall not be
- 24 increased, but may be divided among them as they agree or as the court
- 25 may order. The compensation [provided by law for an executor or adminis-
- 26 trator] is a commission upon the whole estate, [accounted for by him,] as
- 27 follows:
- 28 (a) Upon the property subject to the jurisdiction of the court, including
- 29 income and realized gains:

- 3 (2) In all cases, such further compensation as is just and reasonable
- 4 may be allowed by the court [or judge thereof,] for any extraordinary and
- 5 unusual services not ordinarily required of fan executor or administrator
- 6 a personal representative in the discharge of his trust.
- 7 (3) When a decedent by his will has made special provision for the
- 8 compensation of a personal representative, the personal representative is
- 9 not entitled to any other compensation for his services unless prior to
- 10 his appointment he signs and files with the clerk of the court a written
- 11 renunciation of the compensation provided by the will.
- Section 185. Expenses of personal representative. A personal represent-
- 13 ative shall be allowed in the settlement of his final account all necessary
- 14 expenses incurred in the care, management and settlement of the estate,
- 15 including reasonable fees of appraisers, attorneys and other qualified per-
- 16 sons employed by him. A personal representative who defends or prose-
- 17 cutes any proceeding in good faith and with just cause, whether successful
- 18 or not, is entitled to receive from the estate his necessary expenses and
- 19 disbursements, including reasonable attorney fees, in the proceeding.
- 20 Section 186. Order of escheat. If it appears to the court, at any time
- 21 after the expiration of four months after the date of the first publication
- 22 of notice to interested persons, that there is no known person to take by
- 23 descent the net intestate estate, the court shall order that the estate
- 24 escheat to the State of Oregon and that the whole of the estate, after
- 25 payment of claims, taxes and expenses of administration, be distributed
- 6 to the Division of State Lands. There shall be no further proceeding in
- 27 the administration of the estate, and the estate shall summarily be closed.
- Section 187. Disposition of unclaimed assets. If a report filed in the
- 29 estate proceeding by the personal representative not less than 30 days
- 30 after the date of entry of the decree of distribution shows that payment
- 31 or delivery of property in his possession or under his control cannot be
- 32 made to a distributee entitled thereto, either because the distributee
- 33 refuses to accept the property or because he cannot be found, the court
- 34 may direct the personal representative to pay or deliver the property to

- 1 the Division of State Lands, to be placed in the escheat funds of the state.
- 2 The personal representative shall take the receipt of the Division of

- Section 189. Recording of final decree and discharge order in other
- 20 counties. If real property belonging to the estate is situated in a county
- 21 other than that in which the estate is being administered, the personal
- 22 representative shall cause to be recorded in the deed records of that
- 23 other county certified copies of the decree of final distribution and the
- 24 order discharging the personal representative.
- Section 190. Reopening estate of decedent. Upon the petition of any in-
- 26 terested person, the court, with such notice as it may prescribe, may order
- 27 the estate of a decedent reopened if other property is discovered, if any
- 28 necessary act remains unperformed or for any other proper cause appear-
- 29 ing to the court. The court may reappoint the former personal repre-
- 30 sentative, or appoint another personal representative, to administer any
- 31 additional property or to perform such other acts as are considered
- 32 necessary. The provisions of law as to original administration apply, in
- 33 so far as applicable, to accomplish the purpose for which the estate is

- 1 reopened, but a claim that already is adjudicated or barred may not be
- 2 asserted in the reopened administration.
- 3 Section 191. Reports by county clerks to Division of State Lands. A
- 4 county clerk, upon request, shall furnish to the Director of the Division of
- 5 State Lands the titles of estates of decedents that have remained open for
- 6 more than three years and in which no heirs, or only persons whose right
- 7 to inherit the proceeds thereof is being contested, have appeared to claim
- 8 the estate.
- 9 Section 192. ORS 120.130 is amended to read:
- 10 120.130. Recovery of escheated property. (1) Within 10 years after
- 11 [judgment in any proceeding in the circuit court escheating real property to
- 12 the state, or after the order of the court having probate jurisdiction directing
- 13 the conveyance of escheated real property to the state, and in all other cases
- 14 within 10 years after payment of the proceeds of escheated personal property
- 15 to the State Land Board, the entry of a decree of final distribution designa-
- 16 ting title to an estate available for distribution in the Division of State
- 17 Lands or an order of escheat to the state, a claim may be made for the
- 18 property escheated, or the proceeds thereof, by or on behalf of a person
- 19 not [a party or privy to such proceeding, nor] having actual knowledge of
- 20 the [making of such judgment] decree or order [or of such payment to the
- 21 State Land Board.
- 22 (2) The claim shall be made by a petition filed fin the court in which the
- 23 escheat proceedings were held.] with the Director of the Division of State
- 24 Lands. The claim is considered a contested case as provided in ORS

- 5 (e) That 10 years have not elapsed since the [making of the judgment or
- 6 order] entry of the decree or order escheating the property to the state $\frac{1}{7}$, or
- 7 since the payment of the proceeds of the escheated estate by the administrator
- 8 thereof to the State Land Board pursuant to the order of the court having
- 9 probate jurisdiction; and
- (f) If the petition is not filed by the claimant himself, the status of
- 11 the petitioner [, whether executor, administrator, conservator or guardian].
- 12 (3) The State Land Board shall be made a defendant in the proceeding;
- 13 and a copy of the petition must be served upon the clerk of the board at least
- 14 20 days before the hearing of the petition. The court must try the issue, as
- 15 issues are tried in civil actions, with the aid of a jury, if requested by either

29 Part 4. Apportionment of Estate Taxes

- Section 194. Definitions. As used in sections 194 to 202 of this Act:
- 31 (1) "Estate" means the gross estate of a decedent as determined for the
- 32 purpose of federal estate tax and the inheritance tax payable to this state
- 33 as provided in subsection (1) of ORS 118.100.
- 34 (2) "Person" means any individual, partnership, association, joint stock

- 1 (3) Any deduction for property previously taxed and any credit for gift
- 2 taxes or death taxes of a foreign country paid by the decedent or his
- 3 estate inures to the proportionate benefit of all persons liable to appor-
- 4 tionment.
- 5 (4) Any credit for inheritance, succession or estate taxes or taxes in
- 6 the nature thereof in respect to property or interests includable in the
- 7 estate inures to the benefit of the persons or interests chargeable with
- 8 the payment thereof to the extent that, or in proportion as, the credit
- 9 reduces the tax.
- 10 (5) To the extent that property passing to or in trust for a surviving
- 11 spouse or any charitable, public or similar gift or bequest does not con-
- 12 stitute an allowable deduction for purposes of the tax solely by reason of
- 13 an inheritance tax or other death tax imposed upon and deductible from
- 14 the property, the property shall not be included in the computation pro-
- 15 vided for in section 195 of this Act, and to that extent no apportionment
- 16 shall be made against the property. This subsection does not apply to any
- 17 case where the result will be to deprive the estate of a deduction other-
- 18 wise allowable under section 2053 (d) of the Internal Revenue Code of
- 19 1954 (26 U.S.C. 2053 (d)), as amended and in effect on January 1, 1969,
- relating to deduction for state death taxes on transfers for public, charitable
- 21 or religious uses.
- Section 199. Income interests; life or temporary interests; charging
- 23 corpus. No interest in income and no estate for years or for life or other
- 24 temporary interest in any property or fund is subject to apportionment as
- 25 between the temporary interest and the remainder. The tax on the tempo-
- 26 rary interest and the tax, if any, on the remainder is chargeable against
- 27 the corpus of the property or funds subject to the temporary interest and
- 28 remainder.
- Section 200. Proceedings for recovery of tax; liability of personal repre-
- 30 sentative; apportionment of amount not recovered. Neither the personal
- 31 representative nor other person required to pay the tax is under any duty
- 32 to institute any suit or proceeding to recover from any person interested
- 33 in the estate the amount of the tax apportioned to that person until the
- 34 expiration of three months next following final determination of the tax.

- 1 A personal representative or other person required to pay the tax who
- 2 institutes the suit or proceeding within a reasonable time after the three-
- 3 month period is not subject to any liability or surcharge because any
- 4 portion of the tax apportioned to any person interested in the estate was
- 5 collectible at a time following the death of the decedent but thereafter
- 6 became uncollectible. If the personal representative or other person re-
- 7 quired to pay the tax cannot collect from any person interested in the
- 8 estate the amount of the tax apportioned to the person, the amount not
- 9 recoverable shall be equitably apportioned among the other persons in-
- 10 terested in the estate who are subject to apportionment.
- Section 201. Foreign personal representatives and estates. A personal
- 12 representative acting in another state or a person required to pay the
- 13 tax who is domiciled in another state may institute an action in the courts
- 14 of this state and may recover a proportionate amount of the federal estate
- 15 tax, of an estate tax payable to another state or of a death duty due by
- 16 a decedent's estate to another state, from a person interested in the estate
- 17 who is either domiciled in this state or who owns property in this state
- 18 subject to attachment or execution. For the purposes of the action the
- 19 determination of apportionment by the court having jurisdiction of the
- 20 administration of the decedent's estate in the other state is prima facie
- ²¹ correct.
- Section 202. Construction. Sections 194 to 202 of this Act embody the
- 23 Uniform Estate Tax Apportionment Act and shall be construed to ef-
- 24 fectuate its general purpose to make uniform the law of those states
- 25 which enact it.

26 ARTICLE VII. ESTATES OF ABSENTEES

- Section 203. Petition for administration of estate of absentee. Adminis-
- 28 tration may be had upon the estate of an absentee. A petition for adminis-
- 29 tration shall state, in addition to the information required by section 83
- 30 of this Act:
- 31 (1) Whether the absentee, when last heard from, was a resident or
- 32 nonresident of this state.
- 33 (2) The address of the absentee at his last-known domicile.
- 34 (3) (a) That, to the best knowledge of the petitioner and after diligent

- 1 search, the whereabouts of the absentee is and has been unknown for a
- 2 period stated of not less than one year, and that the petitioner has reason
- 3 to believe and believes the absentee is dead; or
- 4 (b) That the death of the absentee at the time, location and in the
- ⁵ circumstances stated in the petition is probable, and that the fact of his
- 6 death is in doubt solely by reason of the failure to find or identify his
- 7 remains.
- 8 Section 204. Setting date of hearing on petition; notice of hearing. (1)
- 9 Upon the filing of a petition under section 203 of this Act, the clerk of the
- 10 court shall set a date for hearing not less than 30 days after the date of
- 11 filing the petition, unless the court sets an earlier date. A copy of the
- 12 notice of the hearing shall be sent:
- 13 (a) To the absentee at his last-known address by registered mail and
- 14 by postage prepaid letter to be forwarded through the United States
- 15 Social Security Administration to his last-known address available to that
- 16 agency.
- 17 (b) By ordinary mail to the devisees and heirs named in the petition.
- 18 (2) The court may order that additional notice of the hearing be
- 19 given by publication or by other means. Proof of mailing may be made
- 20 by the petitioner by affidavit.
- Section 205. Appointment of person to represent absentee; directing
- 22 search. The court may appoint some disinterested person as guardian ad
- 23 litem to appear for the absentee at the hearing on the petition. The
- 24 court may direct the petitioner or the guardian ad litem to make search
- 25 for the absentee in any manner the court considers advisable, including
- 26 any or all of the following methods:
- 27 (1) By inserting in one or more suitable publications a notice request-
- 28 ing information from any person having knowledge of the whereabouts
- 29 of the absentee.
- 30 (2) By notifying officers of justice and public welfare agencies in
- 31 appropriate locations of the disappearance of the absentee.
- 32 (3) By engaging the services of an investigation agency.
- 33 Section 206. Hearing on petition. Upon the hearing on the petition the
- 34 court shall determine whether the absentee has died and if so, the date

- 1 of his death and whether he died testate or intestate. Upon finding that
- 2 the absentee has died, the court shall grant letters accordingly, or, in the
- 3 absence of that finding, may deny the petition. An appeal may be taken
- 4 from the order of the court.
- 5 Section 207. Effect of finding of death. The finding of the court that
- 6 the absentee has died is conclusive as to the estate of the absentee only if:
- 7 (1) Notice of the hearing on the petition was given as required by
- 8 section 204 of this Act; and
- 9 (2) The court finds that diligent search for the absentee was made.
- Section 208. Procedure for administering estate. Upon the entry of the
- 11 order of the court finding that the absentee has died and granting letters,
- 12 administration of the estate of the absentee, whether testate or intestate,
- 13 shall proceed as provided for the estates of other decedents, except as
- 14 otherwise provided in sections 203 to 212 of this Act.
- 15 Section 209. Revocation of letters; proceedings upon revocation. Upon
- 16 proof that the absentee is alive, letters theretofore granted shall be re-
- 17 voked. Acts of the personal representative before revocation of letters are
- 18 as valid as though the letters had not been revoked, but after revocation the
- 19 personal representative has no further power in the capacity of personal
- 20 representative except as provided in this section. The personal representa-
- 21 tive shall pay claims allowed and proved, file an account of his administra-
- 22 tion for the period of time before revocation of letters and transfer any
- 23 property in his possession to the person for whose estate he acted or to the
- 24 authorized agent of that person.

SENATE BILL 506 (1969 REGULAR SESSION)

Table Showing Source From Preliminary Draft Sections Of Bill Sections

Senate Bill 506 (1969 Regular Session) embodies a proposed Oregon probate code that was initially prepared by the Advisory Committee on Probate Law Revision, with the assistance of the Oregon State Bar Committee on Probate Law and Procedure, and thereafter reviewed, approved and submitted to the Oregon Legislative Assembly by the Law Improvement Committee.

Prior to review, approval and submission by the Law Improvement Committee, the proposed code was distributed to all active members of the Oregon State Bar in Oregon and others, in the form of a blue, paperback publication entitled "Preliminary Draft -- Proposed Oregon Probate Code." In addition to the statutory substance of the proposed code, the preliminary draft contained comments by the Advisory Committee that included references to sources of proposed new provisions of law and reasons for proposed changes in or elimination of present law.

In the course of preparing the proposed code for introduction as Senate Bill 506, some of the sections of the preliminary draft were relocated and many were renumbered. To assist those persons examining sections of Senate Bill 506 in locating comparable sections of the preliminary draft, and vice versa, the following table has been prepared.

The first column on each page of the table sets forth, by number, the sections of Senate Bill 506, followed by the comparable sections, by number, of the preliminary draft. The second column sets forth the preliminary draft sections, followed by the comparable sections of Senate Bill 506. "Added" indicates that a section in the bill did not appear in the preliminary draft. "Deleted" indicates a section in the preliminary draft that does not appear in the bill.

Senate Bill 506

By COMMITTEE ON JUDICIARY (at the request of the Law Improvement Committee)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure as introduced.

Enacts new Oregon probate code. Revises laws relating to probate courts and procedure, intestate succession, wills, initiation of estate proceedings, appointment and qualification of personal representatives (executors and administrators), administration and distribution of decedents' estates, guardianships and conservatorships. Generally eliminates distinctions in treatment of real and personal property. Replaces dower and curtesy with enlarged intestate share and election against will of surviving spouse. Lowers age for making will from 21 to 18. Expands requirements for notice to interested persons of initiation of estate proceeding, but reduces number of published notices. Shortens time period for contesting will and filing claims for preferential payment from 6 to 4 months. Broadens and makes more flexible the support allowance for surviving spouse and dependent children. Simplifies handling of small, solvent estates by permitting them, after paying claims, expenses and taxes, to be set apart as family support, with summary closure of estate proceeding. Gives personal representative more power to act without court proceeding and approval, but allows him or any interested person to obtain court instruction or approval. Makes inventory and appraisal requirements more flexible. Simplifies escheat proceedings. Imparts finality and conclusiveness to court's decree of final distribution. Modifies procedures for handling estates of absentees, including substitution of finding of death based on actual search instead of 7-year presumption. Makes changes in inheritance tax procedures to simplify and conform them to modifications of probate laws. Eliminates separate procedures for conserving property of missing persons, and makes estates of such persons subject to guardianship proceedings. Makes many other substantive changes and refinements in probate laws, rearranges and clarifies those laws and conforms other laws that are geared to probate courts and procedures.

ARTICLE II. INTESTATE SUCCESSION AND WILLS

- Part 1. Intestate Succession
- Section 19. Net intestate estate. Any part of the net estate of a decedent

- 32 Section 20. Share of surviving spouse if decedent leaves issue. If the

- (4) If there is no surviving issue, parent or issue of a parent, to the
- grandparents of the decedent and the issue of any deceased grandparent
- of the decedent by representation. If there is no surviving grandparent,
- the issue of grandparents take equally if they are all of the same degree of 20
- kinship to the decedent, but if of unequal degree, then those of more re-
- mote degrees take by representation.
- (5) If, at the time of taking, surviving parents or grandparents of the
- decedent are married to each other, they shall take real property as ten-
- ants by the entirety and personal property as joint owners with the right
- of survivorship.
- Section 23. Escheat. If no person takes under sections 20 to 22 of this
- Act, the net intestate estate shall escheat to the State of Oregon.
- Section 24. Representation defined. "Representation" means the method
- of determining the passing of the net intestate estate when the distribu-
- tees are of unequal degrees of kinship to the decedent. It is accomplished
- as follows: The estate shall be divided into as many shares as there
- are surviving heirs of the nearest degree of kinship and deceased persons
- of the same degree who left issue who survive the decedent, each surviving

- 13 Section 27. Persons of the half-blood. Persons of the half-blood inherit
- 14 the same share that they would inherit if they were of the whole blood.
- 15 Section 28. Illegitimate children. For all purposes of intestate suc-
- 16 cession, an illegitimate child, unless he has been adopted:
- 17 (1) Shall be treated as the legitimate child of his mother.
- 18 (2) Shall be treated as the legitimate child of the father if, during
- 19 the lifetime of the child:
- 20 (a) The paternity of the child is established under ORS 109.070; or
- 21 (b) The father has acknowledged himself to be the father in writing
- 22 signed by him.
- 23 Section 29. Persons related to decedent through two lines. A person
- 24 who is related to the decedent through two lines of relationship is entitled
- 25 to only a single share based on the relationship which would entitle him
- 26 to the larger share.

Part 2. Advancements

- Section 30. When gift is an advancement. If a person dies intestate as
- 29 to all his estate, property which he gave in his lifetime to an heir shall be
- 30 treated as an advancement against the heir's share of the estate if de-
- 31 clared in writing by the decedent or acknowledged in writing by the heir
- 32 to be an advancement. For that purpose the property advanced shall be

Part 3. Status of Adopted Persons for

- Section 104. Support of spouse and children. The court by order shall
- 13 make necessary and reasonable provision from the estate of a decedent
- 14 for the support of the spouse and any dependent child of the decedent

- 16 (1) Petition therefor by or on behalf of the spouse or any dependent
- 17 child;
- 18 (2) Service of the petition and notice of hearing thereon to the per-
- 19 sonal representative, unless the petititoner is the personal representative;
- 20 (3) Notice to persons whose distributive shares of the estate may be
- 21 diminished by the granting of the petition, unless the court by order
- ²² directs otherwise; and
- ²³ (4) Hearing.
- Section 105. Petition for support and answer. (1) The petition for sup-
- 25 port under section 104 of this Act shall include a description of property,
- 26 other than property of the estate, available for the support of the spouse
- 27 and children, and an estimate of the expenses anticipated for their sup-
- 28 port. If the petitioner is the personal representative, the petition shall also
- 29 include, so far as known, a statement of the nature and estimated value
- 30 of the property of the estate and of the nature and estimated amount of
- 31 claims, taxes and expenses of administration.
- 32 (2) If the personal representative is not the petitioner, he shall answer

- 22 without regard to the powers forfeited under subsection (2) of this section.
- (2) Except as to property applied under subsection (1) of this section to
- 24 reduce the elective share, an election to take under this section forfeits
- 25 any other right to take under the will and under the law of intestate suc-
- 26 cession. If the will would otherwise create a power of appointment in the
- 27 surviving spouse, the spouse by electing to take under this section retains
- 28 the power only if it is not a general power of appointment as defined in
- 29 subsection (5) of ORS 118.010 and the testator has not provided otherwise,
- 30 but the spouse forfeits any general power of appointment. A power to pay

- 14 for the absentee in any manner the court considers advisable, including
- 25 any or all of the following methods:
