#### **EXECUTIVE ORDER NO. 18-01**

BUILDING OREGON'S COMMITMENT TO ADDICTION PREVENTION, TREATMENT, AND RECOVERY PRIORITIES, AND SETTING DEADLINES FOR STATUTORY REQUIREMENTS, AND DECLARING A PUBLIC HEALTH CRISIS

WHEREAS, Oregonians struggle with addiction to alcohol or drugs every day; and

WHEREAS, serving people struggling with addiction is a responsibility borne by many state agencies; and

WHEREAS, addiction is often considered to be an acute crisis but in reality is a chronic, but treatable, disease; and

WHEREAS, addiction treatment and recovery support services are unfortunately beyond reach for many Oregonians in need, especially for Oregonians in rural areas; and

WHEREAS, culturally sensitive addiction treatment and recovery support services are not sufficiently available to historically underserved Oregonians; and

WHEREAS, more than half of youth and adults prosecuted in the criminal justice system enter with addiction or a dual diagnosis; and

WHEREAS, the criminal justice system should not be Oregon's safety net for persons suffering from the disease of addiction; and

WHEREAS, almost sixty percent of children in foster care have at least one parent with a substance use disorder; and

WHEREAS, a person who suffers from addiction often requires low-barrier housing to achieve the safety and stability necessary for recovery; and

WHEREAS, long-term employment can be difficult to sustain when an individual is in the throes of an addiction; and

WHEREAS, the Alcohol and Drug Policy Commission (hereafter, the Commission) was created to establish priorities and policies for alcohol and drug prevention and treatment as part of a strategic state plan to reduce addiction and alleviate its impacts; and

WHEREAS, the Commission is able to work across state agencies to create the state's strategic plan and ensure that state resources are being efficiently utilized on effective programs; and

WHEREAS, improved data collection and research are important components of the Commission's work; and

WHEREAS, it is critical that all state agencies work with the Commission to ensure that they are able to implement a strategic plan;

#### NOW, THEREFORE, IT IS HEREBY DIRECTED AND ORDERED:

- 1. I find that for the reasons recited above it is necessary to declare Alcohol and Substance Abuse Addiction a Public Health Crisis in Oregon.
- 2. The Oregon Health Authority, the Oregon Health Policy Board, the Department of Human Services, the Department of Corrections, the Oregon Youth Authority, the Youth Development Council, the Department of Housing and Community Services, the Department of Consumer and Business Services, and the Department of Education (hereinafter, the Agencies) shall work with the Commission to create a Statewide Addiction Prevention, Treatment, and Recovery Plan (hereinafter, the Plan), and shall provide resources as requested. The Plan shall include the recommendations required by Oregon Revised Statutes 430.242(2) and any other recommendations the Agencies and Commission deem critical to improving services for Oregonians struggling from addiction.
- 3. The Agencies shall provide a single point of contact who shall be empowered to respond to any inquiries of the Commission, and shall direct all employees to assist and respond when needed.
- 4. The Agencies shall enter into data-sharing agreements with the Commission to the extent legally permissible. If barriers to those agreements arise, the Agency will identify the barriers and work to overcome them to the extent practicable, for instance by exploring changes of policy or legislation.
- 5. With the support of the above-listed Agencies, the Commission shall:
  - a. Enter into a Memorandum of Understanding with the Oregon Health Authority and other relevant agencies to ensure continued funding and support of the Commission for at least the remainder of the biennium no later than April 1, 2018.

- **b.** Submit to the Governor and Legislature preliminary recommendations no later than September 15, 2018.
- c. Submit to the Governor's Office a recommended budget (to include whether or not the Commission should change its funding structure) during the building of the Governor's Recommended Budget for the 2019-2021 biennium.
- **d.** Complete any Requests for Proposals to create the Plan no later than November 1, 2018.
- e. No later than July 1, 2020, and July 1 of even-numbered years thereafter, submit a Statewide Addiction Prevention, Treatment and Recovery Plan to the Governor's Office and Legislature.
- **f.** Provide quarterly updates to the Governor's Office regarding the status of the development of the Plan, and be prepared to make budgetary recommendations during the building of the Governor's Recommended Budget for 2021-2023 biennium.
- g. Provide updates as requested to any legislative committees.
- 6. This Executive Order will remain in effect until it is superseded by statute or another Executive Order, or upon the final presentation and adoption of the initial Statewide Prevention, Treatment and Recovery Plan.

# DETERMINATION OF A STATE OF DROUGHT EMERGENCY IN GRANT COUNTY DUE TO LOW SNOWPACK, PRECIPITATION, AND STREAMFLOW, AND WARMING TEMPERATURES

Pursuant to ORS 536.740, I find that the continuing low snowpack, lack of precipitation, low streamflows, and warming temperatures are likely to cause natural and economic disaster conditions in Grant County, resulting in a severe, continuing drought emergency in that county during 2018.

Forecasted water conditions are not expected to improve, and drought is likely to have significant economic impacts on agriculture, livestock, and natural resources in Grant County. Dry conditions will place agricultural and livestock investments at risk, threaten natural resources, and recreational and tourism activities, and subject the regional economy to widespread and severe damage.

Conditions are being monitored by the state's natural resource and public safety agencies, including the Oregon Water Resources Department and the Oregon Office of Emergency Management.

Preparation and timely response to drought are vital to the safety of persons, property, and the economic security of the citizens and businesses of Grant County. I therefore declare that a severe, continuing drought emergency exists in Grant County.

#### NOW, THEREFORE, IT IS HEREBY DIRECTED AND ORDERED:

- I. The Oregon Department of Agriculture is directed to coordinate and provide assistance in seeking federal resources to mitigate drought conditions and to assist in agricultural recovery in Grant County.
- II. The Oregon Water Resources Department and the Water Resources Commission are directed to coordinate and provide assistance to water users in Grant County as the Department and Commission determine is necessary and appropriate in accordance with ORS 536.700 to 536.780.

- III. The Office of Emergency Management is directed to coordinate and assist as needed with assessment and mitigation activities to address current and projected conditions in Grant County.
- IV. All other state agencies are directed to coordinate with the above agencies and to provide appropriate state resources as needed to assist affected political subdivisions and water users in Grant County.
- V. This Executive Order expires on December 31, 2018.

# DEQ Seeks Comments on Prospective Purchaser Agreement for Fueling Station Property in Beaverton

**Comments due:** 5 p.m., May 31, 2018

Project location: 6055 SW Hall Boulevard, Beaverton, OR, 97008

**Proposal:** The Oregon Department of Environmental Quality seeks comments on a proposed Prospective Purchaser Agreement with the City of Beaverton, concerning its acquisition of the property located at 6055 SW Hall Boulevard located in Beaverton, Oregon. The City of Beaverton plans to remove the existing service station and develop the acquired property. The agreement is in the form of a consent judgement.

**Highlights:** In 1994 a gasoline release was discovered during the installation of a vapor recovery system and in 2006 a diesel release of unknown origin impacted soil and groundwater at the Property.

Under the terms of the agreement, the City of Beaverton will prepare an Expanded Contaminated Media Management Plan to establish procedures for managing, characterizing and disposing of contaminated media, if encountered. During property development, the City of Beaverton will demolish the existing infrastructure, including the underground storage tank system (tanks, pumps, hoists, and piping). The city also agrees to excavate impacted soil and remediate groundwater within the excavation areas, if encountered at concentrations that exceed the DEQ risk-based concentrations in groundwater protective of urban residents. Finally, if future development includes an enclosed structure on the property, the city agrees to evaluate potential human health risks and, if necessary, install and monitor a sub-slab vapor mitigation system.

DEQ created the Prospective Purchaser Agreement program in 1995 through amendments to the state's Environmental Cleanup Law. The agreement is a tool that expedites the cleanup of contaminated property and encourages property transactions that would otherwise not likely occur because of the liabilities associated with purchasing a contaminated site.

The proposed consent judgement will provide the City of Beaverton with a release from liability for claims by the State of Oregon under ORS 465.200 to 465.545 and 465.990, 466.640, and 468B.310 regarding existing hazardous substance releases at or from the Property. The proposed consent judgement will also provide the City of Beaverton with third party liability protection.

# Proposed Conditional No Further Action Determination for the Hillsboro Shopping Center

Comments due: 5 p.m., Thursday, May 31, 2018

**Project location:** 346–386 S. 1<sup>st</sup> Ave., Hillsboro, Oregon

**Proposal:** The Oregon Department of Environmental Quality is accepting comments on its proposal to issue a Conditional No Further Action determination for the Hillsboro Shopping Center.

**Highlights:** The property was developed for commercial use as an auto dealership in the 1960s. The existing mall was constructed in 1968. A dry cleaner operated in the northernmost tenant space during the 1970s. Site investigations indicated petroleum impacts from prior automotive-related use were localized and did not present a risk to site workers. However, elevated levels of the dry cleaning solvent perchloroethene, also known as PCE, were detected in soil, sub-slab vapor, and indoor air in the former dry cleaning space and adjacent tenant space. A series of cleanup measures, including repairing and sealing the floor, adjusting the ventilation system, and installation of a sub-slab venting system has reduced indoor air levels to protective levels for site workers. Conditions of DEQ's proposed No Further Action determination include maintenance of the sub-slab venting system and periodic monitoring to ensure site conditions remain protective.

# Proposed Remedial Action for ODOT-Chenoweth Quarry

Comments due: 5 p.m., Thursday, May 31, 2018

**Project location:** US 30 at milepoint 71.8, The Dalles

**Proposal:** In accordance with ORS 465.320, the Department of Environmental Quality seeks comments from the public on a proposed remedy to address soil contamination at this site. The Chenoweth Quarry is a 10.86-acre basalt quarry owned by the Oregon Department of Transportation (ODOT). The site was historically used as an aggregate material source. The property was purchased by ODOT in 1930 for use as a quarry, and was used periodically during construction of US 30 and Interstate 84. The site is located adjacent to and northwest of the Historic Columbia River Highway (US 30) at milepoint 71.8.

The site was a popular unregulated recreational target shooting area for decades due to its close proximity to The Dalles and unrestricted access adjacent to US 30. Over the years, casings, bullets, shotgun shells, shotgun pellets, clay targets, and miscellaneous target debris continued to accumulate at the site.

ODOT proposed addressing this contamination by excavating contaminated soil, consolidating it in one area on the site, and covering it with 2 feet of clean rock. Confirmation samples would be collected from the excavated areas to verify that residual contamination is below risk-based concentrations for occupational exposure. DEQ has requested that ODOT modify its proposal to include a geomembrane cap over the contaminated soil in addition to the 2-foot clean rock cover. ODOT has agreed to do this.
