

Dear Governor Goldschmidt.

It was truly a pleasure meeting you last week. I was greatly impressed both with what I was able to see of your state during my short visit and with your own achievements and the interest and knowledge you displayed of Israel and Israeli affairs. I am very sorry that you could not come on your planned trip last summer, and I hope that you will be able to reschedule it in the near future.

I was very glad to have the opportunity to discuss with you issues of mutual concern to Oregon State and Israel, including paths our states might take toward the strengthening of economic ties and cooperation. As I told you during our meeting, I was also able to meet with key officials at the Department of Agriculture and the Department of Economic Development to explore these matters in greater detail.

One of the topics we discussed was the potential mutual benefits that are available to Oregonian and Israeli businessmen through joint ventures and other activities. Because Israel is the only country in the world that has Free Trade Area agreements with both the European Community and the United States, she is in the unique position of having the capability to act as a "bridge" for American companies that wish to penetrate the European market.

Furthermore, investment incentives such as R & D grants are available to companies entering into joint American-Israeli projects through the United States-Israel Binational Industrial Research & Development (BIRD) Foundation. In addition, universities and research institutions in both countries may be entitled to grants for joint ventures in the agricultural field from the U.S.-Israel Binational Agricultural Research & Development (BARD) Fund.

Participation in trade fairs by Israeli companies in Oregon and by Oregonian ones in Israel is a good way to help increase the awareness and understanding of business leaders, government officials and related institutional representatives about the many and varied opportunities that exist in each place for the citizens of the other. In view of the significant role that agriculture plays in Oregon's economy, Agritech '90 seems to be a perfect exhibition for Oregon's agricultural professionals to attend.

As I told you, Agritech Israel-International Agricultural Exhibition will take place next March 25-29. Agritech, the world's foremost international agricultural exhibition, will give participants the opportunity to explore first-hand some of these many opportunities and to see some of the most recent achievements and innovations in Israeli agriculture and agricultural R & D. The exhibition's highlights include informative seminars and symposia on subjects such as irrigation and greenhouse technology, as well as professional field trips to see Israeli cooperative agricultural settlements and agricultural research institutions.

I discussed at length with Bruce Andrews the possibility of his coming to Israel at the head of a delegation that would consist of farmers, agribusinessmen, food industry representatives, researchers and government officials. Such a delegation would surely contribute to increased knowledge about each state on the part of the other, and therefore later on to increased mutually beneficial economic relations. Finally, we defined during the course of our conversation several key areas of mutual interest to our two states, things that should be explored in greater detail by both parties.

Again, I wish to thank you for your time and your warm reception, and I look forward to seeing you in Israel sometime in the near future.

Dear Spingarn Medal Committee:

I am grateful for this opportunity to nominate Dr. Lee P. Brown for THE 73rd NAACP SPINGARN MEDAL. As a lifelong student of history, I am very much aware of the significance of the SPINGARN MEDAL which is awarded annually for the highest achievement of an African-American. For more than 45 years I have been a member of the NAACP and deeply appreciate and revere the historical involvement of the NAACP in it's courageous and unrelenting efforts to eliminate the violation of fundamental constitutional rights. The NAACP has waged a multi-lateral offense against injustice on all fronts with a long history to achieve protection for all citizens from agencies within the Criminal Justice System. In this regard, a major focus of the NAACP over the years has been the treatment accorded by the police and the need to humanize police actions with greater accountability to the people they serve. As a Retired Captain of Police and an administrator with the U.S. Department of Justice, I have witnessed the admirable efforts of the NAACP to guard against police abuse and more greatly assure responsive and sensitive police service. During the same period I have observed the efforts of Lee P. Brown, presently Police Chief in Houston, Texas, who as an activist police administrator has forged new directions in law enforcement which is resulting in a restructure of police response nationally and achieving the goals of the NAACP.

While history will be the best judge of Lee Brown's public life and services, it is only fitting that those of us fortunate to have worked with him attempt to provide a view of what one individual has done with his life. It is only in the historical context of our country, the elimination of racial oppression, with a respect for all people can one truly understand and appreciate the magnificence of Dr. Brown's invaluable contribution to the Black experience and the quest for justice. He has steadfastly and at great personal sacrifice exemplified the highest of standards in the administration of justice and in the traditions of civil rights.

As you can see from Chief Brown's resume, his career as a police officer started in 1960 in San Jose, California. There are a number of items I should point out relative to his eight and one-half years as a San Jose police officer. They are as follows:

- l. He was the second Black appointed to a police position in that department and the first one to ever be promoted.
- 2. He was the first Director of that department's Community Relations Program, a program which he developed and directed.
- 3. This Community Relations effort was credited with improving race relations in the City of San Jose during the difficult times of the 1960's.
- 4. Community Relations was in its infancy at that time and, therefore, he was a pioneer in the development of such programs.
- 5. As Director of Community Relations, he initiated several significant programs for the Department. For example, he was responsible for having created the Department's first Internal Affairs Unit. In addition, he was able to get the department to initiate Human Relations Training to assist the officers in dealing with the diversity of the community. He also established a Law Enforcement Minority Scholarship in order to get more minorities interested in continuing their education to become a San Jose police officer. In addition, he initiated Police Community Relations Seminars in the community to bring the police and the community closer together.
- 6. As Director of the Police Community Relations Unit, he was very actively involved in the community. He was instrumental in establishing a Community Service Center to serve the low income area of the city.
- 7. His work in the community also involved being elected as the Chairman of an organization called Action for Progress. Action for Progress was a coalition of all the major Black organizations in the community, for example, NAACP, Urban League, etc. They all came together to have a unified approach in addressing the issues that impacted Blacks in the City of San Jose. It was significant that he, as a police official, was selected to be the chairperson of this coalition of organizations.
- 8. In 1968, he received a commendation from Ramsey Clark, United States Attorney General, on behalf of the President of the United States, for his work in the community.
- 9. For two years in a row 1966 and 1967, he was selected by the members of the San Jose Department as its "Officer of the Year".

- 10. In addition, he was an active participant, a charter member and founder of the San Jose Police Officers Association. He served as its President for one term.
- 11. In addition to the above, he was also very active with the Mexican American community. He served as a bridge between the Police Department and the Mexican American community and also between the Black community and the Mexican American community.
- 12. While a police officer with the San Jose Police Department, he also developed and taught the first Community Relations class at San Jose State University.

In 1968 he left the San Jose Police Department and took the position as Director of Law Enforcement Programs at Portland State University. He was responsible for developing a new department designed to provide an academic program in Criminal Justice to undergraduate students. In addition to his responsibilities as chairman of that Department, he also involved himself in the following:

- Served as faculty advisor for the Black students.
- 2. Was successful in getting a significant large number of Black students interested in law enforcement and completing their education.
- 3. Developed the first Black Studies Program at Portland State University and taught some of the classes in addition to regular teaching assignments.
- 4. Was extremely active in campus activities as indicated on his resume. You will note that he received a Danforth Associate Award for his teaching and work with students.

In addition to his activities on campus, he was also active in the community in Portland. He was instrumental in organizing the Oregon Black Caucus and served as its first Chairperson. The Oregon Black Caucus brought together Blacks from throughout the State of Oregon to address the issues of concern to Black residents of the state. The caucus focused on issues such as law enforcement, housing, employment, education, etc. Again, I think it is significant that a person involved in law enforcement was selected to chair this organization that dealt with the problems of minorities and the civil rights of Black Americans in the State of Oregon.

In 1972 he left Portland to accept a position at Howard University in Washington, D.C. He was asked to go there and help that University establish a research institute to address the issues of Blacks in America. He assisted in creating the Institute for Urban Affairs and Research which focused on issues such as transportation, housing, education, crime, health and mental health issues of Black Americans. In addition, he developed that University's Criminal Justice Programs.

In 1975 he was appointed as the first and only Black to be Sheriff of Multnomah County. There, he completely reorganized the department under the concept called a Full Service Model of Team Policing. The objective of that reorganization was to get the police officers involved with the community by assigning them to a geographical area on a permanent basis. This gave them responsibility for the area and the results of his work there are contained in a book which he edited titled, "Neighborhood Team Policing: The Multnomah County Experience".

He served in the position of sheriff for one and one-half years. After that, he was appointed to the position of Director of the Department of Justice Services. This department was responsible for all of the county's criminal justice activities. In that capacity, he was able to address the issue of affirmative action for the department as well as plan for the construction of a new jail that serves today as an example of a humane corrections facility. He continued to be active in the Black community throughout the City of Portland and Multnomah County.

In 1977 he was asked by Griffin Bell, Attorney General of the United States, to take over the position of Deputy Administrator of the Law Enforcement Systems Administration. This was a presidential appointment which he accepted. Prior to receiving confirmation from the United States Senate, he was asked by Mayor Jackson, then Mayor of Atlanta, to assist him by accepting the position of Commissioner of the Department of Public Safety for the City of Atlanta. He accepted that position and took over as Commissioner of Public Safety for Atlanta in May of 1978. His accomplishments are outlined on pages 10 and 11 of his biographical resume. Some of the major accomplishments he achieved there dealt with bettering the relationship within the department between Blacks and Whites. He was responsible for negotiating a resolution of a police hiring and promotions freeze that had been in existence for the Police and Fire Departments for over six years. He also developed, while in that position, a model Use of Firearms Policy that was replicated throughout the nation. In addition, he developed a policy on how to respond to racial and religious violence that was adopted as a model for many other parts of the country.

During the course of his serving as Commissioner of Public Safety for Atlanta, that area experienced the tragedy of the missing and murdered childrens' case. He was responsible for directing the investigation of that case. In that capacity, he was responsible not only for the investigation, but also identified the fact that young Black children were experiencing mental health problems. Thus, he mounted a massive mental health program for the community. In addition to all of that, he was responsible for initiating preventive measures in an attempt to prevent other children from becoming victims. He served as the spokesperson for the area involved in this tragedy and, thus, had to deal with people from all over the world who felt the hurt from this problem.

After the successful completion of that case, which included the arrest and conviction of the person responsible for the killings, he accepted the position as Police Chief for the City of Houston. This represented the first time that a Black had been appointed to the position of Police Chief for America's fourth largest city. In the capacity of Police Chief for Houston, he has been instrumental in addressing the following issues:

- 1. Developed a Firearms Use Policy that now serves as a model for the nation. This policy is now included in the Community Relations Service book on reducing violence.
- 2. Initiated valules for good policing. Those values are now being duplicated throughout the country. It represents what is believed to be the first time a police agency has taken the initiative to articulate a set of values that guides it in setting policies, implementing programs and delivery services on the streets of the city.
- 3. Successfully addressed the issue of police use of excessive force and police brutality which reportedly is no longer one of the major issues in the City of Houston.
- 4. He has initiated many programs in the area of citizen involvement. I am enclosing for your information a list of the programs and a document which contains management reports. Some of the most significant ones are the DART Program, Fear Reducation Program, Positive Interaction Program and Project OASIS. All of these programs are designed to bring the police and citizens closer together.
- 5. Also enclosed please find a document on Neighborhood Oriented Policing. This is a significant document in that it represents a complete change in a law enforcement agency's philosophy of policing. It deviates from the traditional concept of policing and is believed to represent the future of policing in America, if not the free world.

As a result of some of his initiatives in Houston, he was selected by the National Black Police Officers Association as their Law Enforcement Person of the Year in 1982. He also received the Police Executive Research Forum's Law Enforcement Award for work in the area of Community Oriented Policing in 1987. In 1987 he was the recipient of NOBLE's Humanitarian Award for his efforts to curtail the Police Use of Deadly Force. In addition, he has received numerous awards locally.

The following represents some of the other activities that he has been involved in that are significant:

- l. In addition to the education he has received, he is also the recipient of two honorary doctorate degrees. One in Public Administration from Florida International University in 1982 and the second in Law from John Jay College of Criminal Justice in 1984. He is also the recipient of the distinguished Alumnus Award from Fresno State University in 1983.
- 2. He was instrumental in the formation of the National Organization of Black Law Executives. He wrote the proposal to bring the participants together to a conference that resulted in the formation of NOBLE.
- 3. He served for five (5) years as a National Correspondent to the United Nations program for Prevention of Crime and Treatment of Offenders, having been appointed by the President of the United States.
- 4. He was a charter member of the Commission of Accreditation for Law Enforcement Agencies.
- 5. He chaired a task force for the National Advisory Commission of Criminal Justice Standards and Goals.
- 6. He was chairman of the National Minority Advisory Council on Criminal Justice. That council produced a publication entitled "The Inequity of Justice" which represents a significant contribution to the literature on minorities and crime.
- 7. He is currently serving on a panel dealing with the status of Black Americans sponsored by the National Research Council. This is a very distinguished council that is looking at the status of Black Americans since the 1940's.
- 8. He was elected to the 6th Vice President of the International Association of the Chiefs of Police and currently serves as its 3rd Vice President. He will become the President in 1990. This is an International Organization and his election represented the first time a Black had ever been elected to a position in this organization.

In addition to the other items contained in his resume, here are other contributions of great importance:

1. He has served as a Consultant to the Community Relations Service of the U.S. Department of Justice. In that capacity he has been able to effect change to the benefit of Blacks and other minorities. A notable achievement in this regard was the implementation of recommendations for the New York Civil Service System which resulted in the employment of countless number of Blacks and Hispanics as police officers. Another notable activity was as panelist at the American Bar Association's Convention where Dr. Brown identified (for Judges from throughout the nation) indicators of bias in the Criminal Justice System.

- 2. Of notable and historical mention is his work to curtail the Police Use of Deadly Force. As a result of his personal interest and sacrific, the National Organization of Black Law Enforcement Executives (NOBLE) passed a resolution, including a standard in the Accreditation Process dealing with Deadly Force. We have been able to see this issue rise to the level of national debate and as a result also of the great work by the NAACP, seen the United States Supreme Court rule on this issue.
- 3. He has worked extensively in the area of religious and racial violence with his model policy being published in the CRISIS.
- 4. A great deal of the work which Chief Brown is doing in Houston now serves as a model for other parts of the country and other parts of the world. People from European Countries, Africa and Asian Countries visit Houston to look at the concept of community involvement which is Neighborhood Oriented Policing. It is my expectation that initiatives here will become the model for policing throughout the free world.
- 5. He has lectured extensively throughout the country and other parts of the world. Was asked to visit Sweden to lecture on community policing. In addition, he has traveled to Liberia, West Germany, England, Mexico, China, Denmark, Switzerland, France, Belgium, Barbados, Puerto Rico and the Virgin Islands as part of his outreach activities in the area of policing.
- 6. He serves as a consultant to numerous state and local agencies dealing with the issue of policing.

The late James Baldwin often spoke of the importance of being a witness. For twenty years I have witnessed the efforts of Lee Brown which will serve to change the actions of police officers all over the nation so that citizens will be better protected and accorded full constitutional rights regardless of race, creed or color. It is with great admiration for the work of the NAACP and the contributions of Dr. Brown that I respectfully commend him to you for the SPINGARN MEDAL. Through humanitarian principals, he has emerged as America's Quintessential Police Executive.
