

The general idea and theme is very good. I would encourage a "piece" directed at parents and what they can do to support their children in remaining drug-free. Might also be a way to tie in "Preparing For The Drug (Free) Years" promotion.

I think we could help improve the package a little and tailor to Oregon if they were interested. As it stands, it has potential and I see no negatives to it--wording is fine on materials I skimmed.

There may also be a way to tie in some high-risk kids to this program. For example, what if Trout Unlimited and the state joined up--they provided manpower, we provided small funding for "fishing gear" to take youth at MacLaren/Hillcrest or youth from some of the community programs on fishing expeditions and we included some drug education along the way.

I think there could be some valuable spinoffs if we took time with To-Ro to think them through.

Bob O'Loughlin, President of To-Ro Enterprises, has asked us if we would help him obtain some endorsements from local political leaders for a promotion for their sportsmen shows.

The name of the promotion is "Hooked On Fishing - Not On Drugs".

The purpose of the program is to introduce young people, under the age of 12, to fishing as a recreational alternative. Part of the promotion is to further encourage young people not to become involved in drugs. The theory is that fishing, as a healthy, recreational activity, will demonstrate to children there are many alternative activities to drug involvement.

The purpose of the endorsement is to encourage manufacturers to participate in the program with contributions of money and equipment; and to encourage community support for the program, including the public school system.

The Sportsmens' Show is a highly successful trade show geared to outdoor sports such as hunting and fishing. (See the attached brochures.) The show includes a wide range activities from hands-on experience and demonstrations with hunting and fishing, art demonstrations such as taxidermy and wood carving, the free trout pond for young children, many "how to" exhibits, demonstrations and seminars, plus the multitude of exhibitors from resorts, guides, manufacturers, and retailers.

The proposed drug awareness program will involve a morning field trip for middle school children to the Sportsmens' Show. The children will be given a hands-on demonstration as to how to prepare basic fishing tackle, and then each will be allowed to catch three trout at the fish pond.

Manufacturer will donate the costs of the trip and the fishing tackle.

Trout Unlimited will supply the man power to teach the children and assist them with their fishing experience.

Each child will be given a small tackle box, lunch, and free passes to the show so they can bring their parents.

This drug awareness program will be carried on in Tacoma, Seattle, Salt Lake City and Portland. The Tacoma Educators Association has already adopted it and is enthusiastic about its potential. They feel that most government drug awareness programs have not yet hit the mark, and are looking for private industry programs to further develop their own drug awareness program.

The program will be enhanced by a no license required free fishing week for children during National Fishing Week in June. Children will be allowed to fish without licenses with their parents.

The advantage of the program for the community is that it promotes recreation activities in Oregon and promotes and supports the multi-million dollar fishing industry, a major part of the Oregon economy.

X 20 Also attached is a brochure from an organization called "Future Fisherman Foundation". This organization was started by Berkley, a major manufacturer of fishing equipment, for the same purpose. This is an extension of the Berkley program. The Berkley program was to be promoted through dealers, and the To-Ro program is to be promoted through their Sportsmens' Show.

The bottom line for the program is to promote the fishing industry and the Sportsmens' Show as well as contribute to a major community need.

To-Ro Enterprises has been in business for over thirty (30) years in Portland and produces most of the major trade shows in the Portland area and have developed a large sportsmens' oriented show business in the Seattle-Tacoma area. They are currently opening up in Salt Lake City and will be a tenant of the new trade show pavillion in Denver, Colorado.

They have a long record of backing up their programs with substantial time, money and effort. This program will be supported in the same way.

Also, part of this package is a videotape promoting fishing as an alternative to drugs, and as a family activity to develop the family relationships.

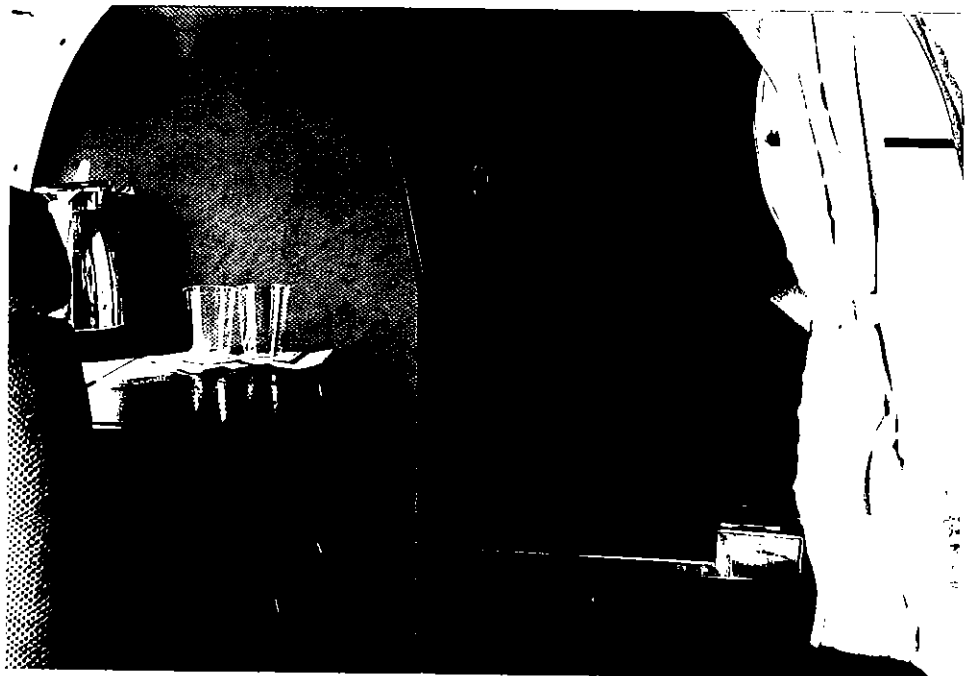

Thank you for your thoughtful correspondence dated March 7, 1989. I appreciate both your comments regarding the Oregon Health Plan as well as your support during the last election.

You questioned whether the board's certification of health insurance products similar to those already available in the marketplace was appropriate public policy. You also questioned whether it was appropriate to limit the opportunity to market tax-credit qualifying products to a "few agents."

I appreciate your questions and would respond generally by stating that the program is still in its first stage of development and will continue to evolve. The board has been very constructive in its efforts to develop certifiable programs that are consistent with its legislative authority. Similarly, I believe the industry has been responsive in modifying their products and will be offering programs that provide good value to the small employer.

It is my understanding that many agents will be able to offer at least one of the six certified programs. The board had no intention of limiting the program to only a few agents as such limitation would be counter-productive to the overall objective to expand coverage. In addition, every authorized health insurer was invited to submit a proposal to be certified.

The intent of HB 2594 is to encourage small employers to purchase health insurance for their employees. The primary incentive is a tax credit equal to one-half the premium paid by the employer capped at \$25 per month per employee, phasing out over a 5 year period. The health insurance is to be reasonably priced and state-mandated benefits have been waived to help accomplish that objective.

Mr. Oppenheimer has complained that the products to be certified by the board are similar to those generally available in the marketplace. He questions whether this is appropriate public policy and is critical of the board.

I don't believe his criticism is justifiable. The board has been very constructive in its efforts to assist in the development of certifiable programs. Similarly, the industry has been reasonably creative in modifying their products and are offering programs that offer very good value to the small employer.

He has complained about the fact that only a few agents and companies would be involved. In fact, most Oregon-licensed health insurance agents will be able to offer at least one of the 5 or 6 programs which will be certified. Furthermore, the limit regarding the number of companies was explicitly described in the law.

Every health insurer authorized to transact business in the state was invited to submit a proposal. Relatively few chose to do so because the requirements of the law and the board required them to stretch to better meet the needs of the consumer.

My staff will be inviting Mr. Oppenheimer to meet with me. Attached is a letter for you to send to the gentleman.

Thank you for being a good sport about my answer to the question of how the first \$1.00 would be spent (at the March 22, 1988 meeting at Multnomah County Children's Services Division, i. e. on supervisor's salaries).

If one had the power to decide where the dollar was to be spent, I recommend on teenage intervention. These out-of-control teens are the Children's Services Division parents of the near future. The dollars for their programs are already in the system. You really ought to take an in-depth look at the 2045 situation, and how those dollars are being utilized.

I wonder, too, if the State should re-evaluate the costs and effects of 96-272 compliance. This law, while having good intentions has been ineffective in helping children and families. The law has buried workers and support staff in a sea of repetitious paper work that seriously limits the ability to do an even adequate job of social work.

I want you to know that we are concerned about things other than just salaries. Clackamas Branch has been actively involved in Student Retention, Interagency Committees, and Juvenile Service Commission. Our Protective Services supervisor was able to organize a Child Abuse Coalition in Clackamas County and two of our supervisors have been actively involved in Day Care advocacy on their own time. Our Branch Manager promotes an environment where creative and innovative ideas and activities are encouraged and he has also been able to keep our branch budget on-line without compromising the services to the client.

We really appreciated your openness to discuss our critical issues.



I am pleased to report the reduction of crime in Clackamas County.

The Crime Analysis Unit of my office has confirmed that the unincorporated and those incorporated areas served by the Sheriff has a verifiable decline of - 6.7% of all classifications of crime and an overall reduction of -10.6% of major crimes for the calendar year 1987.

This report covers a geographical area of 1,854 square miles, serving a population of 156,670 and includes the cities of Barlow, Johnson City, Rivergrove, Happy Valley, Estacada and Wilsonville. This report does not include the law enforcement efforts of the Oregon State Police or the municipal Police Departments serving Canby, Molalla, Sandy, Milwaukie, Lake Oswego, Tualatin, Oregon City, West Linn, Gladstone and some small portions of Portland located in Clackamas County.

The reduction of major crimes in our county are illustrated as follows:

Robbery	Down	-22.8%
Burglary	Down	-16.6%
Assault	Down	-16.0%
Theft	Down	- 6.4%
Criminal Mischief	Down	- 7.7%

Two categories of major crimes rose in 1987. They are:

Sex Crimes	Up	+ 5.9%
Stolen Vehicles	Up	+ 9.5%

The recovery of stolen vehicles during 1987 was 16.3% more than in 1986.

In 1986 my office investigated 10 murder cases, all cleared by arrests. In 1987 Homicide Detectives investigated 14 cases, which include the seven murder victims found in the Molalla Forest area. Two cases have been cleared by arrests, two cases cleared by exception and the remaining ten cases are still under active investigation.

The Special Investigations Unit (SIU) of the Sheriff's Office conducted 887 dangerous drug and narcotics investigations, arrested 41 persons for unlawful drug related activity and seized 27 illegal drug manufacturing laboratory's.

The investigation of criminal cases reported to the Sheriff dropped in 1987 with a total of 10,653 cases. In 1986 there were 11,626 cases filed. These do not include vehicle theft reports.

In other activities, the Sheriff's Crime prevention unit established 95 neighborhood watch organizations and gave 816 crime prevention presentations to 31,665 persons. "Drug Awareness" was the most requested program and was presented 235 times, followed by 89 presentations of "Personal Safety Awareness".

There were only 14 search and rescue missions conducted in 1987. This involved 37 missing persons in 16 incidents. 32 persons were safely recovered while five deaths occurred.

The traffic enforcement and accident investigation unit reports a decrease in the number of accidents and traffic related deaths in 1987.

Highway accidents	Down	-14.5%
Accident injuries	Down	- 5.7%
Accident deaths	Down	- 5.0%
Highway accidents alcohol related	Down	-20.2%
Drunk drivers arrested	Down	-14.6%
Traffic citations	Up	+11.4%

While alcohol related accidents and arrests for Driving Under The Influence have been greatly reduced, traffic enforcement and related activities have increased. It becomes obvious that the wide spread public campaigns against the drinking driver have been very effective.

8,007 prisoners were booked into the Clackamas County Jail during 1987 which was slightly less than in 1986 when there was a total of 8,072 bookings. There were three unsuccessful attempts of escape.

Staff estimates of the average daily count runs between 155-160 prisoners. The maximum capacity is 160 male adults and 16 female adults. During 1987 181,076 meals were served at a cost of .72 cents each. 7,388 prisoners were transported by the Civil Division intrastate, interstate and to court proceedings.

Men and women of the Clackamas County Sheriff's Reserve continue to be a valuable asset to the citizens of Clackamas County. These well trained volunteers contributed over 44,000 hours of public safety service in 1987. This is the equivalent of 21 additional full time Deputy Sheriff's at a cost saving of \$704,000. In addition to their volunteer service, reserves are placed on active duty to relieve Deputy Sheriff's on authorized leave with qualified replacements. Other volunteers are the Sheriff's Posse, the Law Enforcement Explorers and the Chaplain Corps.

My explanation of the success in reducing crime in Clackamas County has a number of important factors that when brought together have made a positive impact against the criminal.

The work product of the Sheriff's Office is accomplished by the entire staff, regardless of position or division assignment. We function as a very hard working team. We have worked together to bring about important changes in the way we operate as a law enforcement agency. These changes had their subtle beginning in 1986 when the department scrapped traditional methods of resource allocation and acted on information based policing from computer data and crime analysis. Work load patterns and calls for service were identified and patrols and staffing levels were reallocated to meet the service demand. Crime prevention activities increased, directed patrols responded to special area crime analysis and evaluation. Self initiated activities of the patrol deputy increased, arrests went up and crime started to falter.

In 1987 more new programs were implemented, such as followup investigations made within the patrol section of the Operations Division. A new case management system was implemented. A career criminal unit was formed which works known criminals instead of case investigations. We share staff with a multi-jurisdictional taskforce to crack down on drugs. Our special identification section developed in 1986 became fully operational and has made many important cases in 1987 through identification of suspects and analysis of evidence. Added training and tactical patrols staffed by reserves augmented regular district patrols.

The anti-crime attitude of our citizens, the positive and continuing support of the Board of County Commissioners, the guidance and support of the District Attorney and his staff, the aggressive public safety agenda of our Governor and the support of the Oregon legislature in building new prison space are all important factors which have helped us make Clackamas County a safer place to live. Together we sent a very clear message ,

"
CRIME IS NOT WELCOME HERE".
